### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of M&S Companies 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

**Note 1 – Description of the Plan**

The following description of the M&S Companies 401(k) Plan (“the Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

**General**

The Plan is a defined contribution plan that covers substantially all employees of M&S Engineering, and Sherwood Surveying & S.U.E., (“the Companies”) who are age 21 or older and have completed 6 months or more of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions**

Each year, participants may contribute a percentage of their pre-tax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds as investment options for participants. The Companies may make discretionary profit-sharing contributions based on the participant’s eligible compensation. For the years ended December 31, 2024 and 2023 the Employer matched contributions up to 3% of total compensation. All contributions are subject to certain limitations of the Internal Revenue Code. Excess contributions payable as of December 31, 2024 and 2023 were \$0 and \$140, respectively and have been reflected as a reduction of the employer contributions on the Statements of Changes in Net Assets Available for Benefits.

**Participant accounts**

Each participant’s account is credited with the participant’s contribution and allocations of: (a) the Companies’ contribution and (b) Plan earnings less any applicable fees. Allocations are based on participant compensation or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting**

All participants are immediately vested in their voluntary and employer contributions and related earnings credited to their accounts.

**Payment of benefits**

Upon termination of employment, death, disability, or retirement, the value of the participant’s vested interest in his or her account may be distributed in lump sums or in partial withdrawals. In the case of a participant’s retirement, the individual may also be subject to minimum required annual distributions.

**Investment options**

Participants direct the investment of all contributions allocated to their accounts into various investment options offered by the Plan.

**Notes receivable from participants**

Participants may borrow from their fund accounts a minimum of \$1,000. The loans are secured by the participant's account. The interest rate is set at 1 percentage point over the prime interest rate. Notes receivable from participants are measured at the unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses have been recorded as of December 31, 2024 or 2023.

**Administrative expenses**

The Plan permits the payment of administrative expenses to be made directly by the Plan Sponsor, or to be paid out of the assets of the Plan provided such payment is consistent with ERISA. Substantially all administrative expenses of the Plan are paid by the Plan Sponsor. Expenses relating to specific participant transactions (i.e. in-service withdrawals, distribution requests, etc.) are charged directly against the appropriate participant's account.

**Forfeited accounts**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$9,606 and \$11,364, respectively. Forfeitures should be used to pay administrative expenses under the Plan, if so directed by the Employer.

**Note 2 – Summary of Significant Accounting Policies**

**Basis of accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Investment valuation and income recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded when paid. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of benefits**

Benefits are recorded when paid.

**Use of estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

All expenses maintaining the Plan are paid by the Companies.

**Date of management’s review**

Subsequent events were evaluated through September 24, 2025, the date the financial statements were available to be issued. Material subsequent events, if any, are disclosed in a separate footnote to these financial statements.

**Note 3 – Investments**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the United States Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, LLC (“the Custodian”), has certified that the following information included in the accompanying financial statements and supplemental schedules is complete and accurate as of December 31, 2024 and 2023.

## **Note 4 – Fair Value Measurements**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments.

When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were used only when Level 1 or Level 2 inputs were not available.

Level 1 – The fair values of common stocks, certain corporate bonds, and U.S. government securities are based on the closing price reported in the active market where the individual securities are traded, when available.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;

If the asset or liability has a specific (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Level 1 instruments consist of cash and cash equivalents, and mutual funds. Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds are deemed to be actively traded. There are no Level 2 and Level 3 investments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 5 – Plan Termination**

Although it has not expressed any intent to do so, the Companies have the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become 100% vested in their account balances.

**Note 6 – Income Tax Status**

The Plan is a Fidelity prototype plan adopted by the Companies. The prototype plan obtained its latest determination letter on March 31, 2014, in which the Internal Revenue Service stated that the prototype plan, as then designed, was in compliance with the applicable requirements of the IRS. The prototype plan has been amended since receiving the determination letter. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits of any tax periods in progress. The Plan's federal tax returns for the last four years remain subject to examination.

**Note 7 – Related Party Transactions and Party-in-Interest Transactions**

Certain Plan investments are managed by Fidelity. Fidelity is the custodian and record-keeper for the Plan, and, therefore, these transactions qualify as party-in-interest transactions. These transactions are covered by an exemption from the “prohibited transactions” provisions of ERISA and the IRC.

The Plan does not consider the Companies’ contributions to the Plan to be party-in-interest transactions. The Companies provides certain accounting, administrative and management services to the Plan for which no fees are charged.

**Note 8 – Amounts Owed to Withdrawn Participants**

As of December 31, 2024 and 2023, the amount of net assets available for benefits that were in accounts of participants that are no longer employees of the Plan Sponsor totaled \$1,909,100 and \$1,465,941, respectively. Of those balances, \$398,397 and \$146,577 had been requested to be paid to the participants subsequent to the Plan’s year end December 31, 2024 and 2023, respectively.

**Note 9 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances, and the amounts reported in the Statements of Net Assets Available for Benefits.
