Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Liebherr-America, Inc. Pension Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the Plan provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

Liebherr-America, Inc. Pension Plan (the Plan) is a defined-contribution plan sponsored by Liebherr-America, Inc. (the Company or Plan Sponsor). The plan provisions qualify under Section 401(k) of the Internal Revenue Code (IRC). Participation in the Plan is voluntary and is open to all full-time employees of the Plan Sponsor. Under the terms of the Plan, participants are eligible for retirement benefits upon attaining age 65 (age 55 with a minimum of 10 years of service). Each retiring participant is entitled to receive an amount equal to the balance in his/her account, and he/she may choose from various distribution alternatives specified in the Plan.

Plan Trustee: The trustee of the Plan is VOYA Institutional Trust Company (VOYA or the Trustee). The Trustee holds the plan assets and manages the assets under a participant-directed trust agreement.

In accordance with the provisions of the Plan, the Company's employees who elect to participate may contribute up to a maximum of 100% of their annual earnings on a pretax or Roth after-tax basis subject to Internal Revenue Service (IRS) limitations up to the \$23,000 maximum for 2024. Participants who are 50 years or older by the end of the year may make an additional pretax or Roth after-tax contribution referred to as a catch-up contribution, which was limited to \$7,500 during 2024. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation with an automatic escalation of 1% annually on the first pay period in April, up to a maximum deferral rate of 10% unless elected otherwise by the participant and their contributions invested in accordance with the default investment alternatives established by the Plan. The Company voluntarily matches 100% of employee contributions up to 6% of each participant's earnings on a pay-period basis, as defined in the Plan. Employee and employer contributions are credited to accounts maintained for each individual participant, and the balance in a participant's account is equal to the sum of employee and employer contributions, adjusted for allocations of investment income, gains, losses, and expenses.

In the event of a participant's death or disability, he/she is entitled to receive the balance in his/her account. If a participant is terminated before retirement, death, or disability, he/she is entitled to withdraw the balance in his/her account.

Upon retirement, disability, or termination, a participant may elect to receive (a) a lump-sum payment, (b) a lump-sum payment to an individual retirement account or to another employer's plan, or (c) if the participant's account balance exceeds \$5,000, the participant may receive periodic installments beginning at age 65. In the event of a participant's death, the account balance will be used to provide the designated beneficiary with a death benefit. Participants may also elect to receive in-service distributions beginning at age 65.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation: The accompanying financial statements have been prepared on an accrual basis and present the assets available for benefits and the changes in those assets.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Investment Valuation and Investment Income (Loss): The Plan's investments in mutual funds and collective trusts are carried at fair value. Fair value is the price at which an orderly transaction to sell the asset or to transfer the liability would take place between market participants at the measurement date under current market conditions. See Note 4 for information and related disclosures regarding fair value measurements.

Fully benefit-responsive investment contracts are carried at contract value. Contract value is the relevant measure for the portion of the assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by VOYA, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are reported on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes realized gains and losses on investments bought and sold and the change in fair value from one period to the next. Realized gains and losses from security transactions are reported on the average-cost method.

Payment of Benefits: Benefits are recorded when paid.

Administrative Expenses: Administrative expenses of the Plan are paid by the Plan or by the Plan Sponsor, at the Plan Sponsor's discretion. Audit fees and other administrative expenses are typically paid by the Plan Sponsor.

Transaction fees related to investment management fees are paid from individual participants' accounts and are included in benefits paid to participants.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets available for benefits and changes in those assets available for benefits at the date of the financial statements. Actual results could differ from those estimates.

Risk and Uncertainties: The Plan invests in various investments. Investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of assets available for benefits.

NOTE 3 – CERTIFIED INFORMATION

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by VOYA (the Trustee of the Plan).

NOTE 4 – FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, Fair Value Measurement (ASC Topic 820), establishes a framework for measuring fair value, which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means
- If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds: Valued at the closing price reported on the active market on which the individual securities are traded (Level 1 inputs).

Collective Trusts: The fair values of participation units held in collective trusts are based on the net asset values per unit as reported by the fund managers. The collective trusts provide for daily redemptions by the Plan at reported net asset values per share, with no advance notice requirement.

The valuation methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 – FULLY BENEFIT-RESPONSIVE INVESTMENT

The Plan invests in a fully benefit-responsive guaranteed investment contract (GIC) with VOYA Retirement Insurance and Annuity Company (VRIAC), an affiliate of VOYA, the VRIAC Stable Value Option, which meets the fully benefit-responsive investment contract criteria and is reported at contract value. The underlying investment of the VRIAC Stable Value Option consists of the Separate Account GIC contract ST-60278. The assets of the Separate Account GIC contract ST-60278 are owned by VRIAC.

Contract value, as reported to the Plan by VRIAC, represents contributions made under the contract, plus interest, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise. VRIAC Stable Value Option has a fixed rate of interest, determined on a quarterly basis. The declared rates are net of all expenses. The rate cannot be less than 0%.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following:

- (1) amendments to the plan documents (including complete or partial plan termination);
- (2) termination of the contract or breach of a provision of the contract by the Plan;
- (3) bankruptcy of the Plan sponsor or other Plan sponsor events (e.g., divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; or

- (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the ERISA.

The Plan Sponsor does not believe that the occurrence of any such event, which would limit the Plan's ability to transact at contract value with participants, is probable.

NOTE 6 – FEDERAL INCOME TAXES

The Plan is a non-standardized prototype plan for which a favorable opinion letter dated June 30, 2020 has been received by the prototype Plan Sponsor. The Plan Sponsor does not intend to request a determination letter for its specific plan and is placing reliance on the prototype plan opinion letter as provided for in Announcement 2001-77. In the opinion of the plan administrator, the Plan and its underlying trust have operated within the terms of the prototype plan document and remain qualified under applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax provisions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or an asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 7 – PARTY-IN-INTEREST TRANSACTIONS

Plan investments at December 31, 2024 and 2023 included a GIC, shares of mutual funds, and participation units of collective trusts managed by VRIAC, VOYA Retirement Funds, and VOYA Investment Trust Co., respectively. VRIAC, VOYA Retirement Funds, and VOYA Investment Trust Co. are affiliates of the Trustee; therefore, transactions related to these investments qualify as party-in-interest transactions. Asset-based fees of 0.27% of managed investment options were paid to VOYA Funds for the year ended December 31, 2024. These fees, which compensate the Trustee, are included in investment returns as a yield adjustment.

NOTE 8 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan under the provisions of ERISA.

NOTE 9 – SUBSEQUENT EVENTS

The Plan has evaluated subsequent events for recognition and disclosure through September 12, 2025, the date the financial statements were available to be issued.

Effective January 1, 2025, the Plan permits one hardship distribution during a plan year.
