Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Deltrol Corp. 401(k) Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Notes to Financial Statements

Note 1: Description of Plan

The following description of the Deltrol Corp. 401(k) Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan, sponsored by Deltrol Corp. (the "Company"), and covers employees of the Company who have at least six months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. The Plan has adopted the required minimum distribution at age 73 effective January 1, 2023, and is in the process of evaluating other voluntary provisions. The Plan is required to be amended in regard to other requirements of SECURE 2.0 by December 31, 2026.

Contributions

Participating employees may contribute up to the maximum allowed under the Internal Revenue Service ("IRS"), as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified plans ("rollovers").

The Company has the option to make discretionary matching contributions to the Plan. To be eligible for the matching contributions, a participant must be employed at the end of the year and complete at least 1,000 hours of service during the Plan year. At the discretion of the Board of Directors, the Company matched 50% up to the first 8% of employee contributions for the year ended December 31, 2024. The Company may also make discretionary nonelective contributions.

During 2024, the Company utilized \$438,000 to fund the Company's 2023 profit sharing contribution. This amount had originally been received on December 18, 2023, from a qualified pension plan sponsored by the Company that was terminated during 2023. The funds were initially deposited into the Plan's contribution account and recorded as part of the Company contributions on the Statement of Changes in Net Assets Available for Benefits. In 2024, these funds were formally allocated to fulfill the prior year's profit sharing obligation.

Participant Accounts

Each participant's account is credited with the participant's contributions along with an allocation of the Company's matching and profit sharing contributions and Plan earnings (losses), which includes a charge for administrative expenses. Earnings (losses) of the Plan are allocated to each participant based upon the relationship of a participant's account balance to the total of all account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes to Financial Statements

Note 1: Description of Plan (Continued)

Investment Options

Contributions to a participant's account can be invested in a variety of investment vehicles and are managed on the participant's behalf by the Plan's Trustee. Investment options are selected by participants and may be changed at any time. The Plan's Investment Committee periodically reviews the performance of each investment and adjusts investment offerings as necessary.

Notes Receivable From Participants

Participants may borrow up to the lesser of \$50,000 or 50% of their vested balance with a minimum loan amount of \$1,000. Loans are made at the prime rate and are repaid through payroll deductions over a maximum term of five years, unless the proceeds are used to purchase a primary residence when the repayment term may be extended. The remaining account balance serves as security for the loan and any defaulted balances are included in the participant's gross income for federal income tax purposes as if a regular distribution were made.

Payment of Benefits

Upon attainment of age 55, a participant may choose to receive an in-service distribution of the vested balance of their account in the form of a lump-sum payment as defined by the Plan agreement. Terminated employees are eligible to receive the vested balance of their account in the form of a qualified rollover to another plan or, if normal retirement age has been attained, in the form of a lump-sum, annuity, or other installment-based payment. Distributions may be deferred until the participant reaches the age of 73, providing the account balance is greater than \$7,000. Under certain circumstances, participants may qualify to receive a hardship distribution (less applicable income taxes and penalties) from their account balance.

Vesting

Participants are immediately vested in their contributions plus actual earnings (losses) thereon. A participant is 100% vested in Company matching and profit sharing contributions after three years of service. Upon retirement, death or disability, a participant's account becomes fully vested. If employment is terminated before the account becomes 100% vested, the non-vested portion will be forfeited.

Forfeitures

Forfeitures of non-vested contributions shall be used to reduce Plan administrative expenses or amounts can be used to reduce the Company matching contributions. There were no forfeitures used to reduce Company matching contributions for the year ended December 31, 2024. As of December 31, 2024 and 2023, the forfeiture account balance was \$10,090 and \$76,580, respectively.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates in Preparation of Financial Statements

The preparation of the accompanying financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and Trustee. See Note 3 for details on inputs, valuation techniques, and fair value measurement level within the fair value hierarchy.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments consists of both realized and unrealized gains and losses on investments.

Notes Receivable From Participants

Notes receivable from participants are valued at their unpaid balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Fees relating to the administration of notes receivable from participants are charged directly to the participant's accounts and are classified as administrative expenses. Fees charged by the Trustee are paid by the Plan and are also classified as administrative expenses. Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements.

Subsequent Events

The Plan has evaluated subsequent events through September 19, 2025, which is the date the financial statements were available to be issued.

Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level. Level 2 inputs consist of observable inputs other than quoted prices for identical assets. Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no Plan assets requiring the use of Level 2 or 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Stable value collective trust fund: A stable value fund that is composed primarily of fully benefit-responsive investment contracts that are valued at the NAV of units of the bank collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities' liquidations will be carried out in an orderly business matter. There are no unfunded commitments.

Note 4: Income Tax Status

The Plan obtained its latest determination letter dated June 30, 2020, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan has since been amended to comply with new regulations, but has not applied for a revised determination letter. However, the Plan Administrator and the Plan's tax counsel believe the Plan as currently designed and operated complies with the relevant sections of the IRC. The Plan is subject to income tax examinations generally for three years after they are filed. There are currently no examinations in process.

Note 5: Party-in-Interest Transactions

The Plan pays fees to the Trustee and holds notes receivable from participants. These transactions are party-in-interest transactions. These transactions are not considered prohibited transactions under ERISA regulations.

Note 6: Information Prepared and Certified by Trustee

Certain information related to the Plan's investments disclosed in the accompanying financial statements and supplemental schedule, were obtained or derived from information certified as complete and accurate by the Trustee of the Plan. This information includes investments held at December 31, 2024 and 2023, net appreciation in fair value of investments and interest and dividend income for the year ended December 31, 2024 and the valuation of notes receivable from participants and applicable interest income earned.

Note 7: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their accounts.

Note 8: Risks and Uncertainties

The Plan invests in various mutual funds and securities. Such investments are exposed to certain risks inherent to interest rates, credit markets, and prevailing economic conditions. Accordingly, it is reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying financial statements.

Investors in Plan assets should refer to each funds prospectus for information related to investment strategies, risks, uncertainties, and fair value considerations related to each fund.
