## INDEPENDENT AUDITOR'S REPORT

### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of the Gibbs Technology Company Employee Savings Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

**NOTES TO FINANCIAL STATEMENTS**

**1. DESCRIPTION OF THE PLAN**

The following description of the Gibbs Technology Company Employees Savings Trust (the Plan) provides only general information. Participants should refer to the Plan agreement for a more comprehensive description of the Plan's provisions.

*General:* The Plan is a profit-sharing plan covering employees of Gibbs Technology Company (the Company). The Plan was established January 1, 2002, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

*Eligibility:* Employees who have completed one year of service in which they have 1,000 or more hours of service are eligible to participate in the Plan. To be eligible for discretionary profit-sharing contributions, employees must also be employed on the last day of the Plan year and have worked 1,000 hours during the Plan year. Effective December 1, 2024, the Plan was amended to remove the one-year of service requirement for all contribution types.

*Contributions:* Participants may contribute a portion of pretax annual compensation, as defined in the Plan, not to exceed maximum amounts specified by the Internal Revenue Service (IRS), in accordance with a participant salary deferral agreement. Participants may also contribute a portion of post-tax annual compensation (Roth 401(k) deferrals). Participants who are at least 50 years of age may make an additional contribution to the Plan not to exceed \$7,500 for 2024 and 2023, under certain conditions. Participants may also contribute amounts representing rollover distributions from other qualified plans. The Company may contribute an amount of matching contributions determined by the Company at its discretion. In 2024 and 2023, the Company's matching contribution was equal to 100% of the participant's contributions not to exceed 3% of eligible compensation. Additional profit-sharing amounts may be contributed at the discretion of the Company. In 2024 and 2023, there were no profit-sharing contributions. Participants direct the investment of contributions into various investment options offered by the Plan.

*Participant accounts:* Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions, if any, and (b) Plan earnings, and (c) the participant's rollover contributions from other qualified benefit plans, if any, and charged with an allocation of Plan expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*Vesting:* Participants are automatically 100% vested in the portion of their accounts resulting from participant salary deferrals. Participants vest in employer matching and profit-sharing contributions at a rate of 20% after two years of service and in 20% increments each subsequent year with full vesting occurring after six years of service. A participant is considered to have one year of service for each one-year period in which he or she has worked 1,000 hours or more. Participants become automatically 100% vested in employer matching and profit-sharing contributions upon attaining age 65, total disability, or death.

*Forfeitures:* Forfeitures are used to reduce the Company's matching and profit-sharing contributions for the plan year following the plan year in which the forfeiture occurs. During the years ended December 31, 2024 and 2023, forfeitures used to offset the Company's matching contributions totaled \$38,169 and \$47,332, respectively. Remaining forfeitures to be used to offset the Company's matching contributions totaled \$35,025 and \$1,142 at December 31, 2024 and 2023, respectively.

*Notes receivable from participants:* Participants may borrow from their accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at a rate that is commensurate with local prevailing rates as determined by the Plan administrator. Principal and interest are payable ratably through payroll deductions.

*Payment of benefits:* Distributions to plan participants can be made any time after termination of employment. A participant may receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, a partial lump-sum amount, or if a participant is required to receive lifetime required minimum distributions, he or she may elect to receive distributions through installments equal to or exceeding the annual required minimum distribution amount.

*Administration:* John Hancock Retirement Plan Services serves as the Plan's third-party administrator and record-keeper. The record-keeper maintains the individual participants' accounts and provides records of balances and transactions to the Plan administrator and participants. John Hancock Trust Company (John Hancock) serves as the Plan's custodian and holds the Plan's assets, administers investment activity, and invests contributions into funds designated by each participant. The Company's Board of Directors is responsible for oversight of the Plan. The Plan's management determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Company's Board of Directors.

## **2. SIGNIFICANT ACCOUNTING POLICIES**

*Basis of accounting:* The financial statements of the Plan are prepared under the accrual basis of accounting.

*Valuation of investments:* Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade date basis. Dividends are recorded on the declaration date. Interest is recorded when earned. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Investment securities of the Plan are exposed to various risks, such as interest rates, market, and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

*Contributions:* Contributions from plan participants and the matching contributions from the employer are recorded in the year which the employee contributions are withheld from compensation.

*Notes receivable from participants:* Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

*Payment of benefits:* Benefits are recorded when paid.

*Expenses:* Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Certain administrative functions are performed by officers and employees of the Company. No officer or employee receives compensation from the Plan for these services. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

*Estimates:* The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

*Subsequent events:* Events that have occurred subsequent to December 31, 2024, have been evaluated through September 19, 2025, which represents the date the Plan's financial statements were approved by management and, therefore, available to be issued.

### **3. TAX STATUS**

The Plan adopted a Cycle 3 Restatement effective January 1, 2022, as an amendment and restatement of the existing plan to bring the Plan into compliance with legislative and regulatory changes. There were no significant changes to plan provisions as a result of the restatement. The IRS has determined and informed John Hancock Retirement Plan Services by letter dated June 30, 2020, that the non-standardized profit sharing plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC).

The Plan may rely on the opinion letter issued by the IRS as evidence that the Plan is qualified under the applicable sections of the IRC. The Plan is relying on the opinion letter. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, the Plan administrator believes the Plan is qualified as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **4. TERMINATED PARTICIPANTS**

Net assets available for benefits at December 31, 2024 and 2023 included \$2,776,797 and \$2,286,248 respectively, allocated to the accounts of individuals who, as of or prior to those dates, had withdrawn from actively participating in the operations of the Plan, generally as a result of terminating employment. These amounts may be paid within the next year, at the request of the participants. These participants receive no further contributions but do receive allocations of investment income and Plan expenses.

### **5. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

## 6. CERTIFICATION OF INVESTMENT INFORMATION

Certain information in the accompanying financial statements and the ERISA-required supplemental schedule of assets held at year-end related to investments held and notes receivable from participants as of December 31, 2024 and 2023, and net appreciation in fair value of investments, dividends and interest, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Trust Company, a qualified institution.

The Plan's independent auditors did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

## 7. FAIR VALUE OF INVESTMENTS

Plan investments are held in a trust and managed by John Hancock Trust Company, the Plan's custodian, and are unsecured. All investments are participant-directed and held by parties-in-interest.

A fair value hierarchy is used that prioritizes the inputs to valuation techniques used to measure fair value of balances that are required or permitted to be measured at fair value for reporting in financial statements. The hierarchy gives the highest priority to the unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to the unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy are described as follows:

The Plan's assessment of the significance of a particular input to the fair value measurement in its entirety requires judgment and considers factors specific to the asset or liability. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of valuation methodologies used for assets recorded at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Cash equivalents:* Valued at cost, which approximates fair value.

*Common collective trusts:* Valued at the net asset value (NAV) of the units of a bank or trust company collective trust. Stable value collective trusts are composed primarily of fully benefit-responsive investment contracts. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Investments in common collective trusts can generally be redeemed without restriction; however, in certain cases, redemption or purchase may be limited to prevent excess and/or short-term trading. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

*Mutual funds:* Valued at the daily closing price as reported by the fund on an active market, which is based on the underlying NAV of the shares held by the Plan at year-end. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
