Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of HLW International LLP Savings and Investment Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Note 1. Description of Plan

The following description of the HLW International LLP (the Company) Savings and Investment Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees. The Plan was adopted on January 1, 1983 and was subsequently amended on July 1, 2024. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

Eligibility

As of July 1, 2024, an employee is eligible to participate in the Plan's salary deferrals upon completion of one month of service.

Contributions

Participants may contribute up to 100% of pretax eligible compensation subject to the annual limit of the Internal Revenue Code (IRC) and may designate all or a portion of their deferrals as Roth deferrals. Participants age 50 and over may make additional pre-tax contributions. Participants may contribute amounts representing rollovers from other qualified plans. The Company may elect to make a matching contribution. Participants direct the investment of participant, rollover and matching contributions into various investment options offered by the Plan.

For employees with five years or more of service as of April 1, 2006, the match is equal to 50% of salary deferral up to 6% of compensation. For participants with less than five years of service at that date or hired after 2006, the match is equal to 33% of salary deferral up to 6% of compensation.

Employees may contribute to the Plan and receive matching contributions on the day that they satisfy the eligibility requirement. As of July 1, 2024, a participant is eligible for an employer match after completing one month of service. Participants must be actively employed by the Company as of December 31 to be entitled to receive a matching contribution for that year.

As of July 1, 2024, participants are subject to auto enrollment provisions which are designated as pre-tax elective deferrals in the amount of 3% of plan compensation.

Payment of Benefits

Upon termination of service, death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested account balance or installments over a period of time, determined in accordance with the plan agreement.

Participant Accounts

Each participant's account is credited with the participant's contribution and the employer's contribution and allocations of plan earnings and charged with an allocation of administrative expenses. Allocations are based on account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Investments of participant accounts are participant-directed.

Vesting

Participants are 100% vested in their salary deferred contributions. Vesting in the Company's contribution portion of their accounts is based on years of service. Participants employed prior to December 31, 2015, are 100% vested in all accounts, including employer contributions. For employees hired January 1, 2016, and thereafter, their share of employer contributions are subject to the following vesting schedule:

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are measured at their unpaid principal balance plus any accrued but unpaid interest. The loans are secured by the vested balance in the participant's account and bear interest rates ranging from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions and must be repaid within five years unless the loan is used to buy or build a principal residence. The maximum number of loans that may be outstanding at any one time is one. Delinquent participant loans are reclassified as distributions based upon the terms of the plan agreement. Loans mature at various dates through August 2026.

Forfeiture Accounts

Forfeitures are used to reduce future employer contributions or used to pay any administrative expenses of the Plan, subject to the Plan's provisions. For the year ended December 31, 2024, there were forfeitures of \$17,925 used against employer contributions. At December 31, 2024 and 2023, the available balance of forfeitures was \$0 and \$1,193, respectively.

Administrative Expenses

Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participants' accounts and are included in administrative expenses. Investment related expenses are included in net depreciation of fair value of investments.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Cash

Cash balances represent liquidated investments to be distributed to participants that have requested, but have not yet received, a distribution before year-end.

Benefit Payments

Benefits are recorded when paid. Payables are accrued for those benefits that are taken in the current plan year that are disbursed in the subsequent period.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates

Investment Valuation and Income Recognition

The Plan's investments in mutual funds are stated at fair value as determined by the Mid Atlantic Trust Company (MATC) by reference to quoted market prices of the underlying investments. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Investment in the Reliance Stable Value Fund – MetLife Series 25053, a common and commingled trust (the Trust), is valued at fair value.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Note 3. Information Certified by the Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company (Reliance), a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments as shown in the statements of net assets available for benefits as of December 31, 2024, and 2023
- Investment income as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Fair Value Measurement

Professional standards established a framework for measuring fair value under U.S. generally accepted accounting principles and expands disclosure about fair value measurements. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access
- Level 2** Inputs to the valuation methodology include: (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the asset or liability; and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full-term of the asset or liability.
- Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Common Collective Trust Fund/Stable Value: The fair value of the common collective trust is determined by the custodian of the common collective trust fund based on the underlying assets, which represent the net asset value, a practical expedient to fair value of units held by the Plan. The common collective trust does not have any unfunded commitments relating to its investments, or any restrictions on redemptions. Redemptions can be made on any business day and do not have a redemption notice period.

Mutual Funds: Valued at quoted market prices in active markets which represent the net asset value of the shares held by the Plan at year-end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Party-in-Interest Transactions

The Plan engages certain financial advisory services from third parties that qualify as party-in-interest transactions which are exempt from the prohibited transaction rules. Administrative expenses paid to third parties responsible for financial advisory services were \$93,276 for the year ended December 31, 2024.

Note 6. Tax Status

The Plan obtained its latest determination letter dated June 30, 2020, in which the Internal Revenue Service (IRS) stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The plan administrator and the Plan's trustee believe that the plan sponsor has operated the Plan in a manner that does not jeopardize this tax status. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7. Risks and Uncertainties

The Plan has a contract with its trustee that encompasses various investment instruments, including mutual funds and a common collective trust fund. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the market conditions in the near term could materially affect participants' account balances and the value of investments reported in the financial statements.

Note 8. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their account balances.

Note 9. Subsequent Events

The Plan has evaluated subsequent events through September 19, 2025, the date the financial statements were available for issuance. All subsequent events requiring recognition or disclosure have been incorporated in these financial statements.
