The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

Notes to Financial Statements

NOTE A--PLAN DESCRIPTION

The following brief description of the Lane & Associates, Inc. 401(k) Plan (formerly known as the Personnel Management Services, Inc. 401(k) Plan) ("the Plan") is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Lane & Associates, Inc. 401(k) Plan was established on July 1, 2008. The Plan is a discretionary contribution retirement plan covering all eligible employees of Lane & Associates, Inc. ("the Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Eligibility: Employees are eligible to participate in the Plan on the first day of the month coincident with or immediately following the date one year after date of employment and after having been credited with at least 1,000 hours of service. If an employee terminates employment after becoming a participant and is later re-employed, he becomes a participant on his re-employment date. Effective August 1, 2021, the Plan was amended to allow for participation immediately following the date three months after date of employment.

Directed Investment Accounts: The Plan permits every participant to direct the investment of his account balance under the Plan.

Contributions: Eligible employees are allowed to have made on their behalf, through salary reduction, an elective contribution up to the maximum amount allowed by the Internal Revenue Code. Participants may elect to contribute in the form of pre-tax and Roth 401(k) contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions in accordance with the Internal Revenue Code.

Effective January 1, 2016, the Plan was amended to include an automatic enrollment feature and to be considered a safe harbor plan. The automatic enrollment feature begins at 3% and increases by 1% each year up to a maximum of 6%. Employees must elect out of this option. As part of the Plan's transfer to a new custodian, the new adoption agreement calls for increases of 1% beginning in year three up to a maximum of 6%.

As part of the amendment to become a safe harbor plan, the Company is required to make matching contributions of 100% up to 1% of employee deferrals plus 50% of employee deferrals between 1% and 6%. The Company made matching contributions totaling \$1,512,778.

Prior to January 1, 2016, the Company had the option of making qualified matching employer contributions equal to a discretionary percentage of the participant's elective deferrals. Qualified matching employer contributions are allocated based on the participant's elective deferrals.

Participant Accounts: Each participant's account is credited with the participant's and Company's contributions and allocation of earnings. The participant's account is charged with benefit payments, transaction fees related to notes receivable from participants and distributions, and an allocation of losses and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Forfeitures: The nonvested portion of a terminated participant's account balance derived from employer contributions is forfeited on the earlier of the last day of the plan year in which the participant first incurs five consecutive one-year Breaks in Service or the distribution of the vested portion of the participant's account. Forfeitures are used to reduce any employer contributions and may be used to pay any administrative expenses. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$71,376 and \$16,541, respectively. Forfeitures of \$14,071 were allocated to reduce administrative fees.

Vesting: A participant has a 100% nonforfeitable interest at all times in his pre-tax savings contributions and any amounts he rolls over into the Plan, and any earnings thereon.

A year of vesting credit is given for each Plan year in which a participant completes at least 1,000 Hours of Service. Participants, who continue in the employ of the Plan sponsor, are generally granted 100% vesting in their account balances upon attaining normal retirement age (as defined by the Plan), death, or disability.

Funding Policy: The employer is generally required to pay its contribution to the Plan for each Plan year within the time prescribed by law, including extensions of time for the filing of the employer's federal income tax return for the fiscal year. However, employee elective contributions accumulated through payroll deductions shall be paid to the custodian as of the earliest date on which contributions can reasonably be segregated from the employer's general assets, but in any event, within the time prescribed by law. Furthermore, any additional employer contributions which are allocable to participants' accounts for a Plan year shall be paid to the Plan no later than the twelve-month period immediately following the close of such Plan year.

Payment of Benefits: A participant's vested interest in the Plan's assets is distributable to the participant, his spouse or other beneficiary generally upon termination, disability, retirement or death, and is distributed in a lump-sum amount.

Notes Receivable from Participants: Loans are granted at a minimum of \$1,000 up to a maximum of \$50,000 or 50% of the vested account balance, whichever is less, and bear interest at the prime rate. The loans are secured by the balance in the participant's account with principal and interest to be paid ratably through payroll deductions. All loans must be repaid within five years unless the loan is for the purchase of the participant's principal residence. Then, the loan must be repaid within a thirty-year period.

Hardship Withdrawals: Withdrawals due to financial hardship are permitted with the approval of the Administrative Committee for the following reasons: medical expenses, purchase of primary residence, post-secondary tuition payment, eviction from or foreclosure on principal residence, funeral expenses, casualty deduction expenses for the repair or damage to primary residence, or as otherwise provided by the Plan. Hardship withdrawals are limited to the employee's vested account, except earnings on pre-tax savings contributions.

Rollover Contributions: The Plan provides for rollover contributions from other qualified retirement plans.

NOTE B--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determines the Plan's valuation policies. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment Options: The investments of the Plan are held by Reliance Trust Company, custodian of the Plan. Standard Retirement Services, Inc. executes investment transactions within the guidelines adopted for each fund. At December 31, 2024, participants could direct the investment of their account balances in the following mutual funds: Standard Stable Asset A Fund, Western Asset Core Plus Bd I Fund, PIMCO Income Fund, Fidelity Freedom Income Fund, Fidelity Freedom Index 2020 Fund, Fidelity Freedom Index 2025 Fund, Fidelity Freedom Index 2030 Fund, Fidelity Freedom Index 2035 Fund, Fidelity Freedom Index 2040 Fund, Fidelity Freedom Index 2045 Fund, Fidelity Freedom Index 2050 Fund, Fidelity Freedom Index 2055 Fund, Fidelity Freedom Index 2060 Fund, Fidelity Freedom Index 2065 Fund, Vanguard Balanced Index Fund, Vanguard Equity Income Fund, Fidelity 500 Index Fund, T. Rowe Price Blue Chip Growth I Fund, Vanguard Mid Cap Value Index Fund, Fidelity Mid Cap Index Fund, MFS Mid Cap Growth R6 Fund, Vanguard Small Cap Value Index Fund, Fidelity Small Cap Index Fund, Vanguard Explorer Fund, Vanguard Developing Markets Index Fund, and JPMorgan Emerging Markets Eq R6 Fund.

Contributions: Employer and employee contributions are accrued in the Plan year to which they relate.

Benefit Payments: Benefit payments are recorded when paid.

Expenses: Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Use of Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Date of Management's Review of Subsequent Events: Plan management has evaluated events through September 22, 2025, the date which the financial statements were available to be issued.

NOTE D--INVESTMENT CONTRACTS

At December 31, 2024 and 2023, the Plan held an investment in a fully benefit-responsive investment contract. The investment is credited with earnings from the underlying investments and charged with withdrawals and expenses. The contract value of the investment was \$712,202 and \$806,834 as of December 31, 2024 and 2023, respectively. The crediting interest rates are based on an agreed-upon formula with the issuer.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Reliance Trust Company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under Employee Retirement Income Security Act of 1974 (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer.

NOTE E--PARTY-IN-INTEREST

Certain Plan investments were shares of investments managed by Standard Retirement Services, Inc. Standard Retirement Services, Inc. administers the Plan, therefore, related transactions qualify as exempt party-in-interest transactions as defined by ERISA. Fees paid by the Plan for the investment management services approximated \$83,868 for the year ended December 31, 2024.

NOTE F--TAX STATUS

The Plan adopted a volume submitter prototype plan that received a favorable opinion letter from the Internal Revenue Service dated June 30, 2020 that the plan qualified under the appropriate sections of the Code. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that, therefore, the Plan was qualified and the related trust was tax-exempt as of the financial statement date. Therefore, no provision for income taxes is included in the accompanying financial statements.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE G--PLAN AMENDMENT AND TERMINATION

While the Company has not expressed an intent to terminate the Plan, it is free to do so at any time subject to the provisions of ERISA. The Company also reserves the right to amend the Plan as conditions may require. However, neither through amendment, nor by termination, may any part of the Plan assets ever be returned to the Company. All assets of the Plan must be used for the exclusive benefit of participants. In the event of Plan termination, participants would become 100% vested in their accounts.

NOTE H--CERTIFIED INVESTMENTS

Information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including all investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company (the custodian of the Plan).

NOTE I--RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the net assets available for benefits.
