Independent Auditor's Report

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of OhioHealth Retirement Savings Plan (403(b)) (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statements of changes in net assets available for benefits for the years then ended and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the years then ended stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Accordingly, the objective of the ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

Notes to Financial Statements

1. Description of the Plan

The OhioHealth Retirement Savings Plan (403(b)) (the Plan) is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan sponsor is OhioHealth Corporation (the Company).

The following description of the Plan provides only general information. Participants should refer to the Summary Plan Description for a complete description of the Plan.

Effective October 21, 2024, assets of \$10,159,820 were merged into the Plan from the Pickaway Health Services, Inc. 403(b) Plan.

Contributions

The Plan is a defined contribution plan. All eligible employees (with limited exceptions) of the Company and any related entity that has adopted the Plan as a participating employer are permitted to participate in the Plan by making deferrals immediately upon hire. Participants may contribute any portion of their salaries and wages to the Plan, subject to certain limitations as prescribed by the Internal Revenue Code (the Code). The Company makes per-pay matching contributions to the Plan equal to 50% of a participant's elective contributions for the payroll period, not to exceed 2% of the participant's compensation for those participants with less than twenty years of service (not to exceed 3% of the participant's compensation for those participants with twenty or more years of service).

The Plan can receive a lump sum rollover contribution on behalf of a participant from a defined benefit retirement plan sponsored by an employer in the OhioHealth controlled group, including the OhioHealth Cash Balance Retirement Plan after such participant has incurred a severance from employment. The Plan will receive rollover contributions from other qualified plans, including Roth rollover contributions.

After-tax Roth contributions may be contributed to the participant's account in addition to or in lieu of pre-tax contributions to meet the elective contribution amount for the year. The total participant contribution will be eligible for the Plan matching contribution.

The Company will also make a "true-up" matching contribution for each participant receiving per-pay matching contributions that is employed by the Company or a related participating employer on the last day of the plan year. The requirement to be employed on the last day of the plan year does not apply if the participant terminates employment during the plan year due to the participant's retirement, death, or disability.

OhioHealth Retirement Savings Plan (403(b))

Notes to Financial Statements (continued)

1. Description of the Plan (continued)

The true-up matching contribution is calculated using the same allocation formula applicable to the per-pay matching contribution but taking into consideration plan year contributions (elective deferrals and catch-up contributions) and compensation.

Once employees begin contributing to the Plan, they are eligible for the employer matching contribution. Participants hired before July 1, 2016 vest or own the matching contribution upon deposit. Otherwise, participants hired on or after July 1, 2016 vest in the matching contributions after being employed for three plan years during which the participant completes at least 1,000 hours of service.

Associates hired or rehired on or after January 1, 2012, are eligible for an Annual Retirement Contribution (ARC). The amount of the ARC is a percentage of the participant's compensation based on the combination of the participant's age and years of service, ranging from 2% to 5% of compensation. To be eligible to receive the ARC, a participant must meet the following requirements prior to January 1 of the year for which the ARC is made: the participant must (1) be age 20 ½ - years or older and (2) have completed six months of service. For those participants who satisfy the initial ARC eligibility requirements, they will receive an annual ARC allocation for a plan year if they are employed on the last day of the plan year for which the ARC is made and have completed 1,000 hours of service in that plan year. The requirement to be employed on the last day of the plan year does not apply if the participant completes 1,000 hours of service during the plan year and terminates employment during the plan year due to the participant's retirement or death. If the participant was hired prior to January 1, 2015, the ARC becomes fully vested after the participant completes three years of service in which the participant completes at least 1,000 hours of service; or if the participant is employed by the companies at age 65. If the participant was hired on or after January 1, 2015, the ARC becomes fully vested after the participant completes three years of service in which the participant completes 1,000 hours of service; or if the participant is employed by the companies on the participant's normal retirement date.

Participants in the Plan have the option to open a BrokerageLink account through Fidelity. Participants can make regular and/or Roth contributions into the account. Through the BrokerageLink account, participants can invest in Fidelity mutual funds and non-Fidelity mutual funds available through Fidelity FundsNetwork. Participants may not invest in any other issue/security that may result in a prohibited transaction under the Plan. For further information, participants should refer to the Summary Plan Description for the Plan.

Participants can self-direct the investment of their accounts into various investment funds. The investments of all amounts in participants' accounts are participant-directed. Earnings on the investments are credited to each participant's account based on the number of shares owned by the

participant. The participants are 100% vested in the amounts that are contributed by both the participants and the Company (except as described above).

Benefit Payments

In general, upon termination of service, the participant's account can be distributed in the form of a lump-sum payment or can be kept in a separate account within the Plan that is held by the trustee. Under the Plan as designed, participants are not subject to federal income tax on the pre-tax (i.e., non-Roth after-tax) contributions and investment income credited to their accounts until such amounts are withdrawn pursuant to Section 403(b) of the Code. Withdrawals of pre-tax contributions by participants (including participants separated from the service of the Company for any reason) which are not rolled over into another qualified plan, or an individual retirement arrangement are subject to federal income tax (as applicable).

If a participant is not fully vested in the ARC or matching contribution on his or her termination date, the nonvested amount in his or her Plan account is forfeited. Forfeitures are used to pay reasonable Plan expenses or to reduce the companies' contributions for the plan year in which the forfeiture occurs, or any prior or future plan year, as determined by the Company in its discretion and in accordance with applicable legal requirements.

Termination

Although the Company has not expressed any intent to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA and the Code. Upon termination of the Plan, participants become 100% vested in their account balances.

Party-in-Interest Transactions

Certain Plan assets are in investment funds managed by Fidelity Management Trust Company (Fidelity) or their affiliates. Fidelity is the service provider of the Plan and, therefore, these transactions qualify as party-in-interest transactions as defined under ERISA guidelines.

Participant Notes Receivable

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Terms range from one to five years or up to 20 years for the purchase of a primary residence. The notes are secured by the balance in the participant's account and bear interest at 2% over prime on the first business day of the month before the loan

is taken. Principal and interest are paid ratably through regular Automated Clearing House (ACH) payments. The Plan also has a financial hardship distribution option that allows participants to withdraw funds for emergency needs that qualify under the IRS rules for financial hardship withdrawals from Code Section 403(b) plans.

2. Significant Accounting Policies

Valuation of Investments

Investments are stated at fair value, except as noted below. The fixed annuity contracts are considered benefit responsive and are valued at contract value. Contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents deposits made to the contracts, plus earnings at guaranteed crediting rates, less withdrawals and fees. All other investments are valued at fair value based on quoted market prices. See Note 6 and Note 7 for additional information.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Participant Notes Receivable

Participant notes receivable is recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable is written off when deemed uncollectible.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Fees for administrative services provided by Fidelity are deducted directly from each participant's plan assets. Other administrative expenses are borne by the Company including external legal and accounting services. In addition, the Company provides internal accounting and administrative services to the Plan at no charge.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including September 15, 2025, which is the date the financial statements were available to be issued.

Restatement

In 2024, it was determined that investments previously classified as common collective trust funds should have been classified as mutual funds. The common collective trust funds were also previously recorded at net asset value and excluded from the fair value hierarchy table and are now included in the fair value table in Note 6 as level 1 investments. Accordingly, the 2023 financial statements have been restated to confirm with this presentation.

3. Certified Information

Fidelity held the Plan's investment assets and participant notes receivable and executed related transactions as of and for the years ended December 31, 2024 and 2023. All information disclosed in the accompanying financial statements and supplemental schedule of assets held, including investments and participant notes receivable held at December 31, 2024 and 2023 and interest income, realized and unrealized gains and losses on investments, and interest from participant notes receivable for the years ended December 31, 2024 and 2023 was obtained or derived from information certified by Fidelity.

4. Income Tax Status

The Internal Revenue Service (IRS) is not currently accepting applications for individual 403(b) plan determination letters. The plan administrator believes that the Plan is designed and is currently being operated in compliance with applicable requirements of the Internal Revenue Code section 403(b). Therefore, no provision for income taxes has been included in the Plan's financial statements.

5. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

6. Fair Value

Accounting Standards Codification (ASC) 820 clarifies the definition of fair value, establishes a framework for measuring fair value, and expands the disclosures for fair value measurements. ASC 820 provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. In general, fair values determined by Level 1 inputs use quoted prices in active markets for identical assets or liabilities that the Plan can access. Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets and liabilities in active markets, and other inputs such as interest rates and yield curves that are observable at commonly quoted intervals. Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset or liability. In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset or liability.

7. Investment Contracts

The Plan has a benefit-responsive investment contract with The Lincoln National Life Insurance Company (Lincoln). Lincoln maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Interest will be credited daily on all contributions. The rate of interest credited each day, if compounded for 365 days, yields the effective annual interest rate in effect for the day. The guarantee that will be credited is an effective annual interest rate not less than the minimum guaranteed interest rate. Interest crediting rates are reviewed on an annual basis for resetting, but may not be less than 1.70 percent.

As described in Note 2, because the contract is benefit responsive, contract value is the relevant measure attribute for that portion of the net assets attributable to the investment contract.

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value with the insurance company. Such events include the following: (i) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (ii) changes to the plan's prohibition on competing investment options or deletion of equity wash provision, (iii) bankruptcy of the plan sponsor or other plan sponsor events (e.g. divestitures or spinoffs of a subsidiary) which cause a

significant withdrawal from the Plan, (iv) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (v) premature termination of the contract. The plan administrator believes that the occurrence of any such events, which would limit the Plan's ability to transact at contract value with participants, is not probable of occurring.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (i) an uncured violation of the Plan's investment guidelines, (ii) a breach of material obligation under the contract, (iii) a material misrepresentation, and (iv) a material amendment to the agreement without the consent of the issuer.
