Independent Auditors' Report

To the Advisory Committee of
U-Haul Holding Company 401(k) Savings Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the financial statements of U-Haul Holding Company 401(k) Savings Plan ("the Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Our audits did not extend to the certified investment information, except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedules Required by ERISA

The supplemental schedules of delinquent participant contributions for the year ended December 31, 2024, and assets (held at end of year) as of December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including its form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

(1) Description of the Plan

The following description of the U-Haul Holding Company 401(k) Savings Plan (the "Plan"), formerly known as the AMERCO 401(k) Savings Plan, provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

- A. General** – The Plan is a defined contribution plan under Section 401(k) of the Internal Revenue Code ("IRC") and covers substantially all employees of U-Haul Holding Company and its subsidiaries (the "Company"), who have at least thirty days of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").
- B. Trustee and administration of the Plan** – The trustee of the Plan is Fidelity Management Trust Company ("Fidelity" or "trustee") and the recordkeeper of the Plan is Fidelity Workplace Services, LLC. The trustee holds all assets of the Plan in accordance with the service provider contract with the Company. The Advisory Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.
- C. Participants contributions** – Participants may make pre-tax contributions from 1% to 100% of earnings subject to the Plan provisions and subject to certain IRC limitations. Participants are immediately vested in all participant contributions plus actual earnings thereon. Participants may also make after-tax Roth 401(k) contributions.

All employees of U-Haul Holding Company are eligible to voluntarily participate in the Plan on the first pay period after the employee has completed 30 days service. Participants are automatically enrolled with an initial deferral rate of 3%. Unless otherwise directed, such contributions will be invested in a Fidelity Freedom target-retirement date fund based on their age.

Those participants that are enrolled automatically will begin at 3% and have 1% increases to their contribution rate each year until they reach the default maximum rate of 10%. The automatic increases may be declined upon request. Eligible participants are notified of the automatic deferral rate of 3% and may elect not to contribute or contribute at a different rate.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants who are at least the age of 50 and who have reached the maximum salary deferral for the year, \$23,000 (actual dollars) in 2024, may defer an additional \$7,500 (actual dollars) subject to certain IRC limitations.

- D. Diversification contributions** – Participants of the U-Haul Holding Company Employee Stock Ownership Plan ("ESOP"), who have met the eligibility requirements in the ESOP's Plan Document, may elect to diversify a portion of their ESOP account to their 401(k) account. Diversification contributions are presented as Plan Transfers in the statement of changes in net assets available for benefits.
- E. Participant accounts and vesting** – Each participant's account is credited with the participant's contributions and an allocation of net Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on the participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants are fully vested in their own contributions and diversification contributions plus actual earnings.

(1) Description of the Plan (continued)

F. Notes receivable from participants – The Plan has enacted a provision authorizing participants to apply for loans secured by their account balance. Participants may borrow a minimum of \$1,000 (actual dollars) up to 50% of the participant's account balance, not to exceed \$50,000 (actual dollars) maximum. Spousal consent is not required on loans taken under the Plan. Loans are charged an interest rate equal to the prime rate, at the time the loan is drafted, plus two percentage points. All loans must be repaid within five years unless it is for the purchase of a primary residence in which case the loan repayment may not extend beyond fifteen years. Principal and interest are paid ratably through payroll deductions. If a participant stops making loan repayments as required by the promissory note, the loan will be declared in default after 60 days. Defaulted loans which are not repaid are deemed distributed and recorded as benefits paid to participants in the statement of changes in net assets available for benefits.

G. Distributions – Distributions from the Plan are available upon termination, retirement, age 59 ½, permanent disability or death. Participants may elect to receive amounts in one lump sum or in partial payments.

Upon termination of employment for any reason, the participant or beneficiary is entitled to receive the entire amount of the vested balance in their account or to leave the vested balance, subject to market changes, in the Plan until age 73. The Plan includes an involuntary distribution feature for terminated employees with balances of less than \$5,000 (actual dollars). Unless the participant provides alternate distribution instructions to Fidelity, balances under \$1,000 (actual dollars) are distributed directly to the participant in cash and balances over \$1,000 (actual dollars), but under \$5,000 (actual dollars) are deposited directly to an IRA at Fidelity. In the event of termination of the Plan, the net assets shall be distributed to participants in the order prescribed by the Plan.

Participants may also obtain a cash withdrawal of all or a portion of the value of their 401(k) account balance on the basis of hardship. The circumstances that qualify for hardship distribution are determined by Internal Revenue Service ("IRS") and are listed in the Plan document.

H. Forfeitures – Participants are immediately fully vested in their contributions and the earnings thereon. Therefore, there are no forfeited accounts.

(2) Summary of significant accounting policies

Basis of presentation – The accompanying financial statements are prepared on the accrual basis of accounting in accordance with US GAAP.

Use of estimates – The preparation of financial statements in conformity with US GAAP requires the Plan administrator to make estimates and assumptions that affect the reported amount of net assets available for benefits and changes therein. Actual results may differ from those estimates.

Payment of benefits – Benefits are recorded when paid.

Investment valuation and income recognition – All investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Advisory Committee determines the Plan's valuation policies utilizing information provided by the investment advisors. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes receivable from participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses have been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Administrative expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and the account maintenance fees for some participant, dependent upon their employment status and/or account balance are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments. Administrative expenses paid by the Plan totaled \$988 for the year ended December 31, 2024.

Plan termination – U-Haul Holding Company intends to continue the Plan indefinitely, however, it does reserve the right to amend or terminate the Plan under the terms of ERISA. Participants are fully vested in their own contributions at all times.

Risks and uncertainties – The Plan provides for various investment options. The values of the Plan's individual investments are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits and the statement of changes in net assets available for benefits.

Subsequent events – The Company's management has evaluated subsequent events through September 22, 2025, the date the financial statements were available to be issued.

(3) Fair value measurements

The Plan's investments are categorized using a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB Accounting Standards Codification ("ASC") 820, Fair Value Measurements and Disclosures, are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

(3) Fair value measurements (continued)

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from, or corroborated by, observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liability's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Money market funds – Money market funds are comprised of short-term (less than one year) securities representing high-quality, liquid debt and monetary instruments which are valued at amortized cost, which approximates fair value. The money market funds are classified as Level 1.

Registered investment company securities – Registered investment company securities held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission and are valued at the daily closing prices, as reported by the fund. These funds are required to publish their daily Net Asset Value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are classified as Level 1.

Common collective trust – The Plan held shares in a Common Collective Trust, the Managed Income Portfolio (“MIP”), during the Plan year with Fidelity, which holds indirect investments in fully benefit-responsive investment contracts. The MIP is valued daily using NAV per share. As of December 31, 2024 and 2023, the Plan had no unfunded commitments related to the common collective trust. The common collective trust investment has a daily redemption frequency and redemption notice period. There are no other restrictions on the timing of redemption; however, participant redemptions may be subject to certain redemption fees. The common collective trust investment is valued using the NAV per share (or its equivalent) as a practical expedient to estimate fair value, as determined based on the NAV of the underlying fund.

Accordingly, Fidelity, the trustee of the Plan, has certified that the following information included in the accompanying financial statements and supplemental schedules is complete and accurate:

- Investments
- Notes receivable from participants
- Interest and dividends
- Net appreciation in fair value of investments
- Interest earned on notes receivable from participants
- Schedule of assets (held at end of year)

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA required supplemental schedules.

(5) Related party and party-in-interest transactions

Certain Plan investments are managed by the Plan's Trustee, as described in Note 1, who holds the Plan's assets and executes investment transactions. Fees paid to the Trustee totaled \$988 for the year ended December 31, 2024. Such transactions represent party-in-interest transactions under ERISA regulations and are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

(6) Income taxes

The Plan uses a pre-approved plan from Fidelity Management & Research Company (FMR), which received an opinion letter from the Internal Revenue Service (IRS) on June 30, 2020, which states that the pre-approved plan, as then designed, satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. Although the Plan has been amended since the date of the opinion letter, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

US GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.

(8) Non-exempt transactions

The DOL's regulations require defined contribution plans to remit participant contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets but not later than the 15th business day of the month following the month in which the participant contributions are withheld by the employer. For the year ended December 31, 2024, the Company failed to remit certain participant contributions totaling \$356 (not in thousands) to the Plan in a timely manner constituting a lending of such monies to the Company. During 2024, Plan management used the DOL lost earnings calculator to estimate the lost earnings on these late contributions and determined them to be immaterial. The lost earnings were remitted to the Plan in August and September 2024.
