Note 1 Description of Plan

The following description of the San Antonio Regional Hospital Savings Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General - The Plan was established to provide retirement benefits for employees of San Antonio Regional Hospital (the "Hospital"). The Plan is a defined contribution plan established on January 1, 2006, under the provision of Section 401(k) of the Internal Revenue Code (“IRC”). The Plan covers all eligible employees of the Hospital. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions - Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the plan document and are subject to limitations by the IRC. Participants may also elect to contribute to a Roth subject to limitations by the IRC. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

Under the Plan's automatic enrollment contribution provision, the Hospital deducts an automatic enrollment contribution equal to 2% of compensation, from each automatic enrollee’s compensation, and contributes it to the Plan effective the first payroll date that is administratively feasible. The amount of each automatic enrollee’s contribution will automatically increase by 1% of compensation, not to exceed 3% of compensation, beginning the first day of the plan year that is at least 12 months after the participant’s automatic enrollment start date. Automatic enrollment contributions end the earlier of: (1) the first payroll date that is administratively feasible after the automatic enrollee elects to stop automatic enrollment contributions or changes the amount of elective deferrals, or (2) the date the automatic enrollee ceases to be an eligible employee.

All newly hired employees are eligible to participate in the defined contribution retirement plan. The Hospital makes a matching contribution of 50% of participant contributions up to 5% of their eligible compensation. The Hospital may make an additional discretionary contribution to the Plan. There were no discretionary contributions made for the years ended December 31, 2024 and 2023.

Effective November 1, 2024, the Plan was amended to allow participants to contribute to Roth Deferrals.

Participant Accounts and Vesting - Each participant's account is adjusted by the participant's contributions, employer matching contributions (if any), and allocations of (a) the employer profit sharing contributions (if any), (b) plan earnings (losses) and, (c) administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the employer contributions portion of their accounts (if any), is based on years of continuous service. A participant is 100% vested after 5 years of credited service.

Notes Receivable from Participants - Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and are generally repaid through payroll deductions. Interest is charged on loans at a rate ranging from 4.25% to 9.50%. The loans must be repaid within 5 years (unless used to purchase a principal residence).

Payment of Benefits - On termination of service due to death, disability, retirement, or other reason, a participant will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account.

Forfeitures - At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$506,680 and \$170,960, respectively. These accounts can be used to offset plan expenses or may be used to reduce the employer matching contributions. Forfeitures used to reduce employer matching contributions were \$38,817 for the year ended December 31, 2024.

Note 2 Summary of Significant Accounting Policies

Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes there-in, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Note 2 **Summary of Significant Accounting Policies** (continued)

Investment Valuation and Income Recognition - Investments are reported at fair value (except for the fully benefit-responsive investment contract which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements. Fully benefit-responsive investment contracts are reported at contract value, see Note 6.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Excess Contributions Payable - Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service ("IRS") are recorded as a liability with a corresponding reduction to contributions.

Payment of Benefits - Benefits are recorded when paid.

Administrative Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Hospital. Expenses that are paid by the Hospital are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

Subsequent Events - The Plan has evaluated subsequent events through September 4, 2025, the date the financial statements were available to be issued.

Note 3 Party-in-Interest Transactions

Certain plan investments are shares of mutual funds managed by Lincoln Financial Group Trust Company, Inc. ("Lincoln"). Lincoln is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transaction by the United States Department of Labor's ("DOL") Rules and Regulations.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Note 4 Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to, or derived from information certified as completed and accurate by Lincoln Financial Group Trust Company, Inc.

Note 5 Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable input (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Code ("FASB ASC") 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any inputs that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Trust Funds: Valued at the NAV of units of a bank common trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sales) may occur daily.

Note 6 Fully Benefit-Responsive Investment Contracts

Lincoln Stable Value Account is a group fixed annuity contract issued by Lincoln Retirement Services Company, Inc., the plan trustee, that meets the requirements for fully benefit-responsive investment contracts and as such is shown at contract value. Under the terms of the existing contract, the composite crediting rate is currently reset on a semi-annual basis and will never be less than the guaranteed minimum interest rate.

The credited interest rate may be based on an index rate specified in the contract or a declared rate, either of which may be changed quarterly and will never be below the guaranteed rate. The Lincoln Stable Value Account contract is backed by the general account assets of the issuing company. Due to the nature of this contract, it does not have specific underlying assets assigned. The value of the group fixed annuity contract is reported at contract value. Contract value represents the amount participants would receive if they were to initiate a benefit-responsive transaction under the terms of the ongoing plan. Group fixed annuity contracts are between the Plan and the issuer and may not be assigned or sold to another party without the consent of the issuer. The fair value of the group fixed annuity contract would be derived by the plan sponsor.

No event would result in the Plan not being able to receive contract value over a five-year installment period. Any of the following events could trigger termination by the issuer, resulting in the Plan not being able to receive immediate contract value: (a) Any charges billed to the contract owner haven't been paid to Lincoln within 30 days (b) The Plan ceases to meet the requirements of the IRC for purchasers of this contract (c) At any time following the end of the third contract year, the contract owner's account balance is less than \$15,000. (d) At any time following the end of the third contract year, there is no deposit activity for a 24-consecutive-month period and the contract owner's account balance is less than \$50,000 (e) The contract owner fails to furnish requested information or other documentation (f) Lincoln discovers any misrepresentation of material information (g) Lincoln discontinues offering this contract form to the public (h) The Plan terminates its recordkeeping agreement with Lincoln.

The plan administrator does not believe that the occurrences of any such events, which would limit the Plan's ability to transact at contract value with participants, are probable.

Note 7 Plan Termination

Although it has not expressed any intent to do so, the Hospital has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

Note 8 Tax Status

The Hospital has adopted a Prototype 401(k) Plan and related trust. The IRS, by a letter dated June 30, 2020, has determined that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Hospital believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
