### Notes to Financial Statements

#### 1. Description of Plan:

The following description of the Modea Holdings, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement or summary plan description for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering all eligible employees of the participating employers under Modea Holdings, Inc. The participating employers include Ozmo Holdings, Inc. and Modea Holdings, Inc. (collectively, the "Company") Employees become eligible to participate upon hire and after attaining age 21. Employees are eligible for entry to the Plan on the first day of each month of the Plan year following the date the employee satisfies the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

**Contributions:** The Plan provides for participant contributions of pre-tax and after-tax annual compensation, as defined in the Plan.

Annually, the Company makes a Safe Harbor Non-Elective contribution to the Plan in the amount of 4% of the participants' covered compensation for the plan year. In addition to the Safe Harbor Non-Elective contributions, the Company may make a matching contribution equal to the lesser of (i) the product obtained by multiplying a discretionary matching percentage, determined by the Plan Sponsor annually, by the amount of the participants' before tax contributions which do not exceed 4% of the participants' covered compensation for the plan year.

**Participant Accounts:** Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions and (b) Plan earnings or losses, and charged with an allocation of administrative expenses. Allocations are based on participant compensation or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Investment Options:** Participants may direct the custodian as to the investment of their account balances in accordance with guidelines established by the Plan. Participants may change their investment elections at any time.

**Vesting:** Participants are immediately vested in their contributions and the Company's contributions plus actual earnings thereon.

**Plan Administration:** Overall responsibility for administering the Plan rests with the Company. Participant accounts are administered by Ascensus, LLC, the third-party administrator of the plan.

**Payment of Benefits:** Distribution of the vested portion of a participant's account will occur upon the participant's termination of service, retirement, death, disability, or hardship withdrawal, as defined in the Plan. A participant is entitled to receive a lump-sum payment in an amount equal to the vested value of his or her account.

### Notes to Financial Statements, Continued

#### 2. Summary of Significant Accounting Policies:

**Basis of Accounting:** The financial statements of the Plan are prepared on the accrual method of accounting.

**Investment Valuation and Income Recognition:** The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits:** Benefits are recorded when paid.

**Use of Estimates:** The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

**Subsequent Events:** Management has evaluated subsequent events through September 15, 2025, the date the financial statements were available to be issued and has determined that there are no subsequent events to be reported in the accompanying financial statements.

#### 3. Fair Value Measurements:

The Financial Accounting Standards Board ("FASB") has issued guidance for measurement and disclosure of fair value and establishes a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value as follows:

#### 3. Fair Value Measurements, Continued:

Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for investments carried or disclosed at fair value:

**Mutual funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Money market fund:** Valued at the cash balance.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 4. Administrative Expenses:

Although not required by the Plan, a portion of the costs of the Plan administration is absorbed by the Company. The Plan paid administrative fees totaling \$7,070 during 2024 and \$7,030 during 2023.

#### 5. Related Party Transactions:

The Plan did not engage in any transactions with parties-in-interest during 2024. Administrative expenses (see Note 4) were paid through revenue sharing arrangements with Vanguard, which receives indirect compensation from certain mutual funds held by the Plan. No payments were made by the Plan to Ascensus, LLC or any other service providers.

#### 6. Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

#### 7. Tax Status:

The Internal Revenue Service has determined and informed the prototype sponsor by letter dated June 30, 2020 that the adopted prototype plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code.

Management has evaluated the effects of accounting guidance related to uncertain income tax positions and concluded that the Plan had no significant financial statement exposure to uncertain income tax positions at December 31, 2024 and 2023. The Plan is not currently under audit by any jurisdiction.

#### **8. Risks and Uncertainties:**

The Plan provides for various investments in mutual funds and a money market fund. Investments are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the financial statements.
