We have performed audits of the financial statements of Riverside Resort and Casino 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Riverside Resort and Casino 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

1. Description Of The Plan

The Riverside Resort and Casino (the Company) 401(k) Profit Sharing Plan (the Plan) was established effective January 1, 1994.

The following description of the Plan is provided for general information purposes only. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a voluntary savings and retirement plan that covers all full-time employees of the following entities (Covered Entities) who have one year of service with a minimum of 1,000 hours of service and are age eighteen or older:

Riverside Resort and Casino (a proprietorship)
Riverside Resort and Casino, Inc. (a corporation)
Laughlin Transit, Inc. (a corporation)
Bullhead Warehouse, LLC (a limited liability company)

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Participants may contribute their desired percent of their annual pre-tax compensation as defined in the Plan. Participants may increase or decrease their contribution percentages on any subsequent pay period. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers).

The Covered Entities currently contribute 25% of the first 4% of compensation that a participant contributes to the Plan. The matching contribution percentage is determined by the Covered Entities annually on a discretionary basis. Any contributions forfeited by a participant due to termination are allocated to a forfeiture account.

Contributions are subject to certain limitations.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Covered Entities' contribution portion of their accounts plus actual earnings thereon is 20% for each year of service. After five years of service, each participant is fully vested. A participant is fully vested upon reaching normal or early retirement age, death, or total disability as defined in the Plan Agreement.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Covered Entities' contributions and an allocation of Plan earnings (losses). The allocation of earnings (losses) is determined by the earnings (losses) of the participant's investment selections based on each participant's account balance, as defined in the Plan Agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Investment Options

Upon enrollment in the Plan, a participant may direct contributions to any of the options offered by the Plan. Participants may change their investment options daily. Lincoln National Life Insurance Company is the Asset Custodian of the assets of the Plan.

Notes Receivable From Participants

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan transactions are treated as a transfer to (from) the investment fund and from (to) the participant notes fund. Loan terms range up to 5 years or longer if used for the purchase of a primary residence and are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates. Principal and interest is paid ratably through payroll deductions.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan Document.

Payment Of Benefits

Upon retirement, termination, disability or death, a participant, or his or her beneficiary in the event of death, may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Additionally, participants may take an in-service distribution upon reaching age 59½. Upon termination, automatic distributions are required for balances of less than \$5,000. Effective April 1, 2024, this threshold was increased to \$7,000. Generally, certain minimum distributions are required for participants who have reached age 73 (72 if the participant reached 72 before January 1, 2023 and 70 ½ if the participant reached 70 ½ before January 1, 2020).

The Plan allows hardship withdrawals, subject to account balance limits and applicable laws.

Forfeitures

At December 31, 2024 and 2023, there were \$7,419 and \$2,653, respectively, in forfeited nonvested accounts. Any balances plus earnings on these amounts will be used to pay Plan expenses and to the extent of any excess in the account for future additional Covered Entities' contributions. There were no forfeitures from nonvested accounts utilized to pay Plan expenses or reduce future contributions for the year ended December 31, 2024.

2. Summary Of Significant Accounting Policies

Basis Of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use Of Estimates In The Preparation Of Financial Statements

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Investment Valuation And Income Recognition

The Plan has entered into investment contracts with Lincoln National Life Insurance Company (Lincoln). Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (and exit price). The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in the fair value of investments represents the difference between the aggregate fair value of investments at year end and the values at the beginning of the year, and includes any realized gains and losses in shares that were bought and sold during the year.

Investment contracts that are fully benefit-responsive are reported at contract value, rather than fair value, because contract value is the amount participants would receive if they were to initial permitted transactions under the terms of the Plan. The Plan's investment in the Lincoln Guaranteed Account is a fully benefit-responsive investment contract and is reported at contract value in the statement of net assets available for benefits.

Payment Of Benefits

Benefits are recorded when paid.

Administrative And Transaction Expenses

Certain expenses of maintaining the Plan, including the annual audit and other administrative costs, are paid directly by the Company and are excluded from these financial statements. Other expenses related to the administration of the Plan are calculated as a percentage of participant accounts and are included in administrative and transaction expenses. Fees related to the issuance of notes receivable from participants are charged directly to the participant's account. Investment related expenses are included in the net change in the fair value of investments.

Subsequent Events

Management evaluates subsequent events through the date the financial statements are available for issue, which is the date of the Independent Auditors' Report.

3. Certified Financial Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, and the net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Lincoln National Life Insurance Company. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information that appears throughout the financial statements and supplemental schedule. 4. Fair Value Measurements

The Plan utilizes an established framework for measuring fair value of investments. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Pooled Separate Accounts (PSAs)

Pooled separate account values are not publicly quoted but are available to current investors via the employer website or when plan participants access their account values. PSAs are valued at the NAV reported by the Asset Custodian of the accounts. The NAV is determined by dividing the net assets, at fair value, of the fund by the number of units outstanding on the day of valuation. PSAs are primarily comprised of shares of registered investment companies held through subaccounts of a separate account of an insurance company at December 31, 2024 and 2023. The Plan has concluded that the NAV as adjusted (for mutual fund dividends, mutual fund splits and administrative maintenance charges and other items) and reported by the insurance company represents fair value of the investments. The NAV is used as the practical expedient to estimate fair value. All of the PSAs held by the Plan file an annual report on Form 5500 as a direct filing entity. The PSAs held by the Plan are not required to be reported in the fair value hierarchy.

The preceding method described may result in a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6. Investments At Contract Value

The Plan has a traditional investment contract with Lincoln National Life Insurance Company. The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. The following represents the contract value of the investment contract held by the Plan as of December 31:

The contract issuer of the guaranteed investment contract is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1 percent. The crediting rate is reviewed on a quarterly basis for resetting. The contract cannot be terminated before the scheduled maturity date.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

- 1) The Plan's failure to qualify under section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under section 501(a) of the internal revenue code.
- 2) Premature termination of the contracts.
- 3) Plan termination or merger.
- 4) Changes to the Plan's prohibition on competing investment options.
- 5) Bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different than contract value. Those events may be different under each contract. Examples of such events include the following:

- 1) An uncured violation of the Plan's investment guidelines.
- 2) A breach of material obligation under the contract.
- 3) A material misrepresentation.
- 4) A material amendment to the agreements without the consent of the issuer.

The average yield was 2.77 percent for the year ended December 31, 2024.

7. Administrative Expenses

The Company pays certain annual administrative expenses of the Plan. Participants pay the Plan's asset maintenance fees and loan fees.

8. Income Tax Status

The Plan adopted a pre-approved plan document sponsored by Lincoln Retirement Services Company, LLC. The pre-approved plan has received an opinion letter dated June 30, 2020, from the Internal Revenue Service (IRS) as to the pre-approved plan's qualified status. The Company has determined that it is eligible to, and has chosen to, rely on the current IRS pre-approved plan opinion letter. Although the Plan has been amended since the pre-approved plan received the letter, the Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable provisions of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

9. Party-In-Interest Transactions

Currently, Lincoln National Life Insurance Company, which is a party-in-interest, provides investments, investment management and record keeping services to the Plan. Fees paid by the Plan related to these services were \$26,288 for the year ended December 31, 2024.

10. Risks And Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

11. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan at any time subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Covered Entities' contributions.
