**Note 1 – Description of Plan**

The following description of the Bill Whitters Construction, Inc. 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more comprehensive description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all full-time employees of Bill Whitters Construction, Inc. and Philipp's Trucking LLC (collectively referred to thereafter as the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Trustees is responsible for oversight of the Plan.

Contributions

Participants in the Plan may contribute a portion of their annual compensation, as defined in the Plan, not to exceed the limit of the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit and defined contribution plans, as well as after-tax contributions from their current compensation. Participants direct the investments of their contributions into various investment options offered by the Plan. If the participant does not make an investment election, the contributions are invested in the Plan's default investment option. For the years ended September 30, 2024 and 2023, the Company made a discretionary contribution equal to one-third of salary deferrals up to 6% of eligible compensation that a participant contributed to the Plan. Additional discretionary amounts may be contributed at the option of Company's management. Company contributions are invested in the same manner as participant contributions. Contributions are subject to certain IRS limitations.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's matching contributions and allocations of Plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The Plan allows each participant to choose his or her own investment mix for Company and participant contributions. Participants can change their investment elections at any time.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in the Company's discretionary contributions portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service.

Notes Receivable from Participants

The Plan allows a participant or his/her beneficiary to borrow up to 50% of the vested account balance not to exceed \$50,000, with the minimum loan allowed being \$1,000. Principal residence loans must be repaid within ten years with a reasonable interest rate, while loans for any other purpose are due within five years with the same interest rate. The loans are secured by the balances in the participants' accounts and bear interest at rates ranging from 5.25% to 9.75%. Principal and interest is paid ratably through scheduled payroll deductions.

Payments of Benefits

On termination of service due to death, disability, or retirement, a participant will receive a lump-sum amount equal to the value of his or her vested account balance. Installment payments are only available for participants subject to lifetime required minimum distributions. In the event of a death, and the death benefit exceeds \$5,000, a beneficiary may elect to receive either a lump-sum amount equal to the value of the participant's vested account balance, or annual installments at least equal to the required minimum distribution amount. Terminated participants with vested balances of less than \$5,000 can be distributed in lump-sum amounts without participant election.

Forfeited Accounts

As of September 30, 2024 and 2023, the forfeited nonvested account total was \$7,733 and \$5,516, respectively. This account is used to pay administrative fees and reduce employer contributions. For the year ended September 30, 2024, the forfeited nonvested account did not pay any administrative expenses or offset Company contributions.

**Note 2 – Summary of Significant Accounting Policies**

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value, except for the investment contract which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. The Plan administrator monitors delinquent loans in order to estimate the allowance for credit loss. As of September 30, 2024 and 2023, the allowance for credit loss is zero. If a participant ceases to make loan repayments and the Plan administrator deems the participant loans to be in default, the participant loan balance is reduced, and a benefit payment is recorded. As of September 30, 2024, the Plan did not have any delinquent notes receivable from participants.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses. Plan administration fees are allocated to participants' accounts or offset against the forfeited nonvested account. Investment related expenses are included in net depreciation of fair value of investments.

Subsequent Events

The Plan Administrator performed an evaluation of subsequent events through July 14, 2025, which is the date the financial statements were available to be issued. There are no subsequent events that require disclosure or recognition in the financial statements as of year end.

**Note 4 – Fair Value Measurements**

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Professional Standards are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets and liabilities in active markets
- quoted prices for identical or similar assets and liabilities in inactive markets
- inputs other than quoted prices that are observable for the asset or liability
- inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at September 30, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 6 – Investment Contract with Insurance Company**

The Plan entered into a guaranteed investment contract with Standard Insurance Company (Standard) totaling \$739,554 and \$627,585 as of September 30, 2024 and 2023, respectively. Net deposits invested in the Standard Stable Asset D become part of Standard Insurance Company's general account. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1 percent, unless the rate is decreased to offset fees. The crediting rate is reviewed on a quarterly basis for resetting.

This contract meets the investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Standard, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or, (3) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) failure to abide by state or federal law, (2) failure to render performance necessary to comply with the terms of the contract, (3) failure to maintain assets of at least \$25,000, (4) plan disqualification, or, (5) failure to adopt the plan in a reasonable period of time.

**Note 7 – Tax Status and Plan Amendments**

The Plan is a non-standardized defined contribution prototype plan sponsored by Standard Insurance Company, the Plan's third party administrator. The prototype plan has received a letter from the Internal Revenue Service as to its qualified status. The Plan obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Professional standards require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan has open tax years for the three years prior to September 30, 2024.

**Note 8 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

**Note 9 – Related Party Transactions and Party-in-Interest**

Certain Plan investments are shares of a guaranteed interest account managed by The Standard. Fees totaling \$48,223 were expensed by the Plan to The Standard, the Plan's third party administrator, for distribution and recordkeeping fees for the year ended September 30, 2024.
