Notes to Financial Statements

Note 1: Description of Plan

The following description of the South Lyon Medical Center Tax Deferred Annuity Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan under Code Section 403(b) covering all eligible employees of South Lyon Medical Center (the "Organization"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Board of Trustees is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Board of Trustees.

Eligibility

There are no minimum age or service requirements to make salary reduction deferral contributions. During 2024, the plan made an amendment that requires two months of service for employer contribution eligibility from January 1 to May 14, with no age minimum. As of May 15, 2024, both age and service requirements were removed, and employees are eligible upon employment. The plan also includes a 2% automatic deferral, which employees may change at any time, beginning January 1, 2024.

Contributions

Each year, participants may contribute pretax annual compensation, as defined in the Plan. The amount is the maximum limitation permitted by law. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). The Organization provides discretionary nonelective contributions, which employees become eligible at the same time they are eligible to make employee contributions. Matching contributions follow a tiered formula: 100% match on the first 2% of elective deferrals and 50% on the next 2%. In 2024, the total discretionary contribution by the Organization was \$182,101. Catch-up contributions for employees aged 50 or with 15 years of service are allowed but not matched.

Participants may elect to make a Roth deferral. These deferrals are subject to federal income taxes in the year of deferral. Participants may also contribute amounts representing distributions from other Roth elective deferral amounts only to a participant's current Roth elective deferral account.

Note 1: Description of Plan (Continued)

Participant Accounts

Each participant's account is credited with the participant's contributions, the Organization's contributions, and earnings thereon, and charged with an allocation of plan expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

All investments of the Plan are participant directed. Participants have the option of directing their account balance to one or more different investment options offered by the Plan.

Vesting

Participants are vested immediately in their voluntary contributions plus actual earnings thereon. Vesting in the Organization's contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. Participants with less than three years of credited service have a vesting percentage of 0%. Participants become fully vested after three years of credited service.

Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance vested in the Plan. Loan terms range from one to five years except for the purchase of the participant's primary residence, for which the terms may extend beyond five years. The loan transactions are secured by the balance in the participant's account and bear interest at a fixed rate determined by the plan administrator based on prevailing market conditions. Interest rates on existing loans range from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

The Plan provides for payment of the entire vested balance in the participant's account upon retirement, death, disability, or termination of employment. The method of payment will generally be in the form of lump-sum distribution, annuity, or installment payments. A participant will receive a lump sum payment for the vested balance in his or her account if the balance is less than \$1,000. Amounts greater than \$1,000, but less than \$7,000 are subject to automatic IRA rollover requirements. In addition, hardship distributions from voluntary contribution accounts are permitted if certain criteria are met. The Plan also allows for in-service distributions for participants who are 100% vested and have attained age 59 1/2.

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0 for both years. These accounts will be used first to restore plan forfeitures to participants and pay plan expenses and then to reduce future employer contributions. In 2024, forfeitures in the amount of \$4,081 were used to reduce administrative expenses and employer contributions.

Note 1: Description of Plan (Continued)

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses paid by the Organization are excluded from these financial statements. Fees related to the administration of benefits paid to participants and loan fees are charged directly to the participant's account and are included in administrative expense. Investment-related expenses are included in net appreciation in fair value of investments.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation/depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

The Secure 2.0 Act

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. Management has evaluated those provisions and determined there is no material impact on the Plan. Plan management will determine the optional provision to elect in the future.

Subsequent Events

The Plan has evaluated subsequent events through September 9, 2025, which is the date the financial statements were available to be issued. The Custodian changed from Matrix Trust Company to Vanguard on April 22, 2025. The plan assets were moved to Vanguard on May 9, 2025.

Note 3: Information Prepared and Certified by the Custodian

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Matrix Trust Company (the Custodian of the Plan).

Note 4: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Note 4: Fair Value Measurements (Continued)

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value. There has been no change in the methodologies used as of December 31, 2024 and 2023.

Money Market Fund: Valued at the net asset value of \$1. These money market funds are comprised of short-term securities, representing highly-liquid debt and monetary instruments.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Transfers Between Levels

For the years ended December 31, 2024 and 2023, there were no transfers between Levels 1, 2 or 3.

Note 5: Related-Party Transactions and Party-in-Interest Transactions

Certain plan investments were managed by CUNA Mutual Group. CUNA Mutual Group is the recordkeeper as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees for the investment management services during the plan year ended December 31, 2024, were offset against earnings. Specific detail for management fees is not available from the Custodian.

CPI Qualified Plan Consultants, Inc. provided consulting services, participant loan processing, participant communication, and recordkeeping services to the Plan. These transactions qualify as party-in-interest transactions. Fees for the services provided during the plan year ended December 31, 2024 were \$3,832.

Palisade Investments, LLC provided investment advisory services to the Plan, and, therefore, these transactions qualify as party-in-interest transactions. Fees for investment advisory services during the plan year ended December 31, 2024 were \$3,749.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Note 6: Plan Termination

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Organization contributions.

Note 7: Tax Status

The Plan's terms have been drafted in reliance on the sample language provided by the IRS. The Plan is required to operate in conformity with the IRC to maintain the exclusion from tax for plan participants. The Plan's management believes the Plan is currently designed and operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

Note 8: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
