**NOTE 1 – DESCRIPTION OF PLAN**

The following description of the Tri-West, Ltd. 401K/Profit Sharing Plan (the “Plan”) provides only general information about the Plan. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan established by Tri-West, Ltd. (the “Company”) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended. All employees of the Company, excluding employees covered by a collective bargaining agreement, leased employees, employees that are residents of Puerto Rico, or certain nonresident aliens, are eligible to participate. The Plan is intended to satisfy the provisions of Section 401(k) of the Internal Revenue Code (“IRC”) of 1986, as amended.

Fidelity Management Trust Company (the “Trustee”) is the Plan’s custodian and trustee. The Company and certain members of management are the plan administrators.

Eligibility: Employees are automatically enrolled in the Plan upon meeting the Plan eligibility requirements, unless the employee makes an election to waive participation in the Plan. Prior to January 1, 2024, employees were eligible to enter the elective deferral and employer contributions sections of the Plan following completion of one year of service and 1,000 hours. Effective January 1, 2024, the one year and 1,000 hours of service requirements for participant elective deferrals was waived, and employees can contribute to the Plan immediately upon hire. There is no minimum age requirement for participation. Plan entry dates for participant elective deferrals are immediate upon meeting all eligibility requirements, and the first day of each month for employer contributions.

Contributions: Each participant may elect to contribute up to 60% of his or her eligible compensation to the Plan, subject to certain IRC limitations, up to a maximum of \$23,000 for the 2024 plan year. Participants may also rollover amounts representing distributions from other qualified plans. Participants that are 50 years of age or older who have met the annual IRC deferral limit or the specified Plan limits for deferral, may contribute a catch-up deferral of up to \$7,500 for the 2024 Plan year.

The Plan provides for an auto-enrollment feature whereby a participant is automatically enrolled in the Plan to make contributions at a default contribution rate of 3% of eligible compensation unless the participant affirmatively opts out. The default contribution rate for each participant is automatically increased by 1% annually on June 1 not to exceed an additional 3% of eligible compensation, except with regard to the first such annual increase which shall not apply to a participant within the first six months following the date such participant was automatically enrolled.

The Plan provides for a default bonus deferral election of 0%. Participants electing to have a contribution withheld from bonus compensation must enter into a special salary reduction agreement with the Company.

The Plan provides a Safe Harbor Formula for a 401(k) Safe Harbor Nonelective Employer Contributions Election (“Safe Harbor Contribution”). For each plan year, the employer shall contribute for each eligible participant an amount equal to 3% of each eligible participant’s compensation for such plan year. For the year ended December 31, 2024, the Company elected to contribute a Safe Harbor Contribution of 3% of each participant’s compensation, which amounted to \$849,391.

The Plan also permits the Company to make a discretionary profit sharing contribution (“Profit Sharing Contribution”) to each participant’s account. For the year ended December 31, 2024, Profit Sharing Contributions were \$1,450,609.

At December 31, 2024 and 2023, the Safe Harbor Contribution and Profit Sharing Contribution are included in employer contribution receivable in the accompanying statements of net assets available for benefits.

All contributions to each participant's account are self-directed by the participant in one or more of the investments offered under the Plan.

Participant Accounts and Investment Options: Each participant's account is credited with the allocable portion of the Company's contributions and Plan earnings. Participant accounts are charged with an allocation of investment and administrative expenses that are paid by the Plan. Allocations are based on the participant earnings, account balances, or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Contributions made on behalf of the participants are invested in various funds according to participant elections. Participants may change investment elections at any time via telephone or internet access with the Custodian.

Vesting: Participants are immediately vested in their contributions and Safe Harbor Contributions plus actual earnings thereon. Vesting in Profit Sharing Contributions, plus earnings thereon, is based on years of service in accordance with the following schedule:

Less than 2	0%
2	20%
3	40%
4	60%
5	80%
6 or more	100%

However, Profit Sharing Contributions and related earnings also become fully vested if the participant becomes permanently disabled or deceased.

Forfeited Accounts: If a participant's employment is terminated before full vesting of Profit Sharing Contributions and related earnings are attained, the amount not vested may be allocated first to pay Plan expenses. Any forfeitures remaining after paying Plan expenses are used to reduce employer contributions. During the year ended December 31, 2024, forfeitures of \$36,534 were used to reduce employer contributions. At December 31, 2024 and 2023, there were forfeited non-vested amounts of \$53,920 and \$36,534, respectively, held by the Plan.

Payment of Benefits: Upon termination of service due to death, disability, or retirement, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account. These payments may be paid in a lump sum payment or paid in installments over time.

Any withdrawal made by a participant prior to attaining age 59½ that is not rolled over into another retirement account for reasons other than death or disability is subject to a 10% federal excise tax.

Hardship Withdrawals: A withdrawal from a participant's account may be permitted if the participant has a financial hardship for certain specific reasons as defined in the Plan document.

Notes Receivable from Participants: Participants may borrow 50% of their vested account balance up to a maximum of \$50,000. The loans are secured by the balance in the participant's account and bear interest at rates based on prevailing rates charged by lenders in similar circumstances. Loans must be repaid within five years, unless the loan is used to pay for the purchase of a personal residence, in which case the loan repayment period may not extend beyond 10 years from the date of the loan. Participants may only have one loan outstanding at a time.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting: The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates: The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could materially differ from those estimates.

Investment Valuation and Income Recognition: Investments are stated at fair value (see Note 4). Net appreciation or depreciation for the period is reflected in the accompanying statement of changes in net assets available for benefits. Purchases and sales of securities are reflected on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the plan's gains and losses on investments bought and sold as well as held during the year.

The Fidelity Managed Income Portfolio ("Managed Income Portfolio"), which is an investment fund held in a common and collective trust, consists primarily of investments in fixed-income securities and bond funds.

Payment of Benefits: Benefits are recorded when paid. Participants terminating employment are entitled to a distribution of their vested portion of accrued benefits.

Notes Receivable from Participants: Promissory notes from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Administrative Expenses: Investment-related expenses are included in net appreciation or depreciation in fair value of investments. Certain transactional expenses, including loan maintenance fees, loan set up fees, and investment advisory fees are charged directly to the account balances of the applicable participants. Other operating expenses, such as recordkeeping fees, audit and consulting fees, incurred in the administration of the Plan are paid by the Plan and allocated pro rata to the participants based on participant balances. A portion of the operating expenses and management fees is returned to the Plan on revenue sharing arrangements. The revenue sharing amounts received by the Plan during 2024 amounted to \$46,295 and are recorded as an offset to administrative expenses in the statement of changes in net assets available for benefits.

The Company may also directly pay certain administrative expenses on behalf of the Plan, and such expenses are excluded from the accompanying financial statements. Administrative expenses incurred by the Plan, net of revenue sharing amounts, totaled \$47,256 for the year ended December 31, 2024.

Risks and Uncertainties: The Plan provides for investments in any combination of mutual funds and a common and collective trust (see Note 4). These investments are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of those investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events: Plan management has evaluated subsequent events for recognition and disclosure through September 24, 2025, which is the date the financial statements were available to be issued.

**NOTE 3 – CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the trustee of the plan).

**NOTE 4 – FAIR VALUE MEASUREMENTS**

Accounting guidance defines fair value as the exchange price that would be received for an asset or paid to transfer a liability (an exit price) in the principal, or in the absence of a principal market, the most advantageous market for the asset or liability, in an orderly transaction between market participants on the measurement date. A fair value hierarchy was established that requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. The guidance describes three levels of inputs that may be used to measure fair value:

*Level 1*: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

*Level 2*: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

*Level 3*: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

The following is a description of the valuation methodologies used for the investments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy.

Investments in Registered Investment Companies (Mutual Funds): The fair value of the Plan's investments in registered investment companies is based upon quoted prices in active markets, which represent the net asset value of the shares held and are classified as Level 1 investments.

Investment in Common and Collective Trust: The fair value of participation units held in a collective trust is based on the net asset value per unit as reported by the fund manager. The collective trust provides for daily redemptions by the Plan at reported net asset value per share, with no advance notice requirement.

**NOTE 5 – TAX STATUS**

The Plan has adopted a prototype plan of Fidelity (the “Prototype Plan”) conforming the design and operations of the Plan to the Prototype Plan. Fidelity received a favorable determination letter from the Internal Revenue Service (“IRS”) for the Prototype Plan on June 30, 2020 indicating that the Plan is designed in accordance with the applicable sections of the IRC. The plan administrator believes that the Plan is designed and is currently being operated in compliance with the Prototype Plan and with the applicable requirements of the IRC. Accordingly, no provision for income taxes is reflected in the accompanying financial statements. Continued qualification is dependent on the Plan’s future operations.

**NOTE 5 – TAX STATUS** (Continued)

In accordance with U.S. GAAP, the plan administrator is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain income tax position that is more-likely-than not to be sustained upon audit by the IRS. An uncertain income tax position will not be recognized if it has less than a 50% likelihood of being sustained. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require the recognition of a liability (or asset) or disclosure in the financial statements. The plan administrator does not foresee material changes to the gross uncertain income tax position liability (or asset) of the Plan within the next twelve months.

The Plan is subject to routine audits by the IRS; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for tax years prior to 2021.

**NOTE 6 – RIGHTS UPON PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their account balances.

**NOTE 7 – PARTIES-IN-INTEREST TRANSACTIONS**

Plan investments are in investments managed by the Trustee. In addition, the Plan has loans with its participants. Both the Trustee and participants are considered parties-in-interest under ERISA. The Plan receives revenue credits from the Trustee, which result from revenue-sharing arrangements for certain of the Plan's investments. The revenue sharing amounts received are recorded as an offset to administrative expenses in the statement of changes in net assets available for benefits. The Plan received \$46,295 in revenue sharing payments from the Trustee for the year ended December 31, 2024. During the year ended December 31, 2024, investment advisory fees paid to Strategic Advisors, Inc., an affiliate of the Trustee, were \$14,482, and fees paid to Fidelity Investments Institutional Operations Company, Inc., an affiliate of the Trustee, were \$6,474, for services provided. All of these transactions are considered exempt party-in-interest transactions under ERISA.
