NOTES TO FINANCIAL STATEMENTS

NOTE A - DESCRIPTION OF PLAN

The following description of the Plan only provides general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

Management has evaluated subsequent events through August 21, 2025, the date the financial statements were available to be issued and, has no material subsequent events to report.

General

The Plan is a defined contribution plan covering substantially all eligible employees of Triumph Higher Education Group, LLC (Company, Employer or Sponsor). The Plan is qualified under the Internal Revenue Code (IRC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). For salary deferrals and employer matching contributions, employees must be 21 years of age.

Contributions

Participants may make pretax and Roth contributions to the Plan up to the maximum percentage allowable by the IRC. Plan limits are indexed to follow changes in the federal limits. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Roth deferrals are also permitted by the Plan. If a participant has not completed a salary deferral agreement or opted out at the time, they have reached the eligibility requirements, the Plan Sponsor will automatically withhold 3% of a participant's compensation and contribute that amount as a salary deferral. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a guaranteed interest account as investment options for participants.

Effective January 1, 2024, the employer will contribute 100% of an eligible participant's elective deferral contribution up to 3%, plus 50% of the amount that exceeds 3%, not to exceed 5% of the participant's compensation.

The Employer may also elect to make a profit sharing contribution. Profit sharing contributions, if any, are determined annually by the Employer. The employee's share of the profit sharing contribution is based on the proportion of the employee's compensation to the total compensation for all eligible participants. During 2024, the Employer did not declare a profit sharing contribution.

Participant Accounts

Each participant account is credited with the participant's contribution and an allocation of (a) the Employer's matching contribution, if any, and (b) Plan earnings (losses), based on investment options selected by participants, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTES TO FINANCIAL STATEMENTS

NOTE A - DESCRIPTION OF PLAN (CONTINUED)

Vesting

Participants are immediately vested in their contributions and associated earnings thereon. Vesting in the Employer contribution portion of their account balance is based on years of service completed. Participants become 100% vested in employer contributions after three years of service, earned in successive annual increments of 33%, 33% and 34%.

Notes Receivable from Participants

The Plan allows for participant loans in amounts not less than \$1,000 up to a maximum of \$50,000, or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate to similar commercial loans by persons or institutions in the business of lending money in the same geographic area as the Employer. The loans must be repaid in level payments through payroll deductions over not to exceed a five-year period, or 10 years for loans used to purchase a principal residence. Participant loans outstanding as of December 31, 2024, have interest rates of 3.25% to 8.5%.

Payment of Benefits

Participants receive benefit payments based on the vested portion of their account balance upon death, retirement or attainment of age 59½, disability, or termination of employment. Benefit payments in amounts defined by law as "required minimum distributions" must commence by age 73, unless the participant is an active employee. All benefits other than "required minimum distributions" will be paid in the form of a lump sum or in installment payments over a period not to exceed the participant's or beneficiary's life expectancy.

Participants may request a distribution of a portion of their contributions in the event of a documented financial hardship certified by the participant. The distribution is limited to the amount of the hardship, which must arise from certain events prescribed by law.

Forfeited Accounts

Forfeited accounts will first be used to pay Plan Administrative expenses. Any excess remaining will be used to reduce any Employer contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$33,710 and \$15,559, respectively. During the year ended December 31, 2024, \$32,429 of forfeitures were used to pay Plan Administrative expenses and \$15,559 were used to reduce Employer contributions.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Investments held by a defined-contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan's guaranteed interest account is deemed to be fully benefit responsive at December 31, 2024, and 2023.

Use of Estimates in the Preparation of Financial Statements

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Valuation of Investments and Investment Income

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Gains and losses are determined on the basis of specific identified cost. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Participant loans are presented at their unpaid principal balance plus accrued interest. Interest income is recognized monthly on the accrual basis. Loans are deemed in default if any scheduled loan repayment is not made by the end of the calendar quarter following the quarter in which the missed payment was due.

Payment of Benefits

Benefits are recorded when paid.

Operating Expenses

The Plan custodian and third-party administrator charge various administrative fees relating to recordkeeping services performed under contract to the Plan. Under no circumstances will compensation be paid by the Plan to the Employer for services rendered as administrator. Certain expenses of maintaining the Plan may be paid by the Employer. The Employer paid approximately \$29,000 in operating expenses on behalf of the Plan during the year ended December 31, 2024.

NOTE C - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC Topic 820 are described as follows:

- Level 1 -** Inputs in the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.
- Level 2 -** Inputs to the valuation methodology include:
Quoted prices for similar assets in active markets.
Quoted prices for identical or similar assets in inactive markets.
Inputs other than quoted prices that are observable for the asset.
Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- Level 3 -** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds: Valued at the net asset value (NAV) of shares held by the Plan at year end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE D - INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan has entered into a benefit-responsive guaranteed interest account with Standard Insurance Company (Standard) through a group annuity contract. Standard maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract is included in the financial statements at contract value as reported to the Plan by Standard. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The guaranteed interest account issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Standard considers this investment option to be fully benefit-responsive notwithstanding the liquidation value events (see below) under the contract that limit the ability of the Plan to transact at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. As of December 31, 2024 and 2023, the crediting rates were 3.04% and 2.78%, respectively. Such interest rates are reviewed on an annual basis for resetting.

Certain events may limit the ability of the Plan to transact at contract value. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan withdrawal or transfer rules. Upon occurrence of any of these events, a market value adjustment or other withdrawal restrictions may apply. Consult the Plan's group annuity contract for further information. The Plan administrator believes that it is not probable that events may occur that will limit the ability of the Plan to transact at contract value with the issuer.

NOTE E - INFORMATION CERTIFIED BY CUSTODIANS (UNAUDITED)

Management has elected the method of annual reporting permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Charles Schwab Trust Bank and Standard Insurance Company, qualified institutions, have certified that the following information included in the accompanying financial statements and the ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Interest (including interest on notes receivable from participants), dividends and net appreciation (depreciation) of investments as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment information included in the schedule of assets (held at end of the year) as of December 31, 2024, as shown on the ERISA-required supplemental schedule.

At the request of management, the Plan's independent auditor did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statement and ERISA-required supplemental schedule.

NOTES TO FINANCIAL STATEMENTS

NOTE F - RISK AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE G - PLAN TERMINATION

Although it has not expressed any intention to do so, the Employer may discontinue its contributions to the Plan at any time, and terminate the Plan subject to regulations under ERISA. In the event of a Plan termination, participants will become 100% vested in their entire account balance.

NOTE H - COMMITMENT

The Plan's investments include \$1,927,569 allocated to participants who have withdrawn from the Plan as of December 31, 2024 but, have not yet been paid. These participants may elect to withdraw their vested balances at any time.

NOTE I - TAX STATUS

The Internal Revenue Service (IRS) has determined and informed the Plan by letter dated June 30, 2020, that the prototype plan and related trust are designed in accordance with applicable sections of the IRC. The Plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE J - PARTY-IN-INTEREST TRANSACTIONS

The Plan's investment in the Standard Insurance Company Guaranteed Interest Account is managed by Standard Insurance Company. Standard Insurance Company is the record keeper of the Plan and, therefore, this investment qualifies as a party-in-interest transaction.
