1. Description of Plan

The following description of Hubbardton Forge Savings and Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by Hubbardton Forge, LLC (the Company). Employees of the Company who have completed two months of service are eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Standard Retirement Services, Inc. (the Standard) is the recordkeeper of the Plan and Reliance Trust Company (Reliance) is the custodian.

Contributions

Each year, participants may contribute up to 100% of eligible compensation, as defined in the plan document, to the Plan, subject to the limitations established by the Internal Revenue Code (the Code). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The Company contributes a discretionary matching contribution and a discretionary profit sharing contribution. The Company contributions are invested as directed by the participant.

Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's matching contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of Plan losses and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings on the contributions. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant's profit sharing contribution is 100% vested immediately. A participant's matching contribution is 100% vested after 3 years of continuous service.

Notes Receivable from Participants

Participants may borrow from their accounts up to a maximum equal to the lesser of \$50,000 reduced by the excess of the participant's highest outstanding balance of all notes receivable from participants during the prior year or 50% of their account balance. Participants may not take out a note receivable that is \$1,000 or less. Notes receivable from participants terms range from 1 to 5 years but may be longer if used for the purchase of a primary residence. Notes receivable from participants are secured by the balance of the participant's account and bear interest at a rate commensurate with local prevailing rates, as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or a partial withdrawal at the discretion of the participant for any amount of their balance. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

A participant who terminates employment with a vested account balance of \$5,000 or less but greater than \$1,000 and does not elect to receive a distribution will receive an automatic rollover to an individual retirement account.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with U.S. generally accepted accounting principles (U.S. GAAP).

Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodian, and insurance company. See Note 3 for discussion of the fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are recorded as distributions based on the terms of the Plan agreement.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain administrative expenses are paid by the Company on behalf of the Plan; however, certain expenses including investment advisory and recordkeeper fees are paid by the participants.

Subsequent Events

The Plan has evaluated subsequent events through September 19, 2025, the date the financial statements were available to be issued. Management has not evaluated subsequent events after that date for inclusion in the financial statements.

3. Fair Value Measurement

Financial Accounting Standards Board's Accounting Standards Codification Topic 820 (Topic 820), *Fair Value Measurement*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under Topic 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Mutual funds were valued at the published amounts of shares held by the Plan at year end. The following tables set forth by level, within the fair value hierarchy, the Plan's assets at fair value as of December 31, 2024 and 2023.

4. Fixed Income Account

At December 31, 2024 and 2023, \$2,467,493 and \$2,038,693, respectively, of Plan assets were invested in a deposit administration contract held by the Standard, which was determined to be fully benefit-responsive. Contract value, as reported to the Plan by the Standard, represents contributions made under the contract plus earnings, less participant withdrawals and administrative expenses. Participants were able to direct the withdrawal or transfer of all or a portion of their investments at contract value. There were no reserves against contract value for credit risk of the contract issuer or otherwise. The average yield and crediting interest rate earned was 2.09% and 1.83% for the years ended December 31, 2024 and 2023, respectively. Nominal interest rates are adjusted quarterly. The plan administrator does not believe there were any events that would limit the Plan's ability to transact at contract value at December 31, 2024.

5. Information Prepared and Certified by Custodian

The investments, notes receivable from participants, investment transactions, net appreciation in fair value of investments, and interest and dividends were certified by Reliance as complete and accurate. This information is included in the following:

6. Parties-in-Interest

Certain Plan investments are managed by the Standard, the recordkeeper as defined by the Plan, and, therefore, these transactions qualify as party-in-interest transactions. The Plan incurred administrative expenses from the Standard amounting to \$39,227 during the year ended December 31, 2024, which qualify as party-in-interest transactions as they are related to recordkeeper fees incurred by the Plan. The Company provides certain accounting and administrative services to the Plan for which no fees are charged. The employees that provide these services are also participants of the Plan.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer matching contributions.

8. Tax Status

The Company has adopted the Standard Volume Submitter 401(k) Profit Sharing Plan, which received a favorable opinion letter dated June 30, 2020, stating that the Plan, as then designed, was in compliance with the applicable requirements of the Code. The Plan has been amended since receiving the advisory letter. However, the plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Code.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
