Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Kier & Wright Civil Engineers & Surveyors, Inc. Salary Deferral Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024, and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). 1. DESCRIPTION OF PLAN AND SUMMARY OF ACCOUNTING POLICIES

The following description of the Kier & Wright Civil Engineers & Surveyors, Inc. Salary Deferral Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan covering all eligible employees of Kier & Wright Civil Engineers & Surveyors, Inc. (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and Section 401(a) of the Internal Revenue Code ("IRC"). The Company has contracted Fidelity Management Trust Company to act as the trustee, custodian and serve as third-party administrator to process and maintain the records of participant data. The Plan was adopted effective January 1, 1994, to provide benefits to eligible employees as defined in the Plan document. The following employees are not eligible to participate in the Plan: Collective Bargaining Employees and Non-Resident Aliens. All other employees of the Company, who have attained the age of eighteen and completed one month of service, are eligible to participate in the Plan. Participants will be eligible to enter the Plan on the first day of each month following satisfaction of the eligibility requirements. The Plan was amended and restated on April 20, 2022 to conform to certain tax law changes.

Basis of accounting – The Plan's financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of estimates - The preparation of financial statements in conformity with U.S. GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from these estimates.

Administration – The Company is the Plan Administrator and is responsible for the operation and administration of the Plan. Fidelity Management Trust Company serves as the Trustee and is responsible for holding the Plan's assets. The Company has contracted with Fidelity Workplace Services LLC ("Fidelity") to act as custodian and provide recordkeeping and compliance services.

Plan termination and modification - The Company intends to continue the Plan indefinitely for the benefit of its employees. However, it reserves the right to terminate or modify the Plan at any time by resolution of its Board of Directors and subject to the provisions of ERISA. In the event the Plan is terminated in the future, participants would become fully vested in their accounts.

Participant contributions - Each year, participants may contribute a portion of pre-tax annual compensation, as defined in the Plan, up to a maximum allowed by law. Participants who have attained the age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans.

Employer contributions - The Company may elect to make discretionary profit-sharing contributions to the Plan. Participants must be over the age of eighteen, complete a minimum of 1,000 hours of service during the Plan year and be employed on the last day of the Plan year to share in Company profit sharing contributions.

Profit-sharing contributions, if any, are allocated to participants based on their eligible compensation. The Company made discretionary profit-sharing contributions of \$451,937 for the year ended December 31, 2024.

The Company may also make an employer safe harbor contribution that is calculated at 3% of eligible compensation. In order to receive an employer safe harbor contribution, a participant must be over the age of eighteen and have completed 1 hour of service during the Plan year. For the Plan year ended December 31, 2024, the Company made an employer safe harbor contribution of \$679,430.

Participant accounts - A separate account is maintained for each participant. Each participant's account is credited with the participant's voluntary contributions, employer contributions and an allocation of Plan earnings, less withdrawals, distributions and administrative expenses, if any. Participants direct the investment of their contributions into the various investment options offered by the Plan. Investment income allocations are made daily based on participant account balances. The benefit to which a participant is entitled is limited to the benefit that may be provided from the participant's vested account balance.

Investment income - Realized gains or losses on investment transactions are recorded as the difference between the proceeds received and the fair value of the investment at the beginning of the Plan year, or cost if acquired during the Plan year. In accordance with the Plan's policy of stating investments at fair value, net unrealized appreciation or depreciation consists of both realized and unrealized gains and losses and is included in the statement of changes in net assets in the period in which the market change occurs. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date.

Forfeited accounts - Forfeited non-vested accounts may be used to reduce future employer contributions or to pay expenses of the Plan. At December 31, 2024 and 2023, the Plan had unallocated forfeitures of \$88,989 and \$571,528, respectively. For the year ended December 31, 2024, forfeitures totaling \$599,269 and \$23,052 were used to reduce employer profit sharing contributions and pay expenses, respectively.

Vesting – Participants are immediately vested in their voluntary contributions and employer safe harbor contributions plus actual earnings thereon. Vesting with respect to employer profit-sharing contributions, if any, plus actual earnings thereon, is based on years of service. Participants do not become vested in employer profit-sharing contributions until they have completed two years of service and contributed at least 1,000 hours of service during each of the two Plan year and become fully vested in employer profit-sharing contributions ratably over a six-year period. Participants become fully vested in all accounts upon retirement, death, disability or Plan termination.

Notes receivable from participants - The Plan provides a provision that allows a participant to borrow up to the lesser of \$50,000 or 50% of their vested account balance. Such loans shall bear interest at fixed rates equal to the published prime rate, plus two percent. The term of the loans cannot exceed five years, except if the loan proceeds are used to finance the purchase of a primary residence, in which case the loan term may not exceed thirty years. The loans are secured by the participant's vested account balance. Principal and interest are paid ratably through payroll deductions. Notes receivable from participants are stated at their unpaid principal balances plus any accrued but unpaid interest. Any participant defaults are deemed taxable distributions to the participant.

Payment of benefits – Benefits are recorded when paid. Participant account balances can be distributed prior to termination or retirement age for hardship claim, death or disability as defined in the Plan agreement. On termination of service due to death, disability or retirement, a participant will receive an amount equal to the value of the vested interest in their account. For termination of service due to other reasons, a participant may also receive the value of the vested interest in their account as a lump-sum distribution. On termination of service for account balances less than \$1,000, a lump-sum distribution may be made at the employer's discretion. For account balances greater than \$1,000, written consent by the employee is required before a distribution can be made.

The normal retirement age under the Plan is age 65. Participants who have reached age 59 ½ may take an in-service distribution subject to the Plan's provisions.

Administrative expenses – All reasonable expenses of administering the Plan may be paid out of the Plan's assets or directly by the Company. The majority of Plan expenses were paid by the Plan for the year ended December 31, 2024.

Subsequent events - The Plan's management evaluates events or transactions occurring after the statement of net assets available for plan benefits date but before the financial statements are available to be issued for potential recognition or disclosure. The financial statements include all subsequent events considered necessary for a fair presentation. Events or transactions occurring subsequent to year end through the date the financial statements were available to be issued, September 17, 2025, have been evaluated in the preparation of the accompanying financial statements.

2. FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurement). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used should maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual funds: Valued at fair market value as of the last day of the Plan year as quoted by Fidelity Management Trust Company based on reported net asset values obtained on a daily basis from a national exchange.

Money market funds: The fair value of money market funds is based on the total value of all the securities held using the amortized cost method. Generally, amortized cost approximates the current fair value. The fund seeks to maintain a net asset value of \$1.00.

Self-directed brokerage account: Self-directed brokerage accounts consist of common stocks and interest-bearing cash, which are valued at the closing price reported in the active market in which the securities are traded.

The Plan's method of valuing investments may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan's management believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

4. INCOME TAX STATUS

On June 30, 2020, the Internal Revenue Service stated that the prototype adopted by the Plan, as then designed, qualifies under the Internal Revenue Code 401(a). The Plan has not received a determination letter specific to the Plan itself; however, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and believes that the Plan was qualified as of December 31, 2024, and 2023. Therefore, no provision for income taxes has been included in the Plan's financial statements.

5. RISKS AND UNCERTAINTIES

The Plan provides for various investment options in any combination of investment securities offered by the Plan. Investment securities are exposed to various risks, such as interest rate, market fluctuations and credit risks. Due to the risk associated with certain investment securities, it is at least reasonably possible that changes in market values, interest rates or other factors in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

Financial instruments, which potentially subject the Plan to concentrations of credit risk, consist of mutual funds, money market funds and a self-directed brokerage account offered by the Plan. As the portfolio is well diversified and issuers of the underlying securities are dispersed throughout many industries and geographies, the concentrations of credit risk are limited.

6. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Fidelity Management Trust Company, the Plan's custodian. Any purchases and sales of these investments are performed in the open market at fair value. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.
