NOTES TO FINANCIAL STATEMENTS

1. DESCRIPTION OF THE PLAN AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Gecko Robotics, Inc. 401(k) Plan (the "Plan") was established effective January 1, 2019 and most recently restated effective January 1, 2024. The Plan and the related Trust agreement are intended to provide the opportunity for retirement savings for employees of Gecko Robotics, Inc. (the "Sponsor").

The following description of the Plan provides only general information. Participants should refer to the plan document, which is amended from time to time to reflect changes in laws applicable to employee benefit plans, for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan qualified under Section 401(k) of the Internal Revenue Code (IRC) and covers substantially all employees of the Sponsor who have completed three months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Use of Estimates - The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the dates of the financial statements and changes in assets and liabilities during the reporting periods. Actual results could differ from these estimates.

Investment Valuation and Income Recognition - Investments are carried at their fair value. The Plan presents net appreciation or depreciation in the fair value of its investments, which consists of the realized gains or losses and the unrealized appreciation or depreciation on these investments, in the statements of changes in net assets available for benefits. The unrealized appreciation or depreciation of investments is determined by the change in current market value from the beginning of the period to the end of the period (if held for the entire period), or from the date of purchase to the end of the period. Realized gains and losses on securities sold or redeemed are determined, on the basis of specific identification, from the date of purchase to the date of sale. Purchases and sales of securities are recorded on a trade-date basis. Dividends and interest are recorded as earned. Investment management fees are deducted from income earned and are reflected as a component of net appreciation or depreciation in the fair value of investments.

Contributions - Participants may elect to make pre-tax or after-tax (Roth) contributions to the Plan up to 100% of compensation, subject to IRS limitations. Employee rollover contributions represent contributions from other plans and are not subject to the IRC contribution limits.

The Plan provides for an employer matching contribution, which was 100% on the first 3% of compensation deferred for the years ended December 31, 2024 and 2023.

Employee deferrals and employer matching contributions to the Plan are recorded in the period during which the Sponsor makes payroll deductions from the participant's earnings.

Participant Accounts - Each participant's account is credited with the employee and applicable employer contributions and an allocation of the Plan's earnings. Earnings are allocated based on a participant's account balance as a percentage of the total account balances for the applicable investment option. Participants are not able to borrow from their accounts.

Investment Options - Upon enrollment in the Plan, a participant may direct their contributions, employer contributions, and any related earnings among various investment options, and may change their investment options at any time.

Vesting - Participants are immediately vested in their voluntary contributions plus actual earnings thereon. The employer contributions and earnings thereon vest according to the following schedule:

<u>Years of Service</u>	<u>Vesting Percentage</u>
Less than 1	0%
1 but less than 2	25%
2 but less than 3	50%
3 but less than 4	75%
4 and over	100%

Effective January 1, 2024, the Plan was amended to change the vesting computation method from an hours of service basis to an elapsed time basis. The vesting table and percentages presented above remained unchanged as a result of the amendment.

Benefits - On termination of service due to death, disability, retirement, or other reasons and subject to certain restrictions, a participant or designated beneficiary may elect to receive either a lump-sum amount equal to the value of his or her account, a rollover to another qualified plan or individual retirement account, or partial withdrawals, subject to applicable tax withholding requirements. All distributions are subject to the provisions of the Plan.

Forfeitures - Forfeitures represent the portion of non-vested account balances remaining in the Plan for all terminated employees. Forfeiture balances may be utilized to pay administrative expenses or reduce employer contributions and are reflected on the last day of the plan year in which the plan administrator distributes the participant's entire vested interest, as defined in the plan document. As of December 31, 2024 and

2023, the available balance in the forfeitures account was \$5,446 and \$61,483, respectively. During the years ended December 31, 2024 and 2023, there were forfeitures of \$87,056 and \$34,877, respectively.

Administrative Expenses - Administrative expenses of the Plan are paid by the Plan or by the Sponsor, as provided by the plan document.

Fair Value Measurements - U.S. GAAP establishes a framework for measuring fair value of financial assets. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs are not quoted prices in active markets but they are observable either directly or indirectly.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies at December 31, 2024 and 2023.

- *Mutual Funds*: Valued at the closing price reported on the active market on which the individual funds are traded (Level 1).
- *Fixed Annuity*: The fixed annuity contract is a public investment vehicle that is not fully benefit-responsive. The fund is valued using the value provided by the custodian on the last day of the Plan's year end, which is based on the valuation method disclosed in the annuity contract, as calculated by the annuity provider (Level 2).

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the plan administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting dates.

Risks and Uncertainties - The Plan assets are comprised of various investment securities which are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events - Management has evaluated subsequent events through September 19, 2025, the date which the financial statements were available to be issued.

2. CERTIFIED FINANCIAL INFORMATION

Empower Trust Company, LLC (Empower), the custodian, has certified that the following data included in the accompanying financial statements is complete and accurate:

- Investments, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net investment income, as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- The schedule of assets held for investment purposes as of December 31, 2024, as shown on the accompanying schedule.

3. PLAN TERMINATION

Although it has not expressed any intention to do so, the employer has the right to terminate the Plan subject to the provisions of ERISA. In the event of termination, all participants shall become 100% vested in their accounts. The assets of the Plan will be distributed by the custodian in accordance with the trust agreement in a uniform and nondiscriminatory manner.

4. INCOME TAX STATUS

The Plan, which is in the form of a non-standardized, pre-approved plan, obtained its latest opinion letter on July 13, 2021 in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC; therefore, no provision for income taxes has been included in the Plan's financial statements.

Management believes there is no liability related to uncertain tax positions at December 31, 2024 or 2023. The Plan is no longer subject to tax examinations for tax years before December 31, 2021.

5. RELATED PARTIES AND PARTIES-IN-INTEREST

Empower serves as the custodian of the Plan and provides access to certain investment options and, accordingly, is considered to be a party-in-interest.

Neither the Sponsor nor employees involved in the administration of the Plan receive compensation from the Plan.
