Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

NOTE 1 - Description of Plan

The following description of the PCF 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan covering substantially all employees of PCF Restaurant Group LLC (the "Company"), as described in the Plan agreement, who meet the eligibility requirements of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Administrative Committee is responsible for oversight of the Plan including the appropriateness of the Plan's investment offerings and monitoring of the investment performance.

Plan Amendment - Effective January 1, 2024, the Plan was amended and restated to require at least 500 hours of service during the year and be employed by the Company on the last day of the year to be eligible for the employer non-elective contributions and to change the allocation of the non-elective contributions from based on compensation to a manner to be determined by the Company.

Contributions - There are two types of salary deferrals: Pre-Tax 401(k) deferrals and Roth 401(k) deferrals. Each year, participants may contribute up to 100 percent of their pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled into the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3 percent of eligible compensation and will increase 1 percent annually up to a maximum of 10 percent until changed by the participant and their contributions are invested in a designated target retirement fund until changed by the participant. The Plan currently offers twenty-two (22) mutual funds as investment options for participants. Participants may change their investment options at any time.

The Company may elect to make a discretionary matching employer contribution to the Plan based on a discretionary amount as determined by the Company in its sole discretion. For the year ended December 31, 2024, the Company did not make a matching contribution.

The Company may also elect to make discretionary non-elective contributions to the Plan which will be allocated to each eligible employee in a matter determined by the employer. For the year ended December 31, 2024, the Company made a discretionary non-elective contribution of \$25,000. The discretionary non-elective contributions are participant directed as above. Contributions are subject to certain IRS limitations.

NOTE 1 - Description of Plan (continued)

Participant Accounts - Each participant's account is credited with the participant's contributions and Company discretionary matching contributions, as well as allocations of the Company's discretionary non-elective contribution and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are vested immediately in their contributions, including rollovers, plus actual earnings thereon. Vesting in the Company's contributions (discretionary matching and discretionary non-elective) portion of their account are based on years of continuous service. A participant is 100 percent vested after four (4) years of credited service. A participant is 100 percent vested upon death, disability, or normal retirement.

Notes Receivable from Participants - Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of the participant's vested account balance. Participants may have one (1) note receivable outstanding at a time. The notes are secured by the balance in the participant's account. The note interest rate, determined the month the note is taken, is set at the Wall Street Journal Prime Rate, as defined in the Plan agreement. Principal and interest are paid ratably through payroll deductions. There were no notes receivable from participants at December 31, 2024.

Payment of Benefits - On termination of service due to death, disability or retirement, or upon termination of employment, a participant or their beneficiary (ies) may elect to receive a lump-sum, direct rollover, or installments, if the participant's vested balance exceeds \$5,000. An account balance less than \$5,000 will receive an automatic lump-sum payment regardless of whether the participant or their beneficiary (ies) elects to receive payment.

Forfeited Accounts - At December 31, 2024 and 2023, there were \$154 and \$0, respectively in forfeited non-vested accounts. Forfeitures may be used for the payment of administrative expenses and/or to reduce the employer contributions. During 2024, no forfeitures were used to pay for plan expenses.

NOTE 2 - Summary of Significant Accounting Policies

Basis of Accounting - The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

NOTE 2 - Summary of Significant Accounting Policies (continued)

Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Administrative Committee determines the Plan's valuation policies utilizing information provided by the investment adviser and trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions - Contributions from Plan participants and the discretionary employer matching contributions are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan is reduced and a benefit payment is recorded. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Excess Participants' Contributions - Corrective distributions are made to certain participants to return the excess deferral contributions as required by the IRS to satisfy the nondiscrimination provisions of the Plan. A liability for excess contributions of \$18,474 was recorded on the Plan's financial statements at December 31, 2023. The Plan distributed the 2023 excess contributions to the applicable participants during 2024.

Payments of Benefits - Benefits are recorded when paid.

Administrative Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and certain participant distributions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events - The Plan has evaluated subsequent events through September 8, 2025, the date the financial statements were available to be issued. Effective January 1, 2025, the Plan was amended and restated to exclude bonuses from eligible compensation for deferrals. Except as noted above, no material events or transactions have occurred during this period which would render these financial statements to be misleading.

NOTE 3 - Certification of Investment Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Hand Benefits & Trust Company, the trustee of the Plan.

NOTE 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/Collective Trust Fund: Valued at the net asset value (NAV) of units of a common/collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sales) may occur daily. Were the Plan to initiate a full redemption of the common/collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure the securities liquidations will be carried out in an orderly business manner.

- (1) In accordance with the FASB Accounting Standards Codification Subtopic 820-10, certain investments that were measured at net asset value per share (or its equivalent) as a practical expedient have not been classified in the fair value of hierarchy. The fair value amount presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statements of net assets available for benefits.

NOTE 5 - Related Party Transactions and Party-in-Interest Transactions

Plan investments are shares of mutual funds managed by Hand Benefits & Trust Company ("HB&T"), the trustee of the Plan. HB&T is the trustee as defined by the Plan, and, therefore, these transactions qualify as party in interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation of the investment, as they are paid through revenue sharing, rather than a direct payment. Fees paid by the Plan for administrative expenses amounted to \$18,953 for the year ended December 31, 2024, which were not covered by revenue sharing. The Plan sponsor pays directly any other fees related to the Plan's operations.

NOTE 6 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

NOTE 7 - Tax Status

The underlying non-standardized pre-approved profit sharing plan has received an opinion letter dated June 30, 2020 from the Internal Revenue Service (IRS) stating that the form of the Plan is acceptable for use by employers for the benefit of their employees under Internal Revenue Code (IRC) Section 401. The Plan Sponsor has adopted this Plan and may rely on the current qualifications of the non-standardized pre-approved profit sharing plan opinion letter. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualifications. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is designed, and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 - Prohibited Transactions

The Plan Sponsor did not remit certain participant deferrals totaling \$5,324 to the Plan within the required timeframe as defined by the DOL during the year ended December 31, 2024. The untimely remittances constitute a prohibited transaction under ERISA. The Company will compute lost earnings on the late remittances identified above and corrected the lost earnings in the 2025 Plan year.

NOTE 9 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits. The current economic environment has increased the degree of uncertainty.
