Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirement of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audit in accordance with auditing standards generally accepted in the United States of America (GAAS). The information included in the supplemental schedules, other than that agreed to or derived from the

certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1 - DESCRIPTION OF PLAN

The following description of the Tapani Plumbing, Inc. 401(k) Retirement Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions. Tapani Plumbing, Inc. is the Plan's sponsor and manages all activity related to the Plan.

(a) General - The Plan is a defined contribution profit sharing plan and a salary reduction plan established July 1, 1998. The Plan covers all employees who are age 17 or older who have completed at least three consecutive months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

(b) Contributions - Each year, participants may contribute the maximum of pretax and after-tax compensation as defined in the Plan and by the Internal Revenue Service. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company may contribute discretionary matching contributions to all participants making salary deferrals. The matching contribution is invested as directed by the participant. Additional discretionary profit-sharing amounts may be contributed to participants who have met the requirements for participation in the profit-sharing portion of the Plan, have at least 1,000 hours of service during the Plan year, and are employed on the last day of the Plan year. The profit-sharing contribution is invested as directed by the participant. Contributions are subject to certain limitations. The Company made discretionary contributions of \$433,990 and \$424,942 for the years ended December 31, 2024 and 2023, respectively.

The Company also contributes those hourly benefits required on wages that are paid to employees performing work subject to the federal Davis-Bacon Act provisions or similar state provisions (prevailing wage contributions). Contributions under this Plan for the years ended December 31, 2024 and 2023, were \$211,928 and \$204,999, respectively.

(c) Participant Accounts - Each participant's account is credited with the participant's contributions, allocations of the Company's contributions, if any, plus a proportionate interest in the investment earnings or losses of the funds in which the contributions are invested. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on account balances on a quarterly basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(d) Investment options - Participants may direct the investment of all contributions into various investment options offered by the Plan. The Plan allows participants to direct their contributions and account balances among various options offered by Empower Annuity Insurance Company of America.

(e) Vesting - Participants are immediately vested in their salary deferral contributions, rollover contributions, and prevailing wage contributions plus actual earnings or losses thereon. Vesting in the Company's matching and profit-sharing contributions plus earnings thereon is based on years of continuous service. A participant is 100% vested after five years of credited service or upon death, disability, or normal retirement.

(f) Notes Receivable from Participants - Loans are available up to the lesser of \$50,000 or 50% of a participant's vested account balance, with a minimum loan of \$1,000. All loans are subject to approval by the loan administrator. The maximum number of Plan loans available to any participant at any one time is one. Loans will only be granted if a participant incurs a financial hardship or has a specified financial need. Principal and interest is paid ratably through payroll deductions.

(g) Payments of Benefits - Upon termination of service due to death, disability, retirement, or termination due to other reasons, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount, as partial withdrawals, or in installments (only if the vested balance exceeds \$5,000). The participant must consent to the distribution if their vested benefit under the Plan exceeds \$5,000. Vested balances not exceeding \$5,000 may only be distributed in a single lump-sum payment.

(h) Forfeited Accounts - Forfeited account balances may be used to offset required employer contributions or to pay administrative expenses of the Plan. The cumulative of unused offsets by the Company totaled \$0 for each of the years ended December 31, 2024 and 2023. During the years ended December 31, 2024 and 2023, forfeited account balances of \$1,103 and \$5, respectively, were used to reduce employer contributions.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

(a) Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

(b) Use of estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

(c) Investment Valuation and Income Recognition - The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

(d) Notes Receivable from Participants - Notes receivable from participants are measured at their outstanding amortized balances. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make scheduled payments and the Plan administrator deems the participant note receivable to be in default, the participant note receivable balance is reduced and a benefit payment recorded.

(e) Payment of Benefits - Benefits are recorded when paid. There were no amounts allocated to accounts of persons who have elected to withdraw from the Plan, but have not been paid at December 31, 2024 and 2023.

(f) Administrative Expenses - The Plan's expenses are paid either by the Plan or the Company, as provided by the Plan document. Expenses paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment-related expenses are included in net appreciation of fair value of investments.

(g) Date of Management's Review - Subsequent events were evaluated through September 23, 2025, which is the date the financial statements were available to be issued.

NOTE 4 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 5 - INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan maintains a traditional fully benefit-responsive guaranteed investment contract with Empower Annuity Insurance Company of America and Empower Trust Company, LLC (Empower). Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan. The interest crediting rate is based on the earnings of the underlying assets in the entire medium-long term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or portion of their investment at contract value. The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (e.g., divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer.

NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by Empower Annuity Insurance Company of America and Empower Trust Company, LLC. Empower Trust Company, LLC, is the custodian as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in the net appreciation in fair value of the related investment, as they are paid through revenue sharing rather than direct payment. In addition, fees incurred by the Plan for third-party administration and investment advisory services are also paid through revenue sharing rather than direct payment.

An officer of the Plan sponsor is a current participant in the Plan and serves as the administrator of the Plan.

NOTE 7 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine.

NOTE 8 - TAX STATUS

The Plan sponsor adopted a prototype non-standardized profit-sharing plan with a cash or deferral arrangement which received a favorable opinion letter from the Internal Revenue Service dated June 30, 2020. The letter states that the Plan is designed in accordance with the applicable sections of the Internal Revenue Code (IRC) and is, therefore, not subject to tax under present income tax law. The Plan is required to operate in conformity with the IRC to maintain its qualification. Management is not aware of any course of action or series of events that have occurred that might adversely affect the Plan's qualified status.

NOTE 9 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
