NOTE 1. DESCRIPTION OF THE PLAN

The following description of the KaiserAir, Inc. Savings and Profit Sharing Plan (the "Plan"), provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution profit sharing plan covering all eligible employees of KaiserAir, Inc. and its subsidiary, Santa Rosa Jet Center, LLC, collectively the "Company". Employees are eligible to participate in the Plan as of the enrollment date coinciding with or next following the date on which the employee has both attained age 18 and completed one month of eligible service.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and certain provisions of the Internal Revenue Code (the "IRC"). The Investment Committee is responsible for oversight of the Plan which includes, among other matters, determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

The Plan provides for a plan administrator who is responsible for keeping accurate and complete records of the Plan's operations, informing participants of changes or amendments to the Plan, ensuring the Plan conforms to the law and government regulations, and providing participants with any reports and documents required by law.

Contributions

Eligible employees ("participants") may contribute up to 100% of their annual compensation subject to certain limitations as defined by the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch up contributions.

The Plan provides for an Automatic Contribution Arrangement whereby all newly eligible employees will be automatically enrolled at a contribution rate of 2% of eligible compensation. In addition, the automatic deferral amount is subject to an automatic increase of 1% of eligible compensation each Plan Year up to a maximum of 10%. All automatically enrolled employees may subsequently elect to stop or change the automatic contribution percentage and the automatic deferral increase.

The Company makes a safe harbor matching contribution on all employee elective deferral and catch-up contributions. The safe harbor matching contribution is equal to 100% up to 4% of the eligible employees' compensation that is contributed to the plan. The Company made matching contributions for the year ended December 31, 2024 of \$449,934. Forfeitures in the amount of \$12,903 were used to partially fund this matching contribution.

The Company may, at its discretion, make additional contributions, including profit sharing contributions, to the Plan in an amount determined by the Company. The Plan allows all employees who meet the eligibility requirement to receive discretionary profit sharing contributions, if any, regardless of whether they make any voluntary contributions. A discretionary profit sharing contribution for the year ended December 31, 2024 was made in the amount of \$462,131.

NOTE 1. DESCRIPTION OF THE PLAN (CONTINUED)

Rollover contributions

The Plan provides for rollover contributions, which represents contributions by participants from other tax qualified retirement plans. The maximum amount of a participant's rollover contribution is not affected by the limits otherwise applicable to participant contributions.

Participant accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions, and (b) Plan earnings, and charged with an allocation of administrative expenses. The contributions are allocated within each participant account based upon the participant's investment elections. All amounts in participant accounts are participant-directed. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their elective deferral contributions and safe harbor matching contributions. Additional Company contributions are 100% vested after five years of credited service.

Payment of benefits

Benefit payments are payable upon termination of service, death, disability or retirement at age 62. A participant may elect to receive a lump-sum distribution, installments over a period of not more than the assumed life expectancy of the participant or beneficiary, an annuity purchased with the participant's vested account balance, or a rollover distribution. A participant may also elect to receive a pre-retirement distribution if the participant is 100% vested in the amount being distributed and has reached 59½ years of age or incurs a financial hardship as defined by the Plan documents. Benefit payments to the participant generally must begin no later than April 1st following the end of the year after the participant attains age 73.

Terminated participant accounts with balances less than \$7,000 but more than \$1,000 will be automatically distributed to the participant in the form of either a lump-sum payment or rolled over to an Individual Retirement Account per the participant's election. Terminated participant accounts with balances less than \$1,000 will be automatically distributed to the participant in the form of a lump-sum payment.

Hardship withdrawals

Participants may withdraw their elective deferral contributions in the event of hardship as defined by the plan agreement.

Administrative expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to certain administrative services are charged directly to participants' accounts and are included in administrative expenses.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of accounting

The financial statements of the Plan are prepared using the accrual method of accounting which is in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Estimates

The preparation of financial statements in conformity with U.S. GAAP requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value, except for the investment in the Guaranteed Interest Account, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisor and the trustee. See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as those held during the year.

Payment of benefits

Benefit payments are recorded when paid.

Forfeitures

Forfeitures of Company contributions are used to reduce Company contributions or pay plan expenses. For the year ended December 31, 2024, forfeitures of \$12,903 were used to reduce Company contributions. At December 31, 2024, there is a balance of \$26,582 in the forfeitures account.

Subsequent events

The Plan has evaluated all events subsequent to the statement of net assets available for benefits date of December 31, 2024 through August 7, 2025, which represents the date these financial statements are available to be issued. Except for the items described under Note 11, there were no material events or transactions occurring during this subsequent event reporting period which required recognition or further disclosure in these financial statements.

NOTE 3. INFORMATION PREPARED AND CERTIFIED BY CUSTODIANS

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the custodians of the Plan, have certified the completeness and accuracy of:

- Investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments and interest and dividends from investments reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investments reflected on the schedule of assets held at December 31, 2024.

NOTE 4. FAIR VALUE MEASUREMENTS

The fair value measurements standard establishes a framework for measuring fair value. That framework provides a hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under the standard are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted market prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE 4. FAIR VALUE MEASUREMENTS (CONTINUED)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price, as reported by the fund. Funds held by the Plan are open-end funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5. GUARANTEED INTEREST ACCOUNT

The Plan maintains a fully benefit-responsive investment contract, the Guaranteed Interest Account, with Massachusetts Mutual Life Insurance Company ("MassMutual"). MassMutual maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The Plan is credited with an annual interest rate of no less than 1.00%, which is reset every six months. There are no reserves against contract value for credit risk of the contract issuer or otherwise. There are no unfunded commitments as of December 31, 2024 and 2023.

NOTE 5. GUARANTEED INTEREST ACCOUNT (CONTINUED)

The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawals or transfer of all or a portion of their investment at contract value. Contract value was \$1,100,002 and \$1,539,238 as of December 31, 2024 and 2023, respectively.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events may limit the ability of the Plan to transact at contract value with Empower. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (3) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (4) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the contract without the consent of the issuer. Upon termination, a market-value adjustment may apply.

NOTE 6. INCOME TAX STATUS

The Plan document is an Empower Retirement, LLC Defined Contribution Pre-Approved Plan with CODA with an Internal Revenue Service (IRS) opinion letter dated November 14, 2022, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require the Plan's management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon an examination by the tax authorities. The Plan is subject to routine audits by applicable taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7. PLAN TERMINATION

Although it has not expressed intent to do so, the Company has the right under the Plan to discontinue contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their Company contribution accounts.

NOTE 8. RISKS AND UNCERTAINTIES

The Plan invests in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 9. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan's assets are managed and held by an affiliate of Empower Retirement. Empower Retirement executes investment transactions, and therefore, these transactions qualify as party in-interest transactions and are exempt from the prohibited transaction rules of ERISA.

Empower provides certain administrative services to the Plan pursuant to a Recordkeeping Agreement between the Company and Empower. Empower receives revenue from certain of the investment management service providers for services Empower provides to the funds. This revenue is used to offset certain amounts owed to Empower for its administrative services to the Plan. Empower also provides a credit to the Plan to offset some of the administrative expenses paid by the Plan.

NOTE 10. PROHIBITED TRANSACTIONS

The Company failed to timely remit certain employee contributions to the Plan's trustee totaling \$611 for the year ended December 31, 2023 within the period prescribed by Department of Labor regulations. Lost earnings on participant contributions were calculated based on interest rates determined by the Internal Revenue Code and remitted to the Plan's trust in April 2023.
