Scope and nature of the ERISA Section 103(a)(3)(C) audit

We have performed audits of the financial statements of Methodist Health System 403(b) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note D to the financial statements, is complete and accurate.

Opinion

Basis for opinion

NOTE A - DESCRIPTION OF THE PLAN

General

The following is a summary description of the Methodist Health System 403(b) Plan (the "Plan"), formerly Methodist Hospitals of Dallas 403(b) Annuity Plan. Participants should refer to the Plan document for a detailed explanation of the Plan. The Plan was established by Methodist Hospitals of Dallas d/b/a Methodist Health System ("MHS" or the "Plan Administrator") to make available to the eligible employees of MHS the opportunity to make mandatory and voluntary contributions toward the purchase of tax-sheltered annuity contracts under an arrangement allowed under Section 403(b) of the Internal Revenue Code (the "Code"). The Plan is administered and investments are managed by the Retirement Administrative Committee. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

Effective January 1, 2023, the Plan was amended and restated to: (i) clarify that individuals who are employed in the capacity of an independent contractor, leased employee, contract employee or who are determined to be an employee of MHS or a participating employer under the National Labor Relations Board joint employer rule will not be eligible to participate in the Plan; (ii) comply with the Proposed Treasury regulations under the Setting Every Community Up for Retirement Enhancement Act ("SECURE Act") regarding the increased age for minimum required distributions from seventy and one-half (70-1/2) to seventy-two (72) and the beneficiary distribution rules; (iii) clarify that participant deferrals may be limited due to other withholding obligations or the amount of the participant's pay check; and (iv) make certain administrative clarifications.

Eligibility

If not specifically excluded, employees may enter the Plan immediately upon hire. Nonresident aliens, leased employees, and employees of Methodist Puerto Rico Transplant Administration Corporation are excluded.

Contributions

Employees eligible to participate in the Plan are automatically enrolled to make voluntary elective deferral contributions of 3% of their base pay, subject to Internal Revenue Service ("IRS") limits. Employees can choose to make a higher or lower percentage, opt for voluntary Roth deferrals, or decline contributions altogether before the 90 day initial eligibility waiting period ends. However, any associated voluntary match contributions will not begin until after this waiting period.

The Plan also provides an automatic annual increase program whereby each Participant whose Voluntary Contribution rate is more than zero percent (0%) but is less than ten percent (10%), will automatically have such percent increase by one percent (1%) each year until such rate reaches ten percent (10%) or the Participant elects to opt out of such automatic annual increase feature.

The Plan also allows for a Roth elective deferral feature.

Participants can make rollover contributions to the Plan from another qualified retirement plan or individual retirement arrangement. Employee contributions are deposited into their accounts each pay period. Participants direct investment of their mandatory, voluntary, and rollover accounts among the investment accounts under the custodial fund. Participants are at all times 100% vested in amounts credited to their mandatory, voluntary, and rollover accounts under the Plan.

During the year ended December 31, 2024, employees making contributions to the Plan are entitled to have MHS match contributions made on their behalf. Effective Month 27, 2022, the MHS voluntary match contribution formula changed to equal 100% of employee voluntary contributions up to 5% of base pay

multiplied by a percentage dependent on an eligible employees' years of service to the Methodist Health System Employee Retirement Plan (the "Retirement Plan"). The maximum MHS match contribution is 7.25%. Participants may contribute voluntary contributions after an initial eligibility waiting period.

MHS match and voluntary match contributions are assets of the Retirement Plan and as such are not included in the accompanying Statements of Net Assets Available for Benefits or the Statements of Changes in Net Assets Available for Benefits.

Participant Loans

Participants can receive loans from their voluntary or rollover accounts. Loans are available for any purpose but cannot exceed the lesser of \$50,000 or 50% of the participants' vested interest in their voluntary and rollover accounts. Loans are treated as a segregated investment of the participants' voluntary and rollover accounts. Loans are secured by assignment of up to 50% of the participants' vested interest in their mandatory, voluntary, and rollover accounts and bear interest at a reasonable rate as defined under section 408(b)(1) of the Employee Retirement Income Security Act ("ERISA"). Principal and interest is paid in bi-weekly or monthly installments over a period generally not exceeding five years. Loans in default are treated as deemed distributions for the year of default. Participants may not have more than one loan at any given time. As of December 31, 2024 and 2023, interest rates ranged from 3.25% to 9.50%. Participant loans are classified as notes receivable from participants in the Plan's financial statements.

Benefit Payments

Certain in-service withdrawals are allowed. Participants withdrawing during the year for reasons of service or disability, retirement, death, or termination are entitled to their vested account balance. Benefits are generally distributed in the form of rollovers or lump sum payments. If withdrawing participants are not entitled to their entire account balance, the amounts not received are forfeited.

Participants may request a distribution of amounts in their voluntary or rollover accounts on the basis of hardship as defined in the Plan document, if the distribution is: (1) on account of uninsured medical expenses incurred by the participant, their spouse or dependents; (2) to purchase (excluding mortgage payments) a principal residence of the participant; (3) for the payment of post-secondary tuition expenses; (4) needed to prevent eviction of the participant from their principal residence or foreclosure upon the mortgage of the participant's principal residence; (5) payment for burial or funeral expenses for the participant's spouse, parent, children or dependent; (6) expenses for the repair of damage to the participant's principal residence that would qualify for the casualty deduction under Code section 165; or (7) any other event described by the IRS to be a heavy and financial need.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

The preparation of the financial statements in conformity with U.S. GAAP requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from these estimates.

Contributions

Contributions from the participants are accrued as they become obligations of MHS, as determined by the Plan Administrator, and in the period in which they are deducted, in accordance with salary deferral agreements.

Investment Valuation and Income Recognition

The investments of the Plan are stated at fair value (except for the fully benefit-responsive investment contracts) as of the end of the year and are subject to market or credit risks customarily associated with equity investments. Fair value measurements are determined in accordance with U.S. GAAP, which defines fair value, establishes a framework for measuring fair value, and expands disclosures about assets and liabilities measured at fair value. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Fully Benefit-Responsive Investment Contracts

The Plan holds a fully benefit-responsive investment contract with Principal Life Insurance Company ("Principal Life") totaling \$26,276,556 and \$29,299,184 as of December 31, 2024 and 2023, respectively. Principal Life maintains the contributions in a general account. The account is credited with earnings on the underlying investments net of administrative expenses and charged for participant withdrawals. There are no restrictions if a participant reallocates their investment. Participants would be subject to restrictions should MHS initiate discontinuance of the Principal contract. The minimum crediting rate to participants will be no less than 1.30% and is determined by the issuer on an annual basis.

The Plan's investments also include group annuity contracts, totaling \$568,863 and \$518,104 as of December 31, 2024 and 2023, respectively, with Empower Annuity Insurance Company of America ("Empower"), which provide a guarantee of principal and a guaranteed interest rate. The Plan ceased making contributions to these investments in 1988. Participants, within the Empower contract, are charged a 4% backend surrender charge for benefit payments unless benefit payment is for an annuity, required minimum distribution, or a death benefit. The minimum crediting rate to participants will be no less than 3.5% and is determined by the issuer on an annual basis. Various types of fees are paid by the participants for this contract.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also limit the ability of the Plan to transact at contract value with the participants. These contracts meet the fully benefit-responsive investment contract criteria and, therefore, are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Notes Receivable From Participants

Notes receivable from participants are recorded at the unpaid principal balance plus accrued but unpaid interest.

Payment of Benefits

Benefits are recorded when paid.

Forfeited Accounts

Forfeitures from terminated participants' Post-1992 MHS match accounts, voluntary match accounts, or Pre-1993 benefit accounts are used to meet MHS' obligation to make MHS match contributions and voluntary match contributions. The Plan was amended effective January 1, 2024 to (i) permit forfeitures to be used to reduce employer contributions or pay administrative expenses of the Plan and (ii) adopt optional provisions of the SECURE Act 2.0. Forfeiture balances were \$294,611 and \$311,201 for the Plan years ended December 31, 2024 and 2023, respectively. Forfeitures used to reduce expenses during the year were approximately \$24,000 in 2024.

Administrative Expenses

Participants are charged a \$55 annual fee covering all MHS Plans the participant is enrolled in. MHS pays various administrative expenses. Employees of MHS perform certain administrative functions with no compensation from the Plan.

NOTE C - FAIR VALUE MEASUREMENTS

U.S. GAAP defines fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date and establishes a three-tier hierarchy that is used to identify assets and liabilities measured at fair value. The hierarchy focuses on the inputs used to measure fair value and requires that the lowest level input be used. The three levels defined are as follows:

- Level 1 - observable inputs that are based upon quoted market prices for identical assets or liabilities within active markets.
- Level 2 - observable inputs other than Level 1 that are based upon quoted market prices for similar assets or liabilities, based upon quoted prices within inactive markets, or inputs other than quoted market prices that are observable through market data for substantially the full term of the asset or liability.
- Level 3 - inputs that are unobservable for the particular asset or liability due to little or no market activity and are significant to the fair value of the asset or liability. These inputs reflect assumptions that market participants would use when valuing the particular asset or liability.

Asset Valuation Technique

Valuation technologies maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets

measured at fair value. U.S. GAAP requires that management describe the methodologies used to measure the fair value of investments. The methodologies used to measure the fair value of the Plan's investments are as follows:

Mutual funds are measured using the estimated net asset values ("NAV") of the shares held by the Plan at year end based on published prices and are classified within Level 1 of the valuation hierarchy. There are no significant restrictions on redeeming these investments at NAV.

There have been no changes in the methodologies used at December 31, 2024 and 2023. The following table details the Plan's investments at fair value by level, within the fair value hierarchy, as of December 31, 2024 and 2023. The Plan has no investments classified within Level 2 or Level 3 of the valuation hierarchy.

These items are classified in their entirety based on the lowest priority level of input that is significant to the fair value measurement. The assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the placement of assets and liabilities within the levels of the fair value hierarchy.

NOTE D - CERTIFIED INVESTMENTS

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company ("Fidelity") and Empower, the Plan's custodians, have certified that the following information in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments at current value and fair value and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024, and 2023.
- Investment net income and interest income on notes receivable from participants, as reported in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment information as detailed in Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

NOTE E - TAX STATUS

It is the intention of the Company that the Plan, as amended and restated, meets the requirements of ERISA and qualifies under Section 403(b) of the IRC, thereby exempting the Plan from federal income taxes. The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

NOTE F - PLAN TERMINATION

Although it has not expressed any intention to do so, MHS has the right under the Plan to terminate the Plan subject to the provisions set forth in ERISA. In the event the Plan terminates, all amounts credited to participant's accounts will become 100% vested.

NOTE G - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available For Benefits.

NOTE H - PARTIES-IN-INTEREST TRANSACTIONS

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee organization, or relatives of such persons.

The Plan invests in shares of mutual funds and guaranteed investment contracts managed by affiliates of Fidelity and Empower, which act as custodians for those investments. Transactions in such investments, as well as notes receivable from participants, qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. The Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions are party in interest transactions under ERISA which are exempt from the prohibited transaction rules.

NOTE I - SUBSEQUENT EVENTS

In preparing the accompanying financial statements, management of MHS has evaluated all subsequent events and transactions for potential recognition or disclosure through September 24, 2025 the date the financial statements were available for issuance.
