### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of the Tyoga Container Company, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Tyoga Container Company, Inc. 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years ended, stating that the certified investment information, as described in Note 9 to the financial statements, is complete and accurate.

### **Opinion**

- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. ### Notes to Financial Statements

#### Note 1 – Plan Description

The following description of the Tyoga Container Company, Inc. 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General – The Plan, established September 1, 1984, is a defined contribution plan covering all eligible employees of Tyoga Container Company, Inc. (the “Company”) and provides for retirement, death, and disability benefits. Employees of the Company who have completed three months of service and have attained the age of 18 are eligible to participate in the Plan. The plan administrator is responsible for oversight of the Plan and determines the appropriateness of the Plan’s offerings and monitors investment performance.

Contributions – Participants may contribute up to 100% of eligible compensation, not to exceed the annual amount permitted by Federal law. Eligible employees are auto enrolled at 3% of compensation to be deferred to the Plan. Catch-up contributions are permitted for eligible participants age 50 or older by the end of the Plan year. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Company matches participant contributions to the Plan through a safe harbor matching contribution. For the years ended December 31, 2024 and 2023, the Company matched 100% of the employee elective deferrals up to 3% of eligible compensation, plus 50% up to a maximum of 5% of eligible compensation. The Company made safe harbor matching contributions of \$267,566 and \$253,885 for the years ended December 31, 2024 and 2023, respectively.

The Company may also make a discretionary employer profit sharing contributions at the option of its board of directors. There were no such contributions made during the years ended December 31, 2024 and 2023. Additionally, the Company may make a qualified non-elective contribution that is sufficient to satisfy certain required regulations. Qualified non-elective contributions totaled \$11 and \$181 for the years ended December 31, 2024 and 2023, respectively.

Participant Accounts – Each participant's account is credited with the participant's contribution and the participant's share of the employer contributions, an allocation of Plan earnings or losses based on the participant's directed investment accounts and charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Each participant directs the investments for their account.

Vesting – Participants are immediately vested in their voluntary, rollover, employer safe harbor match, and qualified non-elective contributions plus actual earnings thereon. Participants are vested in discretionary employer profit sharing contributions plus actual earnings thereon based on years of continuous service as follows:

Payment of Benefits – Upon termination of service, a participant may elect to receive either a lump-sum distribution or substantially equal installments equal to the vested value of his or her account. Automatic distributions will be made to terminated participants with vested balances less than \$1,000. If the terminated participant's vested account balance exceeds \$1,000, a written request from the participant is required before distribution. A participant may also elect to have the amount rolled into an IRA or another qualified plan.

Hardship withdrawals are permitted from fully vested employee deferral accounts. In-service distributions are permitted for participants who have reached age 59 ½.

Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loans must be repaid within 5 years unless the loan was used in the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at the Prime rate plus two percentage points. The rate of interest on all outstanding loans as of December 31, 2024 was 5.25% – 9.5%. Principal and interest is paid ratably through weekly payroll deductions.

Forfeitures – At December 31, 2024 and 2023, there were no forfeited non-vested accounts. These amounts can be used to reduce Plan administrative expenses or reduce employer contributions. Forfeitures of \$0 and \$1,697 were used to reduce employer contributions for the years ending December 31, 2024 and 2023.

#### **Note 2 – Significant Accounting Policies**

Basis of Accounting – The financial statements of the Plan are prepared under the accrual basis of accounting.

Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

### Notes to Financial Statements

#### **Note 2 – Significant Accounting Policies - Continued**

Investment Valuation and Income Recognition – The Plan's investments are stated at fair value as determined and certified by the Plan's custodian. See Note 5 for discussion and methods of fair value measurement.

Purchases and sales are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Investment income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits – Benefits are recorded when paid.

Administrative Expenses – Certain expenses incurred in connection with the general administration of the Plan are paid by the Plan and are recorded in the accompanying statement of changes in net assets available for benefits.

Subsequent Events – Events that occurred subsequent to December 31, 2024 have been evaluated by the Plan's management through September 11, 2025, which is the date the financial statements were available to be issued.

#### **Note 3 – New Accounting Standards**

Pronouncements issued by the Financial Accounting Standards Board (FASB) with future effective dates are either not applicable or are not expected to be significant to the Plan's financial statements.

#### **Note 4 – Investments**

During the years ended December 31, 2024 and 2023, the Plan's investments in a common collective trust fund and in mutual funds (including gains and losses on investments bought, sold, and held during the year) appreciated in value by \$1,113,680 and \$1,375,021, respectively.

#### **Note 5 – Fair Value Measurements**

Generally accepted accounting principles in the United States of America establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan can access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Money market fund:* Valued at quoted redemption price at year end.

*Mutual funds:* Valued at quoted market prices, which represent the net asset value ("NAV") of shares held by the Plan at year end.

**Note 5 – Fair Value Measurements - Continued**

*Common collective trust fund:* The Plan invests in a common collective trust fund. The Fund is designed to deliver safety and stability by preserving principal and accumulating earnings. This fund is primarily invested in guaranteed investments contracts and synthetic investment contracts. The fund is valued based upon the NAV of the underlying investments. Participant-directed redemptions have no restrictions, however, the Plan is required to provide a one-year redemption notice to liquidate its entire share in the fund.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **Note 6 – Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a plan termination or partial plan termination, participants will become 100 percent vested in their accounts.

#### **Note 7 – Parties-In-Interest Transactions**

As previously discussed, the Plan may issue loans to participants that are secured by participant account balances. All of these transactions qualify as party-in-interest transactions.

Administrative fees were paid to JULY Business Services, the custodian, and these transactions qualify as party-in-interest transactions. Administrative fees paid to JULY Business Services totaled \$48,639 and \$48,114 for the years ended December 31, 2024 and 2023, respectively.

#### **Note 8 – Tax Status**

The Company adopted a Non-Standardized Pre-Approved Profit Sharing Plan with a cash or deferral arrangement which received a favorable opinion letter from the Internal Revenue Service (IRS) on June 30, 2020. The opinion letter stated that the Plan, as then designed, is in accordance with applicable sections of the Internal Revenue Code (IRC). The prototype has been amended since receiving the determination letter for various amendments. However, the plan administrator and third-party administrator believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and that the Plan continues to be tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service and the Department of Labor. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023 there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or asset disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
