To the Trustees and Plan Administrator

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

I have performed audits of the accompanying financial statements of the WNS North America, Inc. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Basis for Opinion

NOTE 1 DESCRIPTION OF PLAN

The following description of the WNS North America, Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of Plan provisions.

General

The Plan was created on October 1, 2005, and was most recently restated as of January 25, 2021. The Plan is a 401(k) salary deferral and profit-sharing plan covering substantially all employees of WNS North America, Inc. and its related entities of: WNS Global Services Inc., Value Edge Inc., Denali Sourcing Services Inc., WNS Global Services North America Inc., HealthHelp, LLC, The Allstate Corporation, and WNS BPM Americas LLC (added on September 9, 2023) (collectively, the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Company is the Plan's sponsor and serves as plan administrator.

Transfer from Other Plans

During the year ended December 31, 2024, the Plan received transfers of \$921,055 from The Smart Cube, Inc. 401(k) Plan and the Vuram, Inc. 401(k) Plan as a result of plan mergers, both effective August 1, 2024. The transfers were recorded at the fair value of assets on the transfer date.

Eligibility

Employees of the Company are eligible to participate in the Plan upon reaching age 18. Employees covered by a collective bargaining agreement and leased employees are not allowed to participate in the Plan. Employees enter the Plan on scheduled enrollment dates following completion of the eligibility requirements.

Contributions

Employee deferrals – Participants may elect to contribute pre-tax or after-tax (Roth) up to 90 percent of eligible compensation to the Plan, as defined by the Plan, and subject to certain Internal Revenue Service (IRS) limitations. Participants may also roll over eligible amounts from other qualified plans. Participants aged 50 and over may elect to defer additional amounts ("catch-up" contributions) to the Plan.

Employer safe harbor matching – The Company provides for a safe harbor matching contribution equal to 100 percent of the first 3 percent of eligible compensation deferred by the participant, and 50 percent of the next 2 percent deferred by the participant, as defined by the Plan. Participants must complete at least 6 months of service. Safe harbor matching contributions were \$2,555,834 for the year ended December 31, 2024. The contribution is paid at each payroll, with a true-up accrued at year-end and remitted in the subsequent year.

Employer discretionary matching – The Company may elect to make discretionary matching contributions to the Plan. Participants must complete at least 6 months of service. The contribution is made at the Plan year end. Employer discretionary matching contributions are allocated to eligible participants in an amount equal to a percentage of the eligible contributions made by each eligible participant during the Plan year. There were no discretionary matching contributions for the plan year ended December 31, 2024.

Contributions (continued)

Employer profit-sharing – The Company may elect to make discretionary profit-sharing contributions to the Plan. Participants must complete at least 6 months of service, 1,000 hours of service during the Plan year, and be employed as of the last day of the Plan year, to be eligible to receive any profit-sharing contributions. Profit-sharing contributions are allocated to participants in the same proportion as a participant's compensation bears to the total of all participants' compensation. There were no profit-sharing contributions for the plan year ended December 31, 2024.

Participant Accounts

Individual accounts are maintained for each participant. Each participant's respective account is credited with the participant's contributions and Company safe harbor matching contributions, as well as an allocation of the Company's discretionary matching and discretionary profit-sharing contributions, if any, and Plan earnings. Participant accounts are charged with withdrawals, an allocation of investment losses, and administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Participants direct the investment of their and the Company's contributions into various investment options offered by the Plan. Participants may move portions of their accounts between investment options and can change their salary deferral. In addition, participants are permitted to invest in a self-directed brokerage account, which provides access to a broader range of investments, including common stocks and mutual funds, beyond the Plan's core investment lineup.

Vesting

Participants are vested immediately in their deferral contributions plus actual earnings thereon. Participants are also vested immediately in the Company's safe harbor matching contributions. A participant's interest in employer discretionary matching and discretionary profit-sharing contributions is fully vested after 2 years of service.

Notes Receivable from Participants

The Plan permits participants to borrow a minimum of \$1,000 up to a maximum of 50% of their vested account balance not to exceed \$50,000. The notes are secured by the balance in the participant's account. The loan interest rate is determined by the Plan administrator. Principal and interest are paid ratably through payroll deductions and notes must be fully repaid within five years unless it is for the purchase of a primary residence in accordance with Plan provisions.

Payment of Benefits

On termination due to any reason, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. Participants with vested account balances of less than \$5,000 and more than \$1,000 receive an automatic distribution to an Individual Retirement Account (IRA), while any account less than \$1,000 will be distributed as a lump sum cash distribution without the participant's consent.

Hardship withdrawals are permitted by the Plan, subject to a \$500 minimum amount. Hardship withdrawals must be approved by the Plan administrator and are limited to amounts of participants' contributions. In-service withdrawals are also permitted by the Plan and are available from all vested account balances.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$4,206 and \$1,672, respectively. These accounts will be used to first pay administrative expenses under the Plan, if so directed by the Company. To the extent they are not used to reduce administrative expenses, forfeitures will be used to reduce future employer contributions. Also, for the year ended December 31, 2024, administrative fees were reduced by \$1,614 from forfeited non-vested accounts.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustee determine the Plan's valuation policies utilizing information provided by the investment advisers. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the Company are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

The Plan has performed an evaluation of subsequent events through September 24, 2025, which is the date the financial statements were available to be issued.

NOTE 3 FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology include <ul style="list-style-type: none">• Quoted prices for similar assets or liabilities in active markets;• Quoted prices for identical or similar assets or liabilities in inactive markets;• Inputs other than quoted prices that are observable for the asset or liability;• Inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds:

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common stock:

Valued at the closing price reported on the active market on which the individual securities are traded. Common stock is generally classified within Level 1 of the valuation hierarchy.

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends income, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the trustee of the Plan), a qualified institution. The Plan's independent auditor did not perform auditing procedures with respect to this information, except for comparing the information with the information included in the financial statements and supplemental schedule.

NOTE 5 RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by Fidelity Management Trust Company (FMTC). FMTC is the trustee as defined by the Plan and, therefore, these transactions qualify as exempt party-in-interest transactions.

The Company is a party in interest to the Plan. However, there were no transactions with the Company other than employer contributions and the payment of certain administrative expenses on behalf of the Plan. The Plan uses third-party service providers for administration and trustee services. These transactions qualify as exempt party-in-interest transactions.

Loans to participants also qualify as exempt party-in-interest transactions.

NOTE 5 RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS (CONTINUED)

FMTC provides certain administrative services to the Plan pursuant to a Master Plan Services Agreement (MSA) between the Company and FMTC. FMTC receives revenue from mutual fund service providers for services FMTC provides to the funds. This revenue is used to offset certain amounts owed to FMTC for its administrative services to the Plan.

If the revenue received by FMTC from such mutual fund service providers exceeds the amount owed under the MSA, FMTC remits the excess to the Plan's trust on a quarterly basis. Such amounts may be applied to pay Plan administrative expenses or allocated to the accounts of the participants. During 2024, such excess amounts were applied to pay Plan administrative expenses.

NOTE 6 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their Company contributions.

NOTE 7 RISKS, UNCERTAINTIES AND CONCENTRATIONS

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

At December 31, 2024, approximately 18% of the Plan's investments were invested in the Fidelity 500 Index Fund.

NOTE 8 TAX STATUS

The Company has adopted a Non-Standardized Pre-Approved Profit Sharing Plan with CODA plan document that has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the pre-approved Plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although, the Plan has been amended since adopting the pre-approved plan document, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 9 NONEXEMPT TRANSACTIONS

During the Plan year ended December 31, 2023, participant deferral contributions and loan repayments totaling \$1,452,290, were not remitted to the Plan within the appropriate time period by the Company's management. These transactions constitute prohibited transactions as defined by ERISA. Lost earnings of \$14,509 were calculated and contributed by the Company to the Plan during 2024.

During the Plan year ended December 31, 2024, participant deferral contributions and loan repayments totaling \$3,306,317, were not remitted to the Plan within the appropriate time period by the Company's management. These transactions constitute prohibited transactions as defined by ERISA. Lost earnings of \$5,533 were calculated and contributed by the Company to the Plan during 2025.
