### (1) Description of Plan

The following description of the James J. Anderson Construction Co., Inc. 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution profit-sharing plan covering all employees of James J. Anderson Construction Co., Inc., Dyer Quarry, Inc., Riverside Materials, Inc., SJA Construction, Inc. and Anderson Construction Services, Inc. (the Company) who have attained the age of 18 and have completed three months of service, except employees whose employment is covered by a collective bargaining agreement. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The plan sponsor is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings and monitors investment performance.

#### **Contributions**

Participants may contribute up to 90% of eligible compensation, as defined by the Plan. Annual salary deferrals are limited to the maximum allowable amount under the Internal Revenue Code (IRC) (\$23,000 in 2024). Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions (a maximum of an additional \$7,500 during 2024). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company makes a matching contribution of 10% of a participant's elective deferral contribution for elective deferrals up to 10% of a participant's compensation. An additional discretionary employer match may be contributed at the option of the Company. For the 2024 plan year, the Company elected to make a discretionary matching contribution equal to a multiple of 3.5 times the Company's matching contribution. The Company may also make a discretionary profit-sharing contribution. No discretionary profit-sharing contribution was made for 2024.

#### **Participants' Accounts**

Each participant's account is credited with the participant's contributions, Company matching and discretionary matching contributions, and plan earnings (losses). The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### (1) Description of Plan, Continued

#### *Vesting*

Participants are immediately vested in their individual contributions and rollover contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts plus actual earnings thereon is based on years of continuous service as follows:

Years of Service	Vesting Percentage
Less than 1	0%
1	25%
2	50%
3	100%

Participants' accounts are fully vested upon death, normal retirement, or disability.

#### *Payment of Benefits*

Upon termination of service due to death, disability, retirement or other reasons, a participant with an account balance in excess of \$5,000 may elect to receive either a lump-sum amount equal to the value of his or her account, or payments of agreed upon installments. A participant with an account balance less than \$5,000, without respect to rollover balances, will receive a lump-sum payment of the balance.

#### *Forfeitures*

Forfeitures may be used first to reduce administrative expenses of the Plan and any remaining amount will be used to reduce future employer matching contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$12 and \$10, respectively. During 2024, \$10,211 of forfeitures were used to reduce employer matching contributions.

### (2) Summary of Significant Accounting Policies

#### *Basis of Accounting*

The financial statements of the Plan are prepared on the accrual basis of accounting.

#### *Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### *Contributions*

Contributions from plan participants and matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

#### *Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### *Payment of Benefits*

Benefits are recorded when paid.

#### *Other Income and Expenses*

Certain expenses to maintain the Plan are paid by the Plan, unless otherwise paid by the plan sponsor. Expenses that are paid by the plan sponsor are excluded from these financial statements. Expenses that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. The Plan is a party to a revenue sharing arrangement with the record keeper and established a plan level account (ERISA account) which receives shared revenue from mutual fund providers to pay for investment advisory and administrative services. During 2024, revenue sharing funds received and credited to this ERISA account amounted to \$46,502, and are reported as other income in the accompanying statement of changes in net assets available for benefits. During 2024, Plan investment advisory and administrative fees totaling \$43,092 were paid from this account, and are reported as such in the statement of changes in net assets available for benefits. At December 31, 2024 and 2023, the ERISA account balance was \$22,279 and \$18,277, respectively.

#### *Subsequent Events*

The Plan has evaluated subsequent events through September 24, 2025, the date the financial statements were available to be issued.

### (3) Financial Information Certified by a Qualified Institution

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments at fair value held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and other income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, a qualified institution.

### (4) Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered investment companies:* Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

*Common/collective trust fund:* Valued at the NAV of units of a common collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Automatic Data Processing (ADP) is the record keeper and Reliance Trust Company is the plan trustee. The record keeper and trustee are related parties. Wells Fargo Advisors provides investment advice to the Plan and is a party-in-interest who is paid an investment advisory fee (offset by a revenue sharing arrangement). The revenue sharing income totaled \$46,502 and the investment advisory fee totaled \$24,475 for 2024.

### (6) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become fully vested in their employer contributions.

### (7) Tax Status

The Plan uses a non-standardized pre-approved plan document sponsored by ADP, LLC. The IRS has determined and informed ADP, LLC by a letter dated October 6, 2020, that the plan document is designed in accordance with the applicable section of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### (8) Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
