Accordingly, the objective of the ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

Note 1 - Plan Description

The following description of Pro Equine Group, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan was established and became effective on January 1, 2008. The Plan is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The plan administrator and sponsor is Pro Equine Group Holdings, LLC (Holdings). Under the Plan, any affiliate of Holdings can also adopt the Plan. For all purposes of the Plan, the following employers, in addition to the sponsoring employer (Holdings), will be considered a single employer: Cactus Ropes, Inc.; Fast Back Ropes, Inc.; Cactus Gear, Inc.; Cactus Saddlery, Inc.; Pro Equine Group, Inc.; and RHE Hatco, Inc.

The Plan is a contributory defined contribution plan covering substantially all employees, as defined, excluding all collective bargaining employees; nonresident alien employees; and part-time, temporary, and seasonal employees of the participating companies. Covered employees become eligible to make salary deferral contributions and to receive employer matching and employer profit-sharing contributions at the first enrollment date (the first day of the next month) following the completion of six months of service, as defined in the plan agreement. Employees must be 18 years of age as of the enrollment date in order to be eligible.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of the company contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Contributions

The Plan provides for employee salary deferral contributions up to a maximum of 90 percent of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. The Plan allows participants to contribute up to 90 percent of their compensation on an after-tax basis. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

Holdings may make annual contributions to the Plan, as approved by the board of directors. Holdings made no discretionary matching or profit-sharing contributions to the Plan in 2024.

Plan Administration

The Plan is administrated by Holdings. ADP, LLC (ADP) is the appointed services provider and investment advisor, and Reliance Trust Company is the appointed plan trustee and custodian.

Participant Notes Receivable

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balances. The notes receivable are secured by the balance in the participant's account and bear interest at rates that range from 4.25 percent to 9.50 percent, which are commensurate with local prevailing rates determined periodically by the plan administrator. Principal and interest are paid ratably through monthly payroll deductions.

Note 1 - Plan Description (Continued)

Vesting

Participants are 100 percent vested in their employee pretax account, Roth account, rollover account, and any earnings thereon. Vesting in the employer discretionary matching contributions and discretionary profit-sharing contributions is on a graduated scale, and participants will not be fully vested until the completion of three years of service. Forfeitures of employer contributions will be used to pay administrative expenses of the Plan, and any remaining forfeitures will be used to reduce future employer contributions.

Benefit Payments

Upon retirement, death, disability, or termination of service or certain in-service distributions, a participant may elect to receive either a lump-sum distribution equal to the participant's vested account balance or to receive the vested account balance in installments over a period of no more than the life expectancy of the participant or the joint life expectancy of the participant and his or her designated beneficiary. Hardship withdrawals are also allowed, as permitted under the Internal Revenue Code, subject to certain restrictions defined in the plan agreement.

Termination

Although it has not expressed any intent to do so, Holdings has the right under the Plan to discontinue its contributions at any time and to terminate the Plan. In the event of such termination, participants will become 100 percent vested in their account balances.

Party-in-interest Transactions

Certain plan assets are in investment funds managed by the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation

The Plan's investments are stated at fair value.

The common collective trust fund is valued at net asset value per share (NAV) or its equivalent of the fund, which is based on the fair value of the fund's underlying assets. There are no redemption restrictions or unfunded commitments on this investment. Mutual funds are valued based on quoted market prices. See Note 5 for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Participant Notes Receivable

Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Substantially all administrative expenses of the Plan are paid directly by Holdings.

Note 2 - Summary of Significant Accounting Policies (Continued)

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan provides for investments in various investment securities, which, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including September 11, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

Reliance Trust Company (the "Trustee") holds the Plan's investments and executes all investment transactions. The investment balances and related investment income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Trustee.

Note 4 - Tax Status

The Plan is a prototype plan. The prototype plan has received a favorable opinion letter from the Internal Revenue Service indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter.

Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management's own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

Note 5 - Fair Value Measurements (Continued)

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan’s assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.
