Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of S.L. Husain Hamzavi, MD PC Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (an *ERISA Section 103(a)(3)(C) audit*). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of S.L. Husain Hamzavi, MD PC Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section—

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. NOTE 1 - Plan Description

The following description of S.L. Husain Hamzavi, MD PC Profit Sharing Plan (the "Plan") is sponsored by S.L. Husain Hamzavi, MD PC, as defined in the plan documents for the benefit of the participants. This information is provided for their eligible employees' purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

- a) General – The Plan is a defined contribution plan covering full-time employees of S.L. Husain Hamzavi, MD PC (the "Company") that are age 21 or older and have completed one thousand hours of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
- b) Contributions – Employee contributions are made by payroll deductions and participants may contribute up to 90% of their compensation as long as the total contribution does not exceed the legal dollar or percentage limits for the Plan year. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute rollover amounts, representing distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Sponsor is required to make contributions under the safe harbor provisions in an amount not less than 3% of compensation. A discretionary profit-sharing contribution may also be made at the discretion of the Plan Sponsor.
- c) Participant Accounts – Each participant's account is credited with the participant's contribution and the Sponsor's matching contribution as well as allocations of the Sponsor's profit-sharing contribution and Plan earnings. Participant's accounts are charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- d) Payment of Benefits – Benefit payments of the plan are normally provided in the form of a lump sum payment. A participant is entitled to receive the balance held in his or her account upon reaching normal retirement age. The plan also contains provisions for distributions such as hardship and in-service withdrawals. Upon death of a participant, the full value of his or her account shall automatically become 100% vested and is payable to his or her spouse and/or beneficiary. Upon termination of employment with the Plan sponsor, the vested amount of the participant's account is distributed as defined in the Plan agreement.
- e) Vesting – Participants are vested immediately in participant and Sponsor matching contributions plus actual earnings thereon. Vesting of discretionary sponsor contributions and actual earnings thereon is based on years of continuous service. A participant is fully vested in sponsor contributions after six years of credited service.
- f) Forfeitures – Any balance in the account of a participant, who has separated from service, to which he or she has no vested interest will be forfeited and will be used to reduce sponsors contributions to the Plan or pay administrative fees.
- g) Investment Elections - Each participant may direct that their salary reduction contributions be invested in one or more of the investment choices offered by the Plan. A participant may change allocation percentages quarterly with the trustee and may transfer all or a portion of the value of his or her account among the investments as often as desired.

NOTE 1 - Plan Description (continued)

- h) Participant Notes Receivables – Participants may borrow from their fund accounts subject to a minimum amount of \$1,000 as prescribed in the Plan and in the Internal Revenue Code. The maximum amount that can be borrowed is the lesser of:
- 50% of the vested balance of their account or
 - \$50,000 (reduced by the highest prior 12-month outstanding loan balance)

The loans are secured by the balance in the participant's account. The loan interest rate is fixed for the duration of the loan and set by the Plan administrator by reviewing the interest rates charged for similar types of loans by other lenders. Principal and interest is paid ratably through monthly payroll deductions.

NOTE 2 - Summary of Significant Accounting Policies

The following is a summary of significant accounting policies followed by the Plan:

- a) Basis of Accounting - The financial statements of the plan are prepared on the accrual method of accounting.
- b) Use of Estimates - The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.
- c) Investment Valuation and Income Recognition – The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

- d) Participant Notes Receivable - Participant notes receivable are recorded at their unpaid principal balances plus any accrued interest. Participant notes receivable are written off when deemed uncollectible. If a participant leaves the Plan, any loan balance will be deducted from the distribution and considered a deemed distribution.
- e) Payment of Benefits - Benefits are recorded when paid.
- f) Administrative Expenses – Administrative expenses paid by the Plan are related to the third-party administrator, trustee, the plan auditor and fiduciary fees, which are reduced by forfeitures. Investment related expenses are included in the net appreciation (depreciation) of investments. Certain Plan costs and administrative fees are borne and paid by the Plan sponsor and are not included in these financial statements.

NOTE 3 - Certification of Investment Information

ADP Retirement Trust Services, LLC, as trustee and custodian of the Plan, have supplied the Plan administrator with certifications as to the completeness and accuracy of all of the investment information reflected in the accompanying Statements of Net Assets Available for Benefits at December 31, 2024, the information in the December 31, 2024 Schedule of Assets (Held at End of Year), and the related investment activity and interest income from participant notes receivable reflected in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.

Capital Bank and Trust Company, as trustee of the plan for 2023, had supplied the Plan administrator with certifications as to the completeness and accuracy of all of the investment information reflected in the accompanying *Statements of Net Assets Available for Benefits* at December 31, 2023, the information in the December 31, 2023 *Schedule of Assets (Held at End of Year)*, and the related investment activity and interest income from participant notes receivable reflected in the *Statement of Changes in Net Assets Available for Benefits* for the year ended December 31, 2023.

NOTE 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows.

Level 1 Fair Value Measurements

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Fair Value Measurements

Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in active markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Fair Value Measurements

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There has been no change in the methodology used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 5 - Related Party Transactions and Party-In-Interest

Certain Plan investments are managed by ADP Retirement Trust Services, as Trustee and custodian of the Plan and the Plan pays direct compensations to the third-party administrator. Prior to May 2024, the Plan investments included shares of mutual funds managed by Capital Bank and Trust Company. These transactions with ADP Retirement Trust Services and Capital Bank and Trust Company, as custodians and trustees qualify as party-in-interest transactions; however, these transactions are not considered prohibited transactions under 29 CFR 408(b) of the ERISA regulations.

NOTE 6 - Forfeitures

Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Forfeitures may first be used to pay administrative expenses and then to reduce future Employer contributions. As of December 31, 2024, forfeited non-vested accounts total \$0.

NOTE 7 - Plan Termination

The Company has the right to terminate the Plan. If the Plan is terminated, partially terminated or if there is a complete discontinuance of contributions under the Plan, all amounts credited to the accounts of participants shall become 100% vested and become non-forfeitable. In the event of termination, the employer shall direct the trustee to distribute accounts to or for the exclusive benefit of participants or their beneficiaries. The employer has no intentions to terminate the plan.

NOTE 8 - Tax Status

The Plan is a prototype plan and relies on an opinion letter issued to the prototype sponsor which has obtained a favorable determination letter from the Internal Revenue Service that the prototype plan is designed in accordance with applicable sections of the Internal Revenue Code.

NOTE 9 - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 10 - Subsequent Events

The financial statements and related disclosures include evaluation of events up through September 12, 2025, which is the date the financial statements were available to be issued.
