1. Plan Description

General

The following description of the Kitson & Partners Management Services, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

Kitson & Partners Management Services, Inc. (the "Company" or "Sponsor") established the Plan, a participant-directed defined contribution plan, effective January 1, 2003. The Plan was restated as of October 15, 2008. The Plan, as restated, is a defined contribution 401(k) savings plan, which is designed to assist employees in a long-range program of savings and to be used as a means of adding to their retirement income. Employees of the Company are generally eligible to participate in the Plan on the first day of the month after attaining the age of 21 and completing 6 months of service.

The Plan offers options in which participants may elect to direct Company contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration of the Plan

The general administration of the Plan and the responsibility for carrying out its provisions shall be placed on the Kitson & Partners Management Services, Inc. Administrative Committee (the "Administrative Committee"). The Administrative Committee shall be the Plan administrator and has the authority to appoint or remove the trustee. The Administrative Committee has engaged the services of an independent profit-sharing administration firm to assist it with the performance of its duties. Reliance Trust Company (the "Trustee") and ADP, serve as trustee and record keeper of the Plan, respectively.

The Administrative Committee has entered into a trust agreement with the Trustee providing for the establishment of a trust to which all employee contributions shall be contributed and from which all benefits under the Plan shall be paid. The Trustee values all accounts on each accounting date.

Certain administrative costs of the Plan have been assumed by the Company.

Contributions

Each year participants may contribute earnings from 1% to 90% of base pay, as defined in the Plan. Participants may make a contribution which qualifies as a rollover from another qualified plan, provided the amount is not less than \$500. The Company will match 50% of each participant's contribution up to a maximum of 6% of biweekly eligible compensation. Company contributions made on behalf of each participant will be limited, if necessary, to comply with limits set by the Internal Revenue Service. The maximum amount which may be added to the participant's account for the years ended December 31, 2024 and 2023, in accordance with Section 415(c) of the Internal Revenue Code, is the lesser of \$69,000 and \$66,000 for 2024 and 2023, respectively or 100% of the participant's compensation for the year.

The Company may also make nonelective contributions to the Plan, in which all eligible employees will receive a proportionate amount of the Company's contribution.

Participants direct the investment of their contributions into various investment options offered by the Plan. All contributions are self-directed by plan participants and may be invested, in any combination, into various investment options as presented by the Trustee.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Participants vest in Company contributions and actual earnings thereon at a rate of 50% after completion of one year of service and 100% vested upon the completion of three years of service. A participant will become fully vested if termination occurs as a result of death, retirement, or disability.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined quarterly, is set at 2 percent above the prime rate, as defined. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits

Normal Retirement Benefits - The normal retirement date is the first day of the month following the month in which the participant attains age 65.

Deferred Distribution - A participant may elect in writing to postpone the commencement of benefit distribution until the required beginning date as defined by the Internal Revenue Service.

Benefit Payments - On termination of service, a participant is entitled to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Payment shall be in cash. If a participant's nonforfeitable account balance is \$5,000 or less, the Plan administrator shall automatically distribute it in a lump sum without the participant's consent upon the termination of employment (or if the participant is deceased, to the participant's beneficiary without the beneficiary's consent).

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$9,229 and \$1,416, respectively. These accounts will be used to reduce future employer contributions. Also, in 2024 and 2023, employer contributions were reduced by \$28,190 and \$3,459, respectively from forfeited nonvested accounts.

2. Summary of Significant Accounting Policies

Basis of Accounting

The Plan's financial statements have been prepared on the modified cash basis. Therefore, with the exception of appreciation or depreciation in the market value of investments, income and expense items are recognized only as cash is received or paid and receivables (other than notes receivable from participants), payables and accrued expenses are not reflected.

Use of Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect the amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and custodians. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest and dividends are recorded when received. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance. Interest income is recorded on the modified cash basis. Related fees are recorded as administrative expenses and expensed when they are incurred, if not paid for by the Company. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Payment of Benefits

Benefits are recorded when paid.

Expenses

At the Company's election, expenses incurred for the administration of the Plan may be paid by Kitson & Partners Management Services, Inc. All expenses relating directly to the investments of the Trust Fund, including taxes, brokerage commissions and registration charges, must be paid from the Trust Fund.

Subsequent Events

The Plan's administrator has evaluated subsequent events and transactions that occurred after December 31, 2024 through the date of the independent auditors' report and the date the financial statements were available to be issued, July 24, 2025. The financial statements include all events or transactions, including estimates, required to be recognized in accordance with the modified cash basis of accounting. The Plan administrator has determined that there are no unrecognized subsequent events that require additional disclosure.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to measurements involving significant unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100 percent vested in their employer contributions. These accounts may be reduced by administrative termination expenses incurred and paid by the Company for which the Company seeks reimbursement by the Plan.

7. Tax Status

The Internal Revenue Service has determined and informed the Company by letter dated July 8, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirement of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations at any time within certain statutorily defined periods.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits – modified cash basis.
