## INDEPENDENT AUDITORS' REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(c) Audit

We have performed audits of the financial statements of HardingPoorman, Inc. 401(k) Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of HardingPoorman, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the years ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section—

- The amounts and disclosures in the financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- The information in the financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). **NOTES TO FINANCIAL STATEMENTS**  
December 31, 2024 and 2023

**1. DESCRIPTION OF THE PLAN**

The following description of the HardingPoorman, Inc. 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a 401(k) Salary Deferred plan covering all employees of HardingPoorman, Inc. (Company) who have attained age 18 and have completed at least 1 month of service. New participants may enter the Plan monthly upon satisfying the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The trustee oversees governance of the Plan, determines appropriateness of the Plan's offerings, and monitors investment performance.

**Contributions**

Each year participants may contribute up to 90 percent of pretax annual compensation. Participants may also make Roth contributions as defined in the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4%. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Contributions are subject to certain limitations. Participants may also contribute amounts representing distributions from other qualified plans. The employer may contribute to the Plan a discretionary contribution. For 2023 and 2024, the employer matched employee contributions at 25%, up to a maximum employer match of 1%. Forfeitures will be used to reduce future employer contributions. Additionally, the employer absorbs certain costs of plan administration.

**Participant's Accounts**

Each participant's account is (a) credited with the participant's contribution, an allocation of the Company's contribution and plan earnings and, (b) charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

## 1. DESCRIPTION OF THE PLAN (continued)

### **Vesting**

Participants are immediately vested in their voluntary contributions and company contributions plus actual earnings thereon.

### **Payment of Benefits**

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, monthly installments, or partial withdrawals. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

### **Notes Receivable – Participants**

Participants may borrow from their vested account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the Participant Loan fund. The loans are secured by the balance in the participant's account and bear interest at a reasonable rate as determined by the plan administrator. Principal and interest is paid ratably through payroll deductions.

### **Investment Options**

Upon enrollment in the Plan, a participant may direct all contributions in one percent increments into various investment options offered by the Plan. The plan assets are invested in various accounts offered by Reliance Trust Company.

## 2. SUMMARY OF ACCOUNTING POLICIES

### **Basis of Accounting**

The financial statements of the Plan have been prepared on the accrual basis of accounting in conformity with generally accepted accounting principles.

### **Use of Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan's management to make estimates and assumptions that affect the reported amounts of plan assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

## 2. **SUMMARY OF ACCOUNTING POLICIES** (continued)

### **Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Minimum Funding Requirements**

Contributions to the Plan have been funded in accordance with the minimum funding standards of ERISA.

### **Payment of Benefits**

Benefits are recorded when paid.

### **Notes Receivable – Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

### **Subsequent Events**

The Plan's management has evaluated subsequent events through September 12, 2025, the date the financial statements were available to be issued.

## 3. **INFORMATION CERTIFIED BY THE CUSTODIAN**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and dividends for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company (the custodian of the Plan).

#### 4. FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs are not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the years presented and there were no changes in the methods used to measure fair value at December 31, 2024 and 2023.

##### *Level 1 Fair Value Measurements*

The fair value of mutual funds and money market fund shares is based on the net asset value (NAV) provided by the transfer agents for the funds.

##### *Level 2 Fair Value Measurements*

The fair value of common/collective trusts is based on the underlying securities within the fund as determined by the trust sponsor. Unit values are determined by dividing the fund's net assets at fair value by the fund's outstanding shares.

#### 5. DEFERRED VESTED BENEFITS AND FORFEITED ACCOUNTS

Assets allocated to participants who have withdrawn from the Plan amounted to \$-0- at December 31, 2024 and 2023. There were forfeitures of \$34 at December 31, 2024 and \$31 at December 31, 2023. Forfeitures will be used to reduce future employer contributions.

#### 6. PLAN TERMINATIONS

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan terminations, participants will become 100 percent vested in their accounts.

**7. TAX STATUS**

The Plan has obtained a favorable tax determination letter from the Internal Revenue Service. The Plan has been amended since receiving the determination letter. However, the plan sponsor believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the plan was qualified and the related trust was tax-exempt as of the financial statement date.

**8. REPORTABLE TRANSACTIONS**

There were no single transactions or series of transactions within the plan year in excess of five percent of the current value of the plan assets that are required to be reported on the Form 5500.

**9. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**10. PARTY-IN-INTEREST TRANSACTIONS**

Certain plan investments are shares of investment funds managed by Reliance Trust Company. Reliance Trust Company, the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for administrative services totaled \$14,514 for 2024 and \$14,148 for 2023. Additionally, the Plan paid \$27,221 in 2024 and \$25,433 in 2023 for investment advisor fees.
