We have performed audits of the financial statements of the Trystar, LLC 401k Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Notes to Financial Statements

Note 1. Description of Plan

The following description of the Trystar, LLC 401k Plan (the Plan) is provided for general information purposes only. Participants should refer to the summary Plan description for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan covering all employees of Trystar, LLC, and its wholly owned subsidiaries (collectively, the Company) who are 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan Administrator is responsible for the oversight of the Plan, determining the appropriateness of the Plan's investment offerings and monitoring of investment performance.

Contributions: Participants may contribute pretax elective deferrals and Roth elective deferrals to the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). The combined pretax and Roth elective deferrals are limited to the annual Internal Revenue Service (IRS) limit. The Company matches 100% of the first 4% contributed by the participant. Employees are eligible for ADP Test QACA Safe Harbor Matching Contributions. Non-elective contributions (other than Safe Harbor non-elective contributions) may be contributed at the discretion of the Company.

Investment options: The Plan has investment options, as described in the Plan's literature, from which participants may select. The funds vary in type of investments, rate of return and investment risk. Contributions are deposited with Reliance Trust Company (the Custodian) and are credited to the individual participant accounts. Participants self-direct the investments in their accounts and can allocate their account balance and future contributions to the various investment options in any combination. Such allocations may be changed at any time during the year.

Participant accounts: Each participant's account is credited with the participant's contributions, the Company safe harbor matching contribution, an allocation of Company discretionary contributions, if any, investment results and charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant compensation, account balances or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are vested immediately in their employee contributions. Safe harbor matching contributions are also immediately vested into their accounts. Vesting in the employer matching and profit sharing contribution portion of their accounts plus actual earnings thereon is based on a graduated vesting schedule with 100% vesting after the completion of six years of service. However, upon the participant's death, disability or attainment of normal retirement age, all amounts are immediately vested. Forfeited nonvested accounts are used to fund future Company contributions or pay Plan expenses.

Payment of benefits: Upon a participant's retirement, death, total disability or other termination of service, the participant's vested account balance shall be distributed to the participant or beneficiary using one of several available benefit distribution methods. During employment, participants may withdraw account balances upon attainment of age 59½. Withdrawals are allowed before attaining age 59½ for reasons of financial hardship or other conditions as specified by the Plan.

Note 1. Description of Plan (Continued)

Notes receivable from participants: Participants may borrow from their vested fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. Note transactions are treated as transfers between the investment fund and the note account. Note terms range up to five years or longer if the note proceeds are used by the participant for the purchase of a principal residence. The notes are secured by the balance in the participant's account and bear a fixed rate of interest. Interest rates at December 31, 2024, ranged from 4.25% to 10.50% and are due through December 2029. Principal and interest are paid ratably through regular payroll deductions or remitted directly by participants.

Plan termination: Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Plan Administrator and management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator and management determine the Plan's valuation policies utilizing information provided by the custodian. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Payment of benefits: Benefit payments to participants are recorded upon distribution.

Notes receivable from participants: Participant loans are classified as notes receivable from participants, which are segregated from Plan investments and measured at their unpaid principal balance plus any accrued interest. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan payments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Notes receivable from participants have been classified as an investment for Form 5500 reporting purposes and, accordingly, have been included as an investment in the supplemental schedule, Schedule H, line 4i—schedule of assets (held at end of year).

Contributions: Contributions from Plan participants and the matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

Note 2. Summary of Significant Accounting Policies (Continued)

Administrative expenses: Expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Transaction-based fees, which are associated with optional services offered under the Plan, are incurred by each participant who takes advantage of the services. In addition, certain investment-related expenses are included as an offset to net appreciation in fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

Subsequent events: The Plan evaluated subsequent events through September 22, 2025, the date the financial statements were available to be issued.

Note 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under the Financial Accounting Standards Board's Accounting Standards Codification Topic 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The Plan's policy is to recognize transfers in and transfers out as of the actual date of the event or change in circumstances that caused the transfer. For the year ended December 31, 2024, there were no transfers between levels.

Note 3. Fair Value Measurements (Continued)

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to the methodologies used at December 31, 2024 and 2023.

Mutual funds: Mutual funds are valued at quoted market prices for identical assets in active markets for the shares held by the Plan at year-end.

Collective trust funds: Collective trust funds are valued at the net asset value (NAV) of units held by the Plan on the day of valuation based upon the market value of the underlying investments. The funds' underlying assets consist of common stocks, depository receipts, mutual funds and stable value funds. The NAV is used as a practical expedient to estimate the fair value. The practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

The methods described above may produce fair values that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The redemption notice period disclosed in the table above reflects the notice period required if the Plan withdraws from the investment. There is no redemption notice period required for individual participants who choose to withdraw from the investment.

Note 4. Related-Party Transactions and Party-in-Interest Transactions

The Custodian holds the Plan's assets and executes transactions, therefore, these transactions qualify as party-in-interest transactions.

Note 5. Tax Status

The Plan is qualified under the appropriate section of the Internal Revenue Code (IRC) and intends to continue as a qualified plan. The IRS has determined and informed the Plan sponsor, by a letter dated October 6, 2020, that the Plan, as designed, is qualified under the appropriate section(s) of the IRC. The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the amounts reported in the 2024 statement of net assets available for benefits.
