INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Great Lakes Management 401(k) Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). 1. DESCRIPTION OF THE PLAN

The following description of the Great Lakes Management 401(k) Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General - The Plan is a single-employer defined contribution 401(k) plan covering substantially all employees of Great Lakes Management Company, Inc. and Gentle Touch Health Initiatives, LLC (collectively, the Company) who are age twenty-one or older. Participants are eligible to receive Company discretionary matching, profit-sharing, and safe harbor contributions after completing 1,000 hours of service and one year of service as defined by the Plan Document.

In 2023, the Plan was amended multiple times to change the plan year end to June 30, to change the plan year end back to December 31, and to make adjustments to the definition of compensation.

The Company is the Plan Sponsor and Plan Administrator. Reliance Trust Company has been appointed trustee and ADP, Inc. provides recordkeeping services for the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Investments are held in mutual funds and a common/collective trust fund.

Contributions - Participants are allowed to make an elective pretax (traditional 401(k)) or after-tax (Roth 401(k)) deferral contribution up to IRS limits and not to exceed 80% of annual compensation, as defined in the Plan. The Plan allows participants age 50 and older to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions).

The Company makes safe harbor matching contributions allocated to those who elect salary deferral contributions. Safe harbor matching contributions are equal to 100% of the first 3% of compensation and 50% of the next 2% of compensation that a participant contributes to the Plan. A participant must be age 21 and complete twelve consecutive months of employment in order to be eligible for the safe harbor matching contribution.

The Plan also allows for the Company to make discretionary matching contributions equal to 4% of that participant's compensation. The Plan also allows for the Company to make profit-sharing contributions. No discretionary matching or profit-sharing contributions were made in 2024.

Participant Accounts - Each participant's account is credited with the participant's contributions plus an allocation of (a) the Company's safe harbor matching, discretionary matching, and profit-sharing contributions, and (b) Plan earnings and increases or decreases in the value of investments, net of expenses. Allocations are based on account balances or participant earnings as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - The participant's elective deferral contributions and earnings thereon are always 100% vested. For the Company's contributions and earnings thereon, vesting is based on years of service. A participant is 100% vested after six years of credited service. Notwithstanding the above, a participant's account will be fully vested upon death, disability or retirement.

Notes Receivable from Participants - Participants may borrow from their fund accounts a minimum of \$500 up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at fixed rates of prime plus 2% determined at note inception. The interest rates on notes outstanding at December 31, 2024 were 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits - On termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum distribution equal to the value of the participant's account, rollover to another qualified retirement account, or annual installments no later than age 70.5. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution or rollover to another qualified retirement account.

Forfeitures - When certain terminations of participation in the Plan occur, the non-vested portion of the participant's account represents a forfeiture. Forfeitures are used to reduce future Company contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$31 and \$30. During 2024, \$11,226 of forfeitures were used to reduce Company contributions.

Investment Options - Participants are allowed to direct the investment of their contributions among the various investment options offered by the Plan. Company contributions are allocated on the same basis as employee contributions.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The accompanying financial statements have been prepared on the accrual basis of accounting.

Estimates - The preparation of any financial statements in accordance with U.S. generally accepted accounting principles may require management to make estimates and assumptions that affect certain amounts reported and disclosed in the financial statements. Actual results could differ from such estimates.

Valuation of Investments - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales are recorded on a trade-date basis. Interest income is recorded when earned and dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants - Notes receivable from participants are stated at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a deemed distribution is recorded.

Payment of Benefits - Benefits are recorded when paid.

Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses paid by the Company are excluded from these financial statements.

4. INCOME TAX STATUS

The prototype plan document adopted by the Plan obtained its latest opinion letter on October 6, 2020, in which the Internal Revenue Service stated that the prototype plan document, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has not received a determination letter specific to the Plan itself; however, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. generally accepted accounting principles require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected.

5. FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from, or corroborated by, observable market data by correlation or other means; and Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement and have the lowest priority.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trust fund: The fair value per unit of investments in a common/collective trust is determined by the fund's trustee based on the fair value of the underlying securities within that fund divided by the number of units trading. Plan management believes using net asset value as a practical expedient to estimate fair value is appropriate for investments in the common/collective trust. This practical expedient would not be used if it is determined to be probable that the Plan will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. The Plan's investment in the common/collective trust fund is not subject to any withdrawal or redemption restrictions. The Plan has no unfunded commitments relating to the common/collective trust fund at December 31, 2024 and 2023.

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all of the assets will be distributed to the participants based upon the balance in their respective accounts.

7. PARTY-IN-INTEREST TRANSACTIONS

Notes receivable from participants qualify as party-in-interest transactions.

The Plan's Sponsor pays certain administrative expenses of the Plan.

8. SUBSEQUENT EVENTS

Management has evaluated subsequent events through September 8, 2025, the date on which the financial statements were available for issue, and identified no further significant events or transactions to disclose.
