Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about T-Bonz 401(k) Retirement Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter—Supplemental Schedule Required by ERISA

The supplemental Schedule H; Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental



schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to Financial Statements

1. Description of Plan

The following description of T-Bonz 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of T- Bonz Management Company, LLC (the "Company") who are age twenty-one or older and have completed one year of eligible service with 1,000 service hours. Participants may enter the Plan on the first day of the plan year or the first day of the seventh month of the plan year coinciding with or next following the date which the participant meets the Plan's eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

Contributions

Each year, participants may contribute an elected amount of pretax annual compensation, as defined in the Plan. Additionally, participants may elect to make after-tax Roth contributions to the Plan. Participants who are age fifty or older by the end of the year are eligible to make an additional catch up contribution to the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover contributions). Participants direct the investment of their contributions to various investment options offered by the Plan.

The Company may provide a discretionary matching contribution dependent on the Company's operating results. Company contributions are invested into the investment options elected by the participant. For the 2024 plan year, the Company made a matching contribution equal to 100% of the participant's deferral contribution up to three percent of their compensation.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Vesting

Participants are immediately vested in their elective contributions plus actual earnings thereon. Vesting in the Company's discretionary contribution plus actual earnings thereon is based on years of credited service. A participant vests according to the following schedule:

Years of Service	Vesting Percentage
Less than one year	0%
More than one year, less than two years	25%

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the Company's contribution and Plan earnings and charged with an allocation of administrative expenses. Allocations of Company's contributions are based on a match of participant deferral contributions. Allocations of Plan earnings and administrative expenses are based on account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Upon enrollment in the Plan, a participant may direct employee contributions and employer matching contributions into any of the available investment options offered under the Plan. The Plan currently offers various mutual funds and a common collective trust fund as investment options for participants. Participants may change their investment options as often as permitted under the investment vehicles chosen by the participant.

Notes Receivable from Participants

Participants may borrow a maximum of two loans from their fund accounts at a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Participant loans are valued at their unpaid principal balances, plus all accrued but unpaid interest. The loans are secured by the balance in the participant's account and bear interest at prime rate plus 1%. Principal and interest is paid ratably through weekly payroll deductions.

Payment of Benefits

On retirement, death, disability, or termination of service, a participant (or participant's beneficiary in the event of death) receives a lump sum distribution equal to the participant's vested account balance. Hardship distributions are permitted if certain criteria are met.

Forfeitures

The plan administrator may elect to use all or any portion of the forfeited amounts to pay administrative expenses incurred by the Plan or reallocation to reduce Company contributions. Forfeitures generated for the plan years ended December 31, 2024, and 2023 totaled \$2,465 and \$2,474, respectively. During the plan year ended December 31, 2024, \$2,465 of forfeitures were used to fund employer matching contributions to the Plan. There were no unallocated forfeitures at December 31, 2024 and 2023.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments in mutual funds are reported at fair value. The Plan's for fully benefit responsive investments which are valued at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Trustees determine the Plan's valuation policies utilizing information provided by the Plan's investment advisors and custodians. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded for tax purposes. Deemed distributed loans continue to be reported in the Plan's financial statements until the participant has reached a distributable event.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses incurred in connection with the general administration of the Plan are paid by the Plan and are recorded in the accompanying statement of changes in net assets available for benefits as administrative expenses. Expenses of maintaining the Plan that are paid directly by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net depreciation of fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through September 23, 2025, the date the financial statements were available to be issued.

New Accounting Pronouncements

On December 29, 2022, the SECURE 2.0 Act of 2022 was signed into law. This act contains provisions that go into effect at various times starting in the 2023 year and ending in 2033. The deadline for adopting any required plan amendments pursuant to the SECURE 2.0 Act is December 31, 2026; however, plans must be operated in accordance with the effective date of each new provision. Management has reviewed the provisions effective for the 2023 year and continues to monitor and adjust operations in accordance with provisions as they become effective. As of December 31, 2024, no formal Plan amendments have been made to adopt SECURE 2.0 Act provisions. Management has determined that the Plan was in compliance with all applicable provisions for the year ended December 31, 2024.

4. Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Basis of Fair Value Measurement

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
- Level 2 Inputs to the valuation methodology include
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability; and
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment, and may affect the valuation of fair

value assets and liabilities and their placement within the fair value hierarchy levels. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Mutual Funds: Plan assets invested in mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Fully Benefit-Responsive Investment Contract – Stable Value Fund

At December 31, 2024 and 2023, the Plan held \$42,003 and \$49,830 in a common collective trust fund consisting entirely of the Reliance MetLife Stable Value Fund 25053 – Class O, respectively. The primary investment objective of the Funds is to preserve principal while generating earnings at rates competitive over time with short-term high quality fixed income investments. Reliance Trust Company serves as trustee and investment manager of the Fund. The Fund is not FDIC insured and is not guaranteed by Reliance Trust nor guaranteed by any governmental agency. Units of beneficial interest in the Fund are exempt from registration under the Securities Act of 1933.

The contracts within the Funds are guaranteed investment contracts. The Funds record security transactions on a trade date basis. Interest income is accrued at the contracts' crediting rate. The crediting rate is generally based on the fair value, duration, and yield-to-maturity of the Contracts. These Contracts typically allow for realized and unrealized gains and losses on the underlying assets to be amortized, usually over the duration of the underlying investments, through adjustments to the future interest crediting rate, rather than reflected immediately in the net assets of the Fund. The contracts' issuer guarantees that all qualified participant withdrawals will be at contract value.

Contract 25053 provides a fixed interest rate for a fixed period that will apply to the entire guaranteed value. The interest rate is reset every quarter as determined by MetLife with consideration of the fair value of the separate accounts, the anticipated market yields-to-maturity of benchmark indices of the separate accounts, expected payments into and out of the Contract, amortization of the difference, if any, between the fair value of the separate accounts and the guaranteed value of the Contract, and the fees allowed under the Contract.

Participants' accounts invested in the Stable Value Fund are available for participant-initiated transactions at book (contract) value, including transfers to other investment options, loans and distributions in the event of hardship and upon a participant's retirement, death, disability and certain separations from service. Because these participant-initiated transactions occur at book (contract) value, participants' investments are not subject to changes in value due to market conditions.

If the Agreement is fully or partially terminated, participants will receive the liquidation value of the Fund instead of the book (contract) value. The liquidation value is determined in accordance with a formula contained in the Agreement, which is designed to reflect the value of the assets in the account. The liquidation value may be more or less than the book (contract) value of the plan's investments in the account. This means that upon partial or full termination of the Agreement, a participant's account balance in the Fund may be either increased or decreased.

The fixed interest investment account is considered fully benefit-responsive. As such, the investment has been reported at contract value in the statement of net assets available for benefits at December 31, 2024 and 2023. A reconciliation of fair value and contract value follows:

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the plan to discontinue its contributions at any time and to terminate the plan, subject to plan provisions and ERISA. In the event of plan termination, participants would become 100% vested in the company contributions portion of their account.

7. Related Party Transactions and Party-in-Interest Transactions

During 2024 and 2023, certain Plan investments are managed by Reliance Trust Company (Reliance). Reliance is the custodian and recordkeeper of the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the asset custodial and recordkeeping services are included in the net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. For the plan years ended December 31, 2024 and 2023 the Plan did not make any direct payments to Reliance that were not covered by revenue sharing.

The Company pays directly any other fees related to the Plan's operations. Additionally, the Company provides certain administrative services to the plan for which no fees are charged.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the individual participant account statements and the statement of net assets available for benefits.

9. Concentration of Credit Risk

A significant portion of Plan assets are invested with one investment management company. Such investments are subject to credit and market risk associated with (1) the credit worthiness of the investment management company, (2) the credit worthiness of underlying issuers, and (3) fluctuations in market value inherent with changes in economic conditions. At December 31, 2024, approximately 83% of total plan investments were held in Vanguard funds.

10. Tax Status

The Plan has adopted a volume submitter 401(k)/profit sharing plan offered by ADP, LLC. The prototype plan obtained its latest opinion letter dated October 6, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the opinion letter. However, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the plan is qualified and tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 there were no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the notes to the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

11. Subsequent Events

Effective January 1, 2025, all Plan assets were transferred to Voya Financial. The Plan was restated and renamed Homegrown Hospitality Group 401(k) Plan and Trust at that time. Additionally, the Plan was amended to exclude leased employees from participation and implement standard required SECURE Act provisions.

12. Compliance Matters

The following compliance matters have been identified in the current year audit. As of the report date, management is working with its third-party administrator to take appropriate actions to rectify the matters. While compliance matters could have a significant detrimental impact on the ongoing plan operations, the Sponsor does not believe that the resolution of the identified matter will have a negative impact on the Plan's qualified tax status. As such, the financial statements do not include adjustments that may be required should the Plan lose its qualified tax status as a result of the identified compliance matters.

At December 30, 2024, the Plan entered into a blackout period to facilitate the transfer of assets to the new custodian (see Note 11). During this time, the Sponsor failed to calculate and withhold participant deferral contributions and loan repayments.

The Plan failed to make corrective distributions due to failed non-discrimination testing within two and one-half months of year end. As of the report date, all corrective distributions for the 2024 plan year have been made and the Company is in the process of filing Form 5330 and paying the required excise tax.

13. Form 5500 Reconciliation

The financial statements have been prepared on the accrual basis of accounting. As such, they include the accrual of certain expenses that are presented in the Form 5500 filing in the year paid. Additionally, the financial statements include deemed distributed participant loans that are not reflected in the Form 5500 as the affected participants have not incurred a distributable event. The following is a reconciliation of the net assets available for benefits per the financial statements to the net assets available for benefits per the Form 5500 at December 31, 2024:
