### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Clack Corporation Profit Sharing 401(k) Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). **Note 1. Description of the Plan**

***General***

The following description of Clack Corporation Profit Sharing 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Document and *Summary Plan Description* for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan sponsored by Clack Corporation (the Company) for the benefit of its employees who are full-time employees who are not covered by a collective bargaining agreement. Participants must have completed 30 days of service with the Company and be age 20 or older. Employees who have one year of service with the Company and are age 20 or older are eligible for Company contributions. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Matrix Trust Company is the trustee of the Plan. OneAmerica Retirement Services serves as a recordkeeper to the Plan.

***Contributions***

The Plan permits eligible employees through a salary deferral election to have the Company make annual contributions of up to 80% of pretax annual compensation. Employee rollover contributions are also permitted. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions.

The Company makes non-elective safe harbor contributions of 3% of plan compensation. The safe harbor contribution is decided on annually by the Company's Board of Directors. The Company makes non-elective profit-sharing contributions as determined by the Company's Board of Directors annually. During the years ended December 31, 2024 and 2023, the Company made safe harbor and profit-sharing contributions totaling \$2,671,566 and \$2,384,207 to the Plan, respectively. Contributions are subject to certain limitations.

***Participant Investment Account Options***

Each participant has the option of directing their contributions into any of the various investment options offered by the Plan and may change the allocation daily.

The Plan Document also includes an automatic deferral feature starting at 5% whereby a participant is treated as electing to defer a certain percentage of eligible compensation unless the participant made an affirmative election otherwise. The automatic deferral feature also provides for an annual increase in the percentage deferred which is capped at 10%.

Employer safe harbor and profit sharing contributions to the plan are invested at the discretion of the participant.

***Participant Accounts***

Each participant's account is credited with the participant's contribution, the Company's contributions and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their voluntary contributions, rollover contributions, employer match, and safe harbor contributions, plus earnings thereon. Vesting in the employer's profit sharing contributions plus earnings thereon is based on years of continuous service. A participant is fully vested after six years of continuous service.

***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant's account. The loan interest rate for all loans is the Wall Street Journal Prime rate. Principal and interest is paid ratably through monthly payroll deductions.

***Payment of Benefits***

Upon termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the vested interest in their account or annual installments over a 10-year period. Upon termination of service for other reasons, a participant may receive the value of the vested interest in their account only as a lump-sum distribution.

***Forfeited Accounts***

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$33,163 and \$36,575, respectively. These accounts will reduce future employer contributions to participants based on participants' earnings and time of service as defined by the Plan Document. Also, in 2024 and 2023, employer contributions were reduced by \$38,291 and \$65,793 from forfeited nonvested accounts, respectively.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end.

The Plan's interest in the collective trust is valued based on information reported by the investment advisor using the audited financial statements of the collective trust at year-end.

Universal life policies are presented at cash surrender value, which approximates fair value. Prior to December 31, 1990, under the Plan, participants had the option of purchasing individual life insurance policies. The cash value of these policies, \$19,328 and \$20,451, are included in the statements of net assets available for benefits for 2024 and 2023, respectively.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Contributions***

Contributions from Plan participants and the safe harbor contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Employer profit-sharing contributions are recorded in the year in which the participant compensation is earned.

***Notes Receivable from Participants***

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan Document.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

**Note 3. Certification of Plan Trustee**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Matrix Trust Company, a qualified institution, has certified the following investment information included in the accompanying 2024 and 2023 financial statements, respectively, and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

#### **Note 4. Related-Party and Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

The Plan paid \$132,716 and \$147,667 of recordkeeping, administration and investment fees during the years ended December 31, 2024 and 2023, respectively. The Plan also received fee credits in the form of rebates from the investments. Total fee credits received were \$23,421 and \$26,239 for 2024 and 2023, respectively. The Company provides certain administrative services at no cost to the Plan.

#### **Note 5. Disclosures About Fair Value of Plan Assets**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities

**Investments**

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. The value of certain investments, classified as alternative investments, is determined using net asset value (or its equivalent) as a practical expedient. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

**Note 6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

**Note 7. Tax Status**

The Plan operates under a non-standardized Volume Submitter Basic Plan Document in connection with a defined contribution plan and trust document sponsored by OneAmerica Financial Partners, Inc. This defined contribution volume submitter plan and trust document has been filed with the appropriate agency. The Plan has obtained an opinion letter dated August 19, 2020. However, the Plan has been amended since the date of the opinion letter, but the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.
