Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Southwest Florida Enterprises 401(K) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

1. DESCRIPTION OF PLAN

The following description of the Southwest Florida Enterprises, 401(K) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Southwest Florida Enterprises, Inc. (the “Plan Sponsor”, the “Company”, or the “Employer”), who have one year and 1,000 hours of service and are age 21 or older, and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). The effective date of the Plan is September 1, 1999.

Contributions

Participants may elect to contribute to the Plan a portion of their compensation, as defined by the Plan, on a pre-tax basis, subject to Internal Revenue Service (“IRS”) and other limitations. Those participants who are fifty (50) years of age or older may also make a “catch up” contribution in addition to the maximum salary deferral. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover contributions). The Company may contribute a discretionary matching contribution each year. The Company has elected to match 50% of the participants’ elective deferral contributions, up to 3% of the participants’ contributions with a maximum of 1.5% of participants’ compensation.

Participant Accounts

Each participant’s account in the Plan is credited with the participant’s contribution, an allocation of any Employer contribution and the Plan’s earnings thereon and charged with benefit payments and an allocation of the Plan’s losses and administrative expenses. Plan earnings and losses are allocated based upon account balances while contributions are credited based upon elective deferrals and compensations, as defined. Administrative expenses are charged directly to the accounts of the participant who incur those fees. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investment Options

A participant may direct participant contributions and any Employer contributions into any of several investment options including a guaranteed interest account or pooled separate accounts. Participants may change their investment options at their discretion.

Vesting

Participants are immediately vested in their elective deferral contributions, as well as any rollover contributions, plus or minus any earnings or losses thereon. Participants are also immediately vested in the Company’s matching portion of their accounts and the earnings and losses thereon. As participants are immediately vested in all amounts in their account, there are no forfeitures.

Payment of Benefits

On termination of service due to termination of employment, death, disability, or retirement, a participant or their beneficiary may elect to receive the vested portion in the participant’s account in a lump sum distribution or in installment payments. In-service withdrawals are permitted from pre-tax contributions account balances upon demonstration of financial hardship or for qualified reservist reason. Participants may elect to rollover their vested balance to another qualified retirement plan or IRA.

1. DESCRIPTION OF PLAN (CONTINUED)

Notes Receivable from Participants

Participants may borrow from the Plan a minimum of \$1,000 up to a maximum amount not to exceed the lesser of \$50,000 or 50% of the vested portion of their account balance. Notes receivable from participants range from 1 to 5 years or longer for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with the prime rate as printed in the Wall Street Journal at the time the loan is taken. Interest rates were between 5.25% and 10.50% as of December 31, 2024 and 2023. Principal and interest are paid ratably through monthly payroll deductions. Upon termination of service or termination of the Plan where benefits are paid in a lump-sum amount, the unpaid balance of the note is deducted from the participants vested balance prior to the issuance of the benefit check.

Administrative Expenses

The Company has absorbs a significant part of the administrative costs for the Plan, including professional fees for accounting, auditing and Plan administration, contract charges and servicing fees. Administrative fees paid by the Company are excluded from these financial statements. Participant requested transactions such as loan origination and distribution fees are paid by the participants of the Plan. Investment management fees charged to the Plan for investments in the various funds are deducted from income earned and are reflected as a component of net appreciation in the fair value of investments on the statement of net assets available for benefits.

Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their Employer contributions.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed as incurred. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements and participant account balances.

Subsequent Events

The Plan has evaluated subsequent events through September 1, 2025, which is the date the financial statements were available to be issued.

3. TAX STATUS

The Plan adopted its latest Prototype Non-Standardized Pre-Approved Profit Sharing Plan with a cash or deferral arrangement developed by Principal, which obtained a favorable Internal Revenue Service ("IRS") opinion letter on June 30, 2020 in which the IRS stated that the form of the underlying prototype plan was acceptable under provisions of the Internal Revenue Code ("Code") and that any employer adopting this form of the plan will be considered to have a plan qualified under the Code. The Plan has been amended since receiving the opinion letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

4. PARTY-IN-INTEREST AND RELATED PARTY TRANSACTIONS

Southwest Florida Enterprises is the administrator of the Plan, and as such, executes the normal duties associated therewith. Cost incurred for audit, legal, and other administrative functions are paid by the Southwest Florida Enterprises.

Principal Life Insurance Company ("Principal") is the custodian and recordkeeper of the Plan, and therefore, fees and expenses paid to Principal qualify as party-in-interest transactions. Principal Life Insurance Company serves as the record-keeper of the Plan and as such, fees paid for loan origination and distribution services qualify as party-in-interest transactions. Notes receivable from participants are also considered party-in-interest transactions. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

5. FAIR VALUE MEASUREMENTS

The Financial Accounting Standard Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under the FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
 - quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means.If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Guaranteed Interest Account: Fair value is determined using the discounted cash flow basis. Fair value represents the amount Plan participants would receive if they were to withdraw or transfer funds within the Plan prior to their maturity for an event other than death, disability, termination or retirement. This fair value represents contract value adjusted to reflect current market interest rates only to the extent such market interest rates exceed crediting rates. The guaranteed interest account provides a guaranteed interest rate for a specified period of time as determined, or allowed, by the Plan. The rate credited is the rate in effect on the day when each deposit is directed to the account. The guaranteed interest account promises a contract value for a benefit event (termination, death, disability and retirement); however, there is a possible surrender charge when funds are withdrawn prior to their maturity. Thus, the guaranteed interest account is considered non-benefit responsive. If the contract holder terminates the contract before a guaranteed interest account matures or transfers funds to other investment managers beyond the limits of the contract, the insurance company will apply an early withdrawal charge to guaranteed interest account balances.

Pooled Separate Accounts: Pooled separate accounts are valued at the net asset value of the units held. The NAV is based on the fair value of the underlying investments held by the PSA less its liabilities. The fair value of the underlying investments, which can consist of a single mutual fund or multiple securities, is determined using market quotations or prices obtained from independent pricing sources. The NAV, as provided by Principal Life Insurance Company is used as a practical expedient to estimate fair value. NAV would not be used if it was probable that the investment would not be traded at NAV. The PSAs provide for daily redemptions by the Plan at reported NAV with no advance notice. There are no unfunded commitments related to these investments. These are direct filing entities

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
