**NOTE A - DESCRIPTION OF PLAN**

The following description of the Fidelity Technologies Corporation Employees Savings and Protection Plan (the “Plan”) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

**General**

The Plan is a defined contribution employee benefit plan covering substantially all employees of Fidelity Technologies Corporation (the “Company”). Employees who are 18 years of age are immediately eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions**

Each participant may elect to contribute up to 100% of his/her compensation as a 401(k) contribution, up to statutory limits as prescribed by the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. An automatic elective deferral contribution shall be a pre-tax deferral equal to 6% of compensation for Reading, PA and FL corporate employees. An automatic increase shall not apply. The Company will contribute an amount equal to 50% of the participant’s 401(k) contribution (up to the first 6% of the participant’s compensation) to the Plan. The Company has the option to make a qualified nonelective contribution to all non-highly compensated participants. The Plan will accept rollover contributions on behalf of any participant.

**Participant Accounts**

Participants may direct the investment of their account into the various funds specified by the Plan. Each participant’s account is credited with the participant’s contribution and an allocation of the Company’s matching contribution and Plan earnings (losses). Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account. Participants have access to their accounts 24 hours a day/7 days per week via a toll-free telephone number and a website. Fund transfers and investment election changes may be elected daily. A participant may start or change his/her salary deferral rate quarterly and may stop at any time.

**Forfeitures**

Plan forfeitures may first be used to pay administrative costs or reduce employer contributions. There were no forfeitures available for future use for the years ended December 31, 2024 and 2023. For the year ended December 31, 2024, \$10,465 of forfeitures were utilized to offset employer contribution payments and \$438 of forfeitures were used to pay administrative expenses.

**Vesting**

Participants are immediately vested in their voluntary contributions plus actual earnings (losses) thereon. Vesting in the Company's contribution portion of their accounts plus earnings (losses) thereon is based on years of service. A participant is 20% vested after two years of credited service and 20% for each additional year of credited service until 100% vested at six years of credited service. Participants are immediately vested in contributions resulting from a qualified nonelective contribution made by the employer.

**Participant Loans**

Loans to participants may be granted based upon a written request approved by the Plan Administrator. The maximum loan amount borrowed shall not exceed 50% of the participant's total vested account balance or \$50,000. Interest rates on participant loans are determined by the trustee and are based on market conditions at the time of the loan. Loan repayments are processed via payroll deduction on an after-tax basis.

**Retirement Benefits**

Benefits may be paid out in equal installments over a period of years not extending beyond the life expectancy of the member and/or a designated beneficiary, a lump-sum payment, or through the purchase of an annuity policy, or in any combination. A lump-sum payment is automatic for amounts up to \$5,000. Normal retirement age is 65.

**Administrative Costs**

The Plan is administered by a committee appointed by the Company's Board of Directors. Expenses pertaining to the administration of the Plan are paid by the Company or with account forfeitures. Administrative expenses incurred by the Plan were \$207,220 for the year ended December 31, 2024.

**Plan Amendment**

On December 29, 2022, the "Setting Every Community Up for Retirement Enhancement (SECURE) 2.0 Act" was signed into law in the United States. The Secure 2.0 Act is an expansion of the Secure Act passed during 2019. The Act includes several mandatory and optional provisions that will become effective across several years. The Secure 2.0 Act aims to expand retirement access, increase retirement savings, and simplify plan administration. Plans may choose to operationally implement the provisions of the Secure 2.0 Act, however plan administrators have until December 31, 2026 to officially amend the plan document to reflect the provisions adopted by the plan.

**Date of Management's Review**

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Significant Accounting Policies**

The significant accounting policies of the Plan employed in the preparation of the accompanying financial statements follow.

**Valuation of Investments** - The Plan's investments are stated at fair value. Shares of mutual funds are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year-end. The Plan's investment in a common collective trust is stated at fair value using net asset value, as a practical expedient.

**Participant Loans Receivable** - All transactions are measured at their unpaid principal balance plus any accrued but unpaid interest. Participant loans are valued at cost, which approximates fair value.

**Revenue Recognition and Method of Accounting** - All transactions are recorded on the accrual basis. Purchases and sales of investments are recorded based on the trade date. Investment income is recorded as earned. Realized gains or losses on security transactions are determined using the average cost of securities sold on the trade date. Expenses are recorded as incurred.

**Use of Estimates** - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

**Payment of Benefits**

Benefits are recorded when paid.

**NOTE C - RELIANCE ON TRUSTEE'S REPORT**

The administrator of the Plan chose the method of compliance permitted by Section 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Under that section, no auditing procedures are required to be performed with respect to the investment information certified by Principal Trust Company, the trustee of the Plan, other than comparing such information to that contained in the financial statements and supplemental schedule.

**NOTE D - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**NOTE E - TAX STATUS OF THE PLAN**

The Plan participates in a non-standardized pre-approved profit sharing plan with CODA sponsored by the Trustee. The Trustee has received a favorable opinion letter from the Internal Revenue Service (IRS), dated June 30, 2020, indicating that the Plan is a qualified plan under Section 401(k) of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter. However, the Plan Administrator and the Plan's tax counsel believe the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan believes it has appropriate support for any tax positions taken, and as such, does not have any uncertain tax positions that are material to the financial statements.

**NOTE F - FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below.

*Level 1* inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.
