## 2024 Schedule SB, Part 5 Summary of Plan Provisions

1. Effective Date January 1, 2020
2. Fiscal Year January 1 to December 31
3. Plan Year January 1 to December 31
4. Anniversary Date January 1
5. Covered Employee Only employees whose job classification is Administrative Assistant, Owner, or Wealth Manager are Covered Employees.
6. Participation Eligibility Attainment of Age 21 and completion of two years of Eligibility Service. However, all Covered Employees that were employed as of January 1, 2020, were eligible to immediately enter the Plan irrespective of whether or not they satisfied service requirements.
7. Participation Date January 1 or July 1 immediately following the date eligibility conditions are satisfied; January 1, 2020, for Covered Employees that were employed on January 1, 2020, and had attained Age 21.
8. Compensation Form W-2, Box 1 Compensation paid during a Plan Year plus elective deferrals.
9. Average Compensation Not Applicable.
10. Normal Retirement Age The later of the date: (a) age 65 is attained; and (b) the fifth anniversary of Date of Participation.
11. Normal Retirement Date First day of the month coinciding with or next following Normal Retirement Age.
12. Normal Form of Benefit Straight Life Annuity.
13. Disability Retirement Not applicable.
14. Accrued Benefit Amount earned as of a specified date under the Normal Retirement Benefit formula.
15. Disability Benefit The Plan does not provide for special disability benefits.
16. Early Retirement Benefit None.
17. Pre-Retirement Death Benefit Present Value of Accrued Benefit. All Plan Participants are 100% vested in their Accrued Benefit upon death.
18. Vesting Schedule Plan Participants are 100% vested upon entering the Plan.
19. Year of Service (for eligibility) Twelve-consecutive-month period during which an employee completes 1,000 hours of service. The twelve-consecutive-month period begins on an employee's date of hire and each anniversary thereof.
20. Year of Service (for benefit accrual) Plan Year beginning on January 1, 2020, during which a Covered Employee completes at least 1,000 hours of service.

21. Year of Service (for vesting)      Plan Year during which an employee completes at least 1,000 hours of service. Service earned prior to the Effective Date of the Plan and prior to the attainment of age 18 is not credited for vesting purposes.
22. Forms of Distribution              Single Life Annuity, 50% Joint and Survivor Annuity, 75% Joint and Survivor Annuity, 100% Joint and Survivor Annuity, and Single Lump Sum Distribution.
23. Top-Heavy                              Only Plan Participants who are non-key employees are eligible to receive minimum top-heavy benefits.

### 24. Normal Retirement Benefit

#### Contribution Credits

Contribution Credits to a Plan Participant's Hypothetical Account are determined as a percentage of annual compensation based on an employee's job classification as follows:

Job Classification	Annual Percentage of Compensation
Administrative Assistant	10.0%
Owner	51.0%
Wealth Manager	The present value, determined as of the last day of the Plan Year using the Plan's basis of actuarial equivalence, of a single life annuity equal to .5% of a Participant's compensation for the Plan Year commencing on a Participant's Normal Retirement Date.

#### Interest Credits

For each Plan Year up to the commencement of a Participant's full benefits, an Interest Credit shall be added annually on the last day of each Plan Year to each Participant's Hypothetical Account in an amount equal to 6.0% multiplied by the amount of the Participant's Hypothetical Account as of the first day of the Plan Year.
