Significant Audit Matters

Qualitative Aspects of Accounting Practices

Management is responsible for the selection and use of appropriate accounting policies. The significant accounting policies used by the Plan are described in Note 2 to the financial statements. No new accounting policies were adopted, and the application of existing policies was not changed during 2024.

We noted no transactions entered into by the plan during the year for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the financial statements in the proper period.

Accounting estimates are an integral part of the financial statements prepared by management and are based on management's knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected. The most sensitive estimates affecting the financial statements were:

Management's estimate of the fair value of the Plan's investments. Investments in the Plan are stated at fair value, as detailed in Note 3 to the financial statements. We evaluated the key factors and assumptions used to determine the fair value by comparing the amounts recorded in the financial statements and supplementary schedule to the amounts prepared and certified to by the Plan's qualified custodian.

Certain financial statement disclosures are particularly sensitive because of their significance to financial statement users. The most sensitive disclosures affecting the financial statements were:

The information prepared and certified by the asset custodian, fair value of financial instruments, related party transactions, plan termination, and tax status.

The financial statement disclosures are neutral, consistent, and clear.

Encountered in Performing the Audit

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditors' report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

Difficulties Encountered in Performing the Audit

We encountered no difficulties in dealing with management in performing and completing our audit.

Corrected and Uncorrected Misstatements

Professional standards require us to accumulate all misstatements identified during the audit, other than those that are clearly trivial, and communicate them to the appropriate level of management. There were no such misstatements.

Disagreements with Management

For purposes of this letter, a disagreement with management is a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditor's report. We are pleased to report that no such disagreements arose during the course of our audit.

Management Representations

We have requested certain representations from management that are included in the management representation letter dated September 18, 2025.

Management Consultations with Other Independent Accountants

In some cases, management may decide to consult with other accountants about auditing and accounting matters, similar to obtaining a "second opinion" on certain situations. If a consultation involves application of an accounting principle to the Plan's financial statements or a determination of the type of auditor's opinion that may be expressed on those statements, our professional standards require the consulting accountant to check with us to determine that the consultant has all the relevant facts. To our knowledge, there were no such consultations with other accountants.

Other Audit Findings or Issues

We generally discuss a variety of matters, including the application of accounting principles and auditing standards, with management each year prior to retention as the Plan's auditors. However, these discussions occurred in the normal course of our professional relationship, and our responses were not a condition to our retention.

Other Matters

Our responsibility for the ERISA-required supplemental schedules accompanying the financial statements is to perform adequate procedures to evaluate whether the form and content of the ERISA-required supplemental schedules, other than that agreed to or derived from the certified investment information, is presented in compliance with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, and whether the information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

To the Plan Administrator of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings and certain internal control related matters that we identified during the audits.

1. DESCRIPTION OF PLAN

The following brief description of Segers Aero Corporation 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan sponsor is Segers Aero Corporation (the Company or the Plan Sponsor). The Plan is a defined contribution plan covering all eligible employees of the Company, as defined in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Plan is a participant-directed plan offering several investment options.

Eligibility

All employees, after having completed 60 days of service, are eligible to participate in the Plan.

Contributions

Participants may elect to defer a portion of their compensation each year up to the maximum amount permissible by the Internal Revenue Code (IRC). Participants in the Plan are automatically enrolled at a 3% "default" contribution rate unless the participant chooses a different contribution rate. Participants are permitted to contribute catch-up contributions in accordance with IRC requirements. Participants may also rollover amounts from other qualified defined benefit or contribution plans.

In 2024 and 2023, the Company contributed a safe harbor match to eligible participants equal to 100% of a participant's elective deferrals which do not exceed 3% of the participant's compensation, plus 87.5% of the amount of the participant's elective deferrals which exceed 3% of the participant's compensation but do not exceed 4% of the participant's compensation, plus 80% of the amount of the participant's elective deferrals which exceed 4% of the participant's compensation but do not exceed 5% of the participant's compensation. The Company, at the sole discretion of its Board, may also make a nonelective discretionary contribution to the Plan. Nonelective discretionary contributions are allocated to participant accounts based on each participant's pro-rata share of the compensation of all eligible employees. No nonelective discretionary contributions were made in 2024 and 2023.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocation of (1) the Company's contribution (if any) and (2) Plan earnings and is charged with an allocation of investment expenses. Allocations are based on participant salary or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment of Benefits

Upon termination of service a participant or a participant beneficiary, in the event of the participant's death, may elect to receive either a lump-sum amount, equal to the value of the vested interest in their account, or request that it be rolled-over to an individual retirement account or annuity.

Participant consent is required for a distribution only if the participant's vested account balance is greater than \$1,000. If the vested interest is \$1,000 or less upon termination of service, a participant will receive a lump-sum distribution.

Participants age 59½ or older may elect to receive a distribution of the vested portion of their account balance regardless of employment. In addition, a participant may request a withdrawal from the Plan while still under the employment of the Company for reasons of financial hardship. The benefit to which a participant is entitled consists of their contributions, their accumulated share of annual employer contributions and earnings thereon.

Notes Receivable from Participants

Participants may borrow from their account balance in accordance with IRC requirements. New loans are limited to one loan outstanding per participant at any given time. The loan amount is allowed at a minimum of \$1,000 and a maximum of 50% of the participant's vested balance up to \$50,000. The loans are secured by the balance in the participant's account, which are commensurate with local prevailing rates as determined at the time of the loan issuance. Principal and interest are payable ratably through payroll deductions over terms ranging up to five years, except for home loans which may range up to 10 years.

Vesting

Participants are fully vested with respect to their employee and employer contributions plus actual earnings thereon.

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value as discussed in Note 4. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Because of the inherent uncertainties in estimated market value, it is reasonably possible that the estimates used will change within the near term. In the statement of changes in net assets available for plan benefits, the Plan presents the net appreciation (depreciation) in the fair value of its investments, which consists of the realized gains or losses on investments sold during the year and the unrealized appreciation (depreciation) on investments held at year end. Purchases and sales of securities are recorded on a trade-date basis.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus accrued interest. Related fees are recorded as administrative expenses when incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits to participants are recorded when paid.

Administrative Expenses

Fees for the administration of benefit payments and notes receivable from participants and investment related expenses are charged directly to the participant's account and are included in administrative expenses.

Subsequent Events

The Plan has evaluated subsequent events through September 8, 2025, the date the financial statements were available to be issued, and has determined that there were no additional subsequent events that required disclosure.

3. INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Plan administrator has obtained certifications from Ascensus Trust Company (the trustee) as of December 31, 2024 and 2023, and for the year ended December 31, 2024, that the following information is complete and accurate.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy are described as follows:

- Level 1 Observable inputs such as quoted prices in active markets;
- Level 2 Inputs, other than quoted prices in active markets, that are observable either directly or indirectly; and
- Level 3 Unobservable inputs in which there is little or no market data, which require the reporting entity to develop its own assumptions.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money Market Fund: Because of the nature of these assets, carrying amounts approximate fair value.

5. TAX STATUS

The Plan has adopted a prototype “standardized” plan, and the prototype sponsor has received an opinion letter dated June 30, 2020, from the Internal Revenue Service indicating that the Plan is a qualified plan meeting the requirements of applicable sections of the IRC. Accordingly, Plan management believes the Plan is currently designed and operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Plan investments are managed by Ascensus Trust Company. Ascensus Trust Company is the trustee as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for the investment management services are included in administrative expenses on the Statement of Changes in Net Assets Available for Benefits. During 2024, the Plan made direct payments to a trustee and third party-administrator of \$24,306 for recordkeeping and administrative services

Merrill Lynch Retirement & Benefit is the broker for the plan. Therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for these services during 2024 were \$20,473 and are included in administrative expenses on the Statement of Changes in Net Assets Available for Benefits.

7. RISK AND UNCERTAINTIES

The Plan invests in a variety of investment funds. Investments in general are exposed to various risks, such as interest rate, credit and overall volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for plan benefits.

8. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.
