Independent Auditor's Report

To the Board of Directors of Antech Systems, Inc., and the Trustee of ASI Employee Stock Ownership Plan:

***Opinion***

## NOTES TO FINANCIAL STATEMENTS

### 1. Description of Plan

The following brief description of the ASI Employee Stock Ownership Plan (“Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for complete information.

Antech Systems, Inc. (“Company”) established the Plan effective January 1, 2021. Effective with the share purchase described below, the Plan operates, in relevant part, as a leveraged employee stock ownership plan (ESOP) and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (“IRC”), and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan is administered by the Company’s Board of Directors (“Board”). An independent individual specializing in providing services to employee stock ownership plans is the Plan’s trustee.

On December 30, 2021, the Plan purchased 1,000 shares of the Company’s common stock financed with a loan of \$650,000 from the Company. Effective March 15, 2022, the Board authorized a 1,000 to one stock split, increasing the number of shares of common stock held by the Plan from 1,000 to 1,000,000 shares. The Plan holds the common stock in a trust established under the Plan.

The loan is collateralized by the unallocated shares of common stock. The Company has no rights against shares of common stock once they are allocated to participants in accordance with the terms of the ESOP. Accordingly, the financial statements of the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, present separately the assets and liabilities and changes therein pertaining to:

- (a) the accounts of employees with rights in allocated common stock (allocated), and
- (b) common stock not yet allocated to employees (unallocated).

*Eligibility:* Employees of the Company are generally eligible to participate in the Plan upon attainment of age 18 and completion of one year of service, providing they worked at least 1,000 hours during such Plan year.

*Contributions:* The Company is obligated to make contributions in cash to the Plan equal to the amount necessary to enable the Plan to make its regularly scheduled payments of principal and interest due on its term loan. Additional amounts may be contributed at the option of the Board. Employee contributions are not permitted.

*Payment of Benefits:* Distributions on account of death are made as a lump sum in the Plan year following the event. Distributions on account of disability or retirement are made in five annual installments commencing in the Plan year following the event. Distributions for other separations from service commence in the fifth Plan year following separation from service and are made in five annual installments. The amount to be distributed is based upon the immediately preceding valuation date. Distributions are made in the form of cash. Under the provisions of the Plan, the Company is obligated to repurchase participant shares, which have

been distributed under the terms of the Plan if the shares are not publicly traded or if the shares are subject to trading limitations.

*Administrative Expenses:* As provided in the Plan agreement, administrative expenses may be paid either by the Plan or by the Company. The Company has historically paid the operating expenses of the Plan.

*Voting Rights:* Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account with respect to major corporate matters and is notified by the Trustee prior to the time that such rights are to be exercised. The Trustee is required to vote any allocated shares for which voting instructions are not received in its discretion. On all other corporate matters, the shares of Company stock owned by the Plan are voted by the Plan Trustee, in its discretion.

*Participant Accounts:* The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each Plan year with an allocation of shares of the Company's common stock released by the Trustee from the unallocated account, cash contributed to the Plan, and forfeitures of terminated participants' non-vested accounts. Only those participants who are eligible employees of the Company will receive an allocation. Allocations are based on a participant's eligible compensation, relative to total eligible compensation. Plan earnings are allocated to each participant's account based on the ratio of the participant's account balance.

*Vesting:* If a participant's employment with the Company ends for any reason other than retirement, permanent disability, or death, he or she will vest in the balances in his or her account based on total years of service with the Company. Participants vest as shown on the following schedule:

<u>Years of Service</u>	<u>Vested %</u>
Less than 2 years	0%
2 years but less than 3	20%
3 years but less than 4	40%
4 years but less than 5	60%
5 years but less than 6	80%
6 years and thereafter	100%

Service prior to January 1, 2021, is excluded from vesting.

*Diversification:* Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company common stock into investments that are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a 6-year period. In each of the first 5 years, a participant may diversify up to 25 percent of the number of shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50 percent. Participants who elect to diversify receive a cash distribution. The election to diversify is made subsequent to year-end based upon the shares of employer stock in the participant's account at year-end.

*Forfeitures:* Plan forfeitures are allocated to each participant’s account based upon the relation of the participant’s eligible compensation to total eligible compensation for the Plan year. Forfeitures allocated to participants during the year ended December 31, 2024, totaled \$16,551. There were no unallocated forfeitures as of December 31, 2024 and 2023.

## 2. Summary of Accounting Policies

*Basis of Accounting:* The financial statements of the Plan are prepared on the accrual basis of accounting.

*Use of Estimates:* The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

*Allocations:* The financial statements of the Plan present separately the assets and liabilities and changes therein pertaining to (a) the accounts of employees with rights in allocated stock (“allocated”) and (b) stock not yet allocated to employees (“unallocated”). Shares are released from collateral and become allocated generally in the period in which debt service is actually paid.

*Investment Valuation and Income Recognition:* The shares of Company common stock are reported at fair value. See Note 4 for a discussion of the fair value measurements. Dividend income is accrued on the ex-dividend date. Purchases and sales of securities are recorded on a trade-date basis. Realized gains and losses from security transaction are reported on the average cost method. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

*Payment of Benefits:* Benefits are recorded when paid.

*Subsequent Events:* The Plan has evaluated subsequent events through September 15, 2025, the date the financial statements were available to be issued.

#### 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## 5. Loan Payable

In connection with the purchase of Company shares, the Plan entered into a loan agreement with the Company (see Note 1). Unallocated shares are collateral for the loan. Shares are released from collateral and allocated to participants as payments of principal and interest are made. The number of shares released in any year is the number of shares held as collateral, times the ratio of the current year payment divided by the total of this year's payment, plus all future years' principal and interest payments. This resulted in 50,000 shares being released and allocated for the Plan year ended December 31, 2024. The agreement provides for the loan to be repaid over 20 years.

The scheduled amortization of the loan (principal and interest) for the next 5 years follows:

The loan bears interest at 1.90 percent.

## **6. Related-Party Transactions and Party-in-Interest Transactions**

The Plan invests in Company common stock and has a loan payable to the Company. These are related-party and party-in-interest transactions. As described in Note 1, the Company pays all Plan expenses. The Plan has a number of service providers. Such providers are parties-in-interest under ERISA.

## **7. Risks and Uncertainties**

The Plan investments consist of the Company's common stock, which is exposed to various risks, such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows and other such techniques. Due to the level of risk associated with the investment in the common stock and to uncertainties inherent in estimates and assumptions, it is at least reasonably possible that changes in the value of the common stock will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

## **8. Plan Termination**

The Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon termination of the Plan, the Board directs the Trustee to pay all liabilities and expenses of the ESOP and to sell shares of financed common stock held as collateral to the extent it determines such sale to be necessary in order to repay the loan. Subsequently, the interest of each participant in the trust fund will be distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the IRC.

## **9. Tax Status**

The IRS has determined and informed the pre-approved plan sponsor by a letter dated June 30, 2020, that the pre-approved plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the pre-approved plan has been amended since receiving the advisory opinion letter, the Plan administrator and the pre-approved plan sponsor believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
