Basis for Opinion

NOTES TO FINANCIAL STATEMENTS

(1) Description of plan

The following description of the Green Worldwide Shipping, LLC 401(k) P/S Plan (the "Plan") provides only general information. Participants should refer to the Plan document or Summary Plan Description for a more complete description of the Plan's provisions, which are available from the plan administrator.

General - The Plan is a defined contribution plan sponsored by Green Worldwide Shipping, LLC (the "Company") for the benefit of its full-time employees who are age twenty-one or older. Employees become eligible to participate in the Plan on the first of the month following the employee's date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions - Participants may contribute up to 100% of annual compensation as pre-tax or Roth contributions, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Additionally, participants age 50 or older, who are making contributions to the Plan, are allowed to make catch-up contributions as defined in the Plan. Participants direct the investment of all contributions into various investment options offered by the Plan.

The Company may contribute a discretionary matching contribution to the Plan. Employees that are eligible to make employee deferrals in the plan are eligible for the employer matching contribution. The Company makes a matching contribution of 50% of participant deferrals up to a maximum employer contribution of \$1,500. The Company may contribute a discretionary profit-sharing contribution to the Plan. Participants must complete 1,000 hours of service during the year and be employed as of the last day of the year to be eligible for the employer profit sharing contributions. Additional amounts may be contributed at the option of the Company. There was no employer profit sharing contribution to the Plan in 2024. Contributions are subject to certain Internal Revenue Code ("IRC") limitations.

Participant investment account options - The Plan currently offers various mutual funds as investment options for participants.

Participant accounts - Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution, (b) plan earnings, and (c) charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in their contributions, employer matching contributions, and employer profit sharing contributions plus actual earnings thereon.

NOTES TO FINANCIAL STATEMENTS

(1) Description of plan - continued

Notes receivable from participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions.

Payment of benefits - Participants may withdraw all or any portion of their voluntary employee contributions, and their vested portion of employer contributions and income earned thereon in their account under the following circumstances: financial hardship, termination of employment, disability, death and a pre-retirement distribution after the participant has attained the age of fifty-nine and one-half. The Plan allows participants to withdrawal qualified Roth contributions and rollover contributions from another qualified plan at any time. Benefit payments may be made in a single lump-sum, installments, or via ad-hoc distributions.

Forfeited accounts - Forfeiture of a participant's employer discretionary contribution portion occurs when a complete distribution of the vested portion of a participant's account is received. Forfeitures are used by the Plan to pay for Plan expenses first, with the remaining used to reduce the employer discretionary contribution amount. There were no forfeitures during the Plan years for 2024.

(2) Summary of significant accounting policies

Basis of accounting - The financial statements of the Plan are prepared on the accrual method of accounting.

Use of estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Capital gains distributions from mutual funds are recorded as dividend income. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

(2) Summary of significant accounting policies - continued

Notes receivable from participants - Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of benefits - Benefits are recorded when paid.

Administrative expenses - Certain expenses of the Plan are paid by the Company and are not included in the statements of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants and distributions paid are charged directly to the participant's account. During 2024, the plan made direct payments for plan administration services to the plan custodians and other service providers totaling \$39,689, inclusive of the fees charged to participants for notes receivable and distributions. Investment related expenses are included in net appreciation (depreciation) fair value of investments.

(3) Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Mutual funds, interest bearing cash and money market account: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

(5) **Excess contributions payable**

Contributions received from participants for 2024 are net of payments of \$18,418 made in March 2025, to certain active participants to return to them excess deferral contributions as required to satisfy the relevant nondiscrimination provisions of the Plan. Those amounts are also included in the Plan's statement of net assets available for benefits as excess contributions payable at December 31, 2024. There were no excess contributions payable at December 31, 2023.

(6) **Plan termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

(7) **Tax status**

The Company has adopted an Ascensus pre-approved prototype plan document. The Plan third party administrator received an opinion letter dated June 30, 2020 from the Internal Revenue Service stating that the prototype plan was acceptable under section 401 of the IRC. Although the Plan has been amended since the date of the opinion letter, the Company believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

(8) **Risks, uncertainties and concentrations**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risk. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

At December 31, 2024 and 2023, approximately 59% and 73% of the Plan's investments were invested in two and three investment options, in each respective Plan year, as elected and directed by the Plan participants.

(9) Related party transactions and party-in-interest transactions

Ascensus provides certain administrative and custodial services to the Plan. The Plan made direct payments to Ascensus of \$17,648 for the year ended December 31, 2024. The Plan paid certain expenses related to the Plan's operations and investment activity of \$22,041 to other service providers. These transactions are party-in-interest transactions. The Plan Sponsor pays directly any other fees related to the Plan's operations.

(11) Subsequent events

On January 25, 2025, the Sponsor suspended the discretionary employer match. The discretionary employer match will be reinstated in October 2025 at 50% of participant deferrals up to a maximum employer contribution of \$375, and effective January 1, 2026 will be 50% of participant deferrals up to a maximum employer contribution of \$1,500.

The Plan has evaluated subsequent events through September 19, 2025, which is the date the financial statements were available to be issued.
