NOTE 1: Description of Plan

The following brief description of the Columbus Hospice, Inc. 403(b) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan Agreement for a more complete description of the Plan’s provisions.

General - The Plan is a defined-contribution profit sharing plan sponsored by Columbus Hospice, Inc. (the “Plan Sponsor”) for its employees and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan was originally adopted on January 1, 1988, has been occasionally amended, and was most recently restated effective October 1, 2021. The most recent restatement included amendments since the previous restatement, most significantly, adjusting the definition of compensation to exclude certain types of fringe benefit pay.

The Plan Administrator, who is employed by the Plan Sponsor, has responsibility for the administration of the Plan. Lincoln National Life Insurance Company and Mutual of America Life Insurance Company (“MOA”), as qualified institutions, serve as custodians, and have responsibility for the management, operation and administration of the Trust Fund. A fee is charged by the custodians for services rendered.

Eligibility – All employees, apart from non-resident aliens and leased employees are eligible to participate in the Plan upon their date of hire.

Contributions - Participants may elect to contribute, on a before-tax or after-tax basis, compensation up to maximum limits provided under the Internal Revenue Code (“IRC”). Participants are automatically enrolled to defer 3% of their pay, unless the participant elects otherwise. An auto-escalation feature is in place to increase contributions by 1% each year, until a maximum of 6% is reached. Participants who have attained age 50 are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contributory plans.

All employees who are eligible to participate in the Plan, and are over 18 years of age, are also eligible for matching contributions. The Plan Sponsor provides a matching contribution equal to 60% of each participant’s deferrals up to 6% of a participant’s annual eligible compensation (3.6% maximum match).

3. \$5,000 times the number of years worked for the Plan Sponsor less the total deferrals made while working for the Plan Sponsor.

Participant Accounts - Each participant's account is credited with the participant's and employer's contributions and allocations of (a) Plan earnings, (b) administrative expenses, and (c) forfeitures of nonvested account balances. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting - Participants are immediately vested in their voluntary contributions and the Plan Sponsor's discretionary contributions and any earnings or losses thereon. Vesting in the employer's matching contributions occurs in 25% increments over each year of credited service, with full vesting occurring at 4 years of credited service. A participant also becomes fully vested in matching contributions upon reaching 59.5 years of age.

Forfeitures - Forfeitures of employer matching and discretionary contributions of participants' non-vested accounts may be used to pay Plan expenses or to reduce employer matching or discretionary matching contributions. Forfeited, non-vested accounts totaled \$0 at both December 31, 2024 and 2023. Amounts used from these accounts to reduce the employer's matching contributions totaled approximately \$6,900 and \$7,800 for the years ended December 31, 2024 and 2023, respectively.

Investment Options - Upon enrollment in the Plan, a participant may direct participant and employer contributions in any of the investment options established by the plan administrator. Participants may change their investment options daily.

Notes Receivable from Participants - Participants may borrow, subject to approval by the plan administrator, a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance. Loan terms range from 1 - 5 years. The loans are secured by the balance in the participant's account and bear interest at a fixed rate of interest approximating the Wall Street Journal's published prime interest rate plus one-percent. Principal and interest are paid ratably through bi-weekly payroll deductions.

Payment of Benefits - Upon reaching age 59.5 or termination of employment due to death, disability, retirement or other reasons, participants may elect to receive either a lump-sum distribution equal to the value of the participant's vested interest in his or her account, or annual installments over a period of years. For termination of service due to other reasons, a participant is entitled to the vested interest in his or her account as a lump sum distribution. Participants may also make withdrawals under certain "hardship" conditions if approved by the custodians of the Plan. The Plan Sponsor may force a participant to take a mandatory distribution upon severance from employment if the vested balance in the participant's account is less than \$1,000.

Plan Termination - Although there is no present intention to do so, the Plan Sponsor may terminate the Plan at any time subject to the provisions of ERISA. In the event of termination, the participants will become fully vested in their account balances and the custodians shall dispose of the Plan assets by distribution to participants or beneficiaries.

NOTE 2: Summary of Significant Accounting Policies

Basis of Accounting - The financial statements of the Plan are prepared using the accrual basis of accounting.

Cash and Cash Equivalents - The Plan's cash and cash equivalents consist of amounts held in a General Account at MOA. The characteristics of this account are comparable to a cash equivalent and therefore are excluded from the fair value hierarchy in Note 3. Amounts in this account are completely liquid and can be withdrawn to another investment choice at any time.

Valuation of Investments - The Plan's investments are stated at fair value except fully benefit-responsive contracts, which are stated at contract value, as described in Note 4. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between participants at a measurement date. See Note 3 for a description of the valuation and methodologies used to determine each investment's respective fair value.

Net appreciation or depreciation of the fair value of investments consists of the unrealized appreciation or depreciation of investments held during the year, as well as the realized gain or loss on sale of investments which represents the difference between net sales proceeds and cost or previous fair value of the investments sold.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Payment of Benefits - Benefits are recorded when paid.

Plan Expenses - Significant costs of administering the Plan are absorbed by the Plan Sponsor and are not reflected in these financial statements. These costs include legal, administrative, accounting and trustee fees. Certain investment management fees and administrative expenses, including audit fees, are incurred and paid by the Plan. Other investment-related expenses are included in net appreciation of fair value of investments.

Tax Status - The Plan has been designed to qualify under Section 403(b) of the IRC. The terms of the Plan have been prepared to conform with the sample language provided by the Internal Revenue Service (“IRS”) in Revenue Procedure 2007-71. The Plan Administrator and the Plan’s tax counsel believe the Plan is currently being operated in conformity with the IRC to maintain tax exempt status for Plan participants under IRC Section 403(b).

Accounting principles generally accepted in the United States of America (“GAAP”) require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS or state taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions within the standard statute of limitation periods; however, there are currently no audits for any tax periods in progress.

Reclassifications - Certain items in the 2023 financial statements have been reclassified in order to be in conformity with the 2024 statement presentation.

Use of Estimates - The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Subsequent Events - The plan administrator has evaluated all subsequent events that may qualify for disclosure through September 9, 2025, which is the date the financial statements were available to be issued. There were no transactions that are required to be disclosed under the professional guidance.

NOTE 3: Fair Value Measurements

GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy according to GAAP are described below:

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

Separate accounts: Separate accounts consist solely of investments in mutual funds registered with the Securities and Exchange Commission and are valued at net asset value of shares held by the Plan at year end.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes the valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4: Fully Benefit-Responsive Investment Contracts

The Plan holds an investment in the Lincoln Financial Group Fixed Account (“Lincoln GIF”). The Lincoln GIF is a guaranteed separate account provided under a group annuity contract and is deemed to be fully benefit-responsive. As such, contract value is the relevant measurement attribute for benefits attributable to the Lincoln GIF because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made to the contract, plus earnings at guaranteed crediting rates, less participant withdrawals and administrative fees, and is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Generally there are no events that could limit the ability of the Plan to transact at contract value paid within 90 days or, in rare circumstances, contract value paid over time. There are no events that allow the issuer to terminate the contract and which require the Plan Sponsor to settle at an amount different than contract value paid either within 90 days or over time.

Lincoln Financial Group bears the risk that the return on the underlying investments will be sufficient to support the guaranteed rate during each guarantee period.
