Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of AccessCNY, Inc. Employees' Retirement Plan and Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

**NOTES TO FINANCIAL STATEMENTS
DECEMBER 31, 2024 AND 2023**

1. DESCRIPTION OF PLAN

The following brief description of the AccessCNY, Inc. Employees' Retirement Plan and Trust (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established to provide retirement benefits to employees of AccessCNY, Inc. There are no years of service or age requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration

AccessCNY, Inc. sponsors and administers the Plan. Reliance Trust Company (Reliance) was the custodian of the Plan's assets through June 30, 2024. Beginning July 1, 2024, Transamerica Trust Company (TTC) became the custodian of the Plan's assets. Transamerica Financial Life Insurance Company, Inc. (TFLIC) is the custodian of the Plan's stable value fund. Transamerica Retirement Solutions, LLC (Transamerica) is the recordkeeper of the Plan. Actuarial Pension Analysts, Inc. (APA) is the third-party administrator of the Plan.

Contributions

Each year, participants may elect to contribute a percentage of their annual wages on a pre-tax basis to the Plan. Participants age 50 and over are also permitted to make additional "catch-up" contributions. Contributions are subject to certain limitations as defined by the Plan and the Internal Revenue Code (the Code). Participants may also contribute amounts representing rollovers from other qualified defined benefit or defined contribution plans.

The Plan provides for matching contributions by AccessCNY, Inc. AccessCNY, Inc.'s matching contribution was equal to 50% of the participant's elective deferrals up to a maximum of 6% of eligible compensation. In addition, AccessCNY, Inc. may make annual discretionary contributions to the Plan. Discretionary contributions of \$69,000 and \$96,207 were made for 2024 and 2023, respectively.

Participant Accounts

Each participant's account is credited with the participant's contributions, AccessCNY, Inc.'s contributions, account earnings/losses and administrative expenses. Participants direct the investment of the contributions into various options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

Participants are immediately vested in their own contributions and matching contributions and earnings/losses thereon. A participant is 100% vested in AccessCNY, Inc.'s discretionary contributions plus earnings/losses thereon after six years of credited service if they occurred prior to April 1, 2024. The Plan was amended beginning April 1, 2024 to provide participants with immediate vesting in all contribution types.

1. DESCRIPTION OF PLAN (Continued)

Hardship Withdrawals

The Plan allows for hardship withdrawals from a participant's account. Such withdrawals are regulated by the Internal Revenue Services (IRS).

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. Plan participants may borrow up to 50% of the amount of their vested interest in the Plan and may have a maximum of one outstanding loan. The minimum loan is \$500 and the maximum loan is \$50,000. Participants' loans are secured by their vested account balances and bear interest at rates ranging from 5.25% to 10.5%.

Payment of Benefits

A participant may withdraw any part of their vested account upon termination of service. A participant or beneficiary may elect to receive an amount equal to the value of the participant's vested interest in their account in either a lump-sum amount, or in periodic payments if the vested balance exceeds \$1,000. Participants may also withdraw amounts in the event of undue hardship or disability.

Forfeitures

Forfeited, non-vested accounts are used to reduce future AccessCNY, Inc. contributions or to pay administrative expenses of the Plan. The amounts used to pay administrative expenses and reduce future employer AccessCNY, Inc. contributions were approximately \$17,055 and \$7,424, in 2024 and 2023, respectively. Unallocated forfeitures were \$11,023 and \$6,969 as of December 31, 2024 and 2023, respectively.

Administrative Expenses

Substantially all administrative expenses associated with the Plan are paid by participants.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared in conformity with accounting principles generally accepted in the United States of America (GAAP).

Investment Valuation and Income Recognition

Investments in mutual funds are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Investments in fully benefit responsive investment contracts are reported at contract value. Contract value is the relevant measure for the portion of the net assets available for benefits attributable to fully benefit responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are reflected on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

All investments are participant directed.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Risks and Uncertainties

Investment securities are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the accompanying financial statements.

Fair Value of Financial Instruments

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. GAAP provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, directly or indirectly, are considered level 2 measurements.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Payment of Benefits

Benefits are recorded when paid.

Estimates

The preparation of financial statements in accordance with GAAP requires the Plan Administrator to make estimates and assumptions that may affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Following is a description of the valuation methodology used for assets measured at fair value:

Mutual Funds: Valued at the net asset value of shares held at year end based on quoted prices in active markets.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There were no changes in the valuation techniques during 2024 and 2023.

5. STABLE VALUE FUND

The Plan is invested in a fully benefit-responsive investment contract with Transamerica Financial Life Insurance Company. Transamerica Financial Life Insurance Company maintains the contributions in a general account. The account is credited with earnings on the credited interest rate and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The interest rate was 1.50% through June 30, 2024 and then increased to 1.65% for the remainder of 2024.

As described in Note 2, because the stable value fund is fully benefit responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the contract. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. The stable value fund is not considered a guaranteed interest contract and there is no stated minimum or maximum interest rate. Contract charges may reduce the return. Prior to January 1st and July 1st, the effective annual rate of interest is established for the corresponding six-month period. Although plan participants generally may withdraw assets from the stable value fund without restrictions, Transamerica Financial Life Insurance Company may impose a hold period at the contract level in the event of a full contract discontinuance or partial contract discontinuance. The Plan Administrator does not believe that any events that would limit the Plan’s ability to transact at contract value with the Plan participants are probable of occurring. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the custodian of the Plan has the right to terminate the Plan at any time, subject to the provisions of ERISA. In the event of termination, partial termination, or complete discontinuance of contributions to the Plan, all amounts credited to the accounts of the participants would become fully vested and nonforfeitable. All distributions would be made in accordance with any applicable requirements of the ERISA and the Code.

7. TAX STATUS

The IRS has determined and informed AccessCNY, Inc. by a letter dated March 14, 2005 that the Plan and related trust are designed in accordance with applicable sections of the Code. Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code.

8. RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

The classification of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, differs between these financial statements and Form 5500. However, the total changes in net assets available for benefits for the years then ended agrees between these financial statements and Form 5500.

9. PARTY-IN-INTEREST TRANSACTIONS

Reliance was the custodian of the Plan's assets through June 30, 2024. Beginning July 1, 2024, TTC became the custodian of certain of the Plan's assets. TFLIC is the custodian of the Plan's stable value fund. Transamerica is the recordkeeper of the Plan. APA is the third-party administrator of the Plan. As such, transactions between Reliance, TTC, TFLIC, Transamerica, APA and the Plan qualified as party-in-interest transactions. Additionally, notes receivable from participants qualified as party-in-interest transactions.

10. SUBSEQUENT EVENTS

Subsequent events have been evaluated through September 18, 2025, which is the date the financial statements were available to be issued.
