Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Gibson Plumbing 401k Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of Gibson Plumbing 401k Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023 stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

NOTE 1 – DESCRIPTION OF THE PLAN

The following brief description of Gibson Plumbing 401k Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

General

The Plan is a defined contribution plan which covers substantially all employees of Gibson Plumbing Company (the “Company”). Employees become eligible to participate in the Plan must have attained age 18 and completed three months of service. The Plan is designed to meet the requirements of Internal Revenue Code Section 401(a) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Entry dates for participants are on January 1st or the same day of the month occurring in each successive three-month period, coincident with or next following satisfaction for the eligibility requirements.

Contributions

Participants may defer a percentage of their compensation (either as pre-tax or Roth deferral) from 0% to 100%. In addition, each year the managing body of Gibson Plumbing Company will determine the amount of profit sharing contributions, if any, which it will contribute to the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants who have attained age 50 before the end of Plan year are eligible to make catch-up contributions.

Participant Accounts

Benefits to employees of the Company consist of employer non-elective contributions, employer matching contributions, participant contributions, and earnings on investments. Participant accounts are also charged with an allocation of administrative expenses. Allocations of employer non-elective contributions, if any, are determined each year as a percentage of compensation per participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested under the Plan with respect to any contributions made by the participant and any earnings thereon. Vesting in the employer’s profit sharing contributions portion of their accounts, plus earnings thereon is based on years of service. Participants vest in employer’s profit sharing contributions, plus earnings, as follows:

Payment of Benefits

On termination of service for any reason, a participant may elect to receive an amount equal to the value of the participant's vested balance in the form of a lump-sum distribution.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates. Following is a summary of the Plan's more significant accounting and reporting policies.

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis of accounting and present the net assets available for the benefit of the participants and change in those net assets.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for discussion of fair value measurements.

Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Administrative expenses for the Plan may be paid by the Plan to the extent not paid by the employer. Administrative expenses attributable to terminated participants are allocated among terminated employees in proportion to the amount of their account balance. Administrative expenses attributable to active participants are allocated among active employees in proportion to the amount of their account balance.

NOTE 3 – CERTIFIED FINANCIAL INFORMATION

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the years then ended, included throughout the Plan's financial statements and supplemental schedule that was prepared by or derived from information provided by the custodian and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the custodian that the information provided to the Plan Administrator by the custodian related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information which appears throughout the financial statements and the supplemental schedule related to the following assets:

NOTE 4 – TAX STATUS

The Internal Revenue Service has determined that the prototype plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The plan administrator and its legal counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken uncertain tax positions that more-likely-than-not would not be sustained upon examination by applicable taxing authorities. The plan administrator has analyzed tax positions taken by the Plan and has concluded that there are no uncertain tax positions taken, or expected to be taken, that would require recognition of a liability or that would require disclosure in the financial statements.

NOTE 4 – TAX STATUS (CONTINUED)

The Plan is subject to routine audits by taxing jurisdictions. However, currently no audits for any tax periods are in progress. The plan administrator believes that the Plan is no longer subject to income tax examination for years ended prior to December 31, 2021.

NOTE 5 – CONCENTRATIONS OF CREDIT RISK

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 6 - FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board Statement ASC 820, *Fair Value Measurements* (FASB ASC 820), establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has specified a (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value.

Pooled separate accounts: Valued at the net asset value (NAV) by the custodian, as of the close of business and adjusted for dividends, splits, administrative maintenance charges and other items.

The method above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan's assets and liabilities recorded at fair value have been categorized based upon the fair value hierarchy in accordance with FASB ASC 820. The following table sets forth by level, within the fair value hierarchy, the Plan's investment assets at fair value as of December 31, 2024 and 2023.

NOTE 7 – PLAN TERMINATION

The Company has approved the merger of the Plan, effective September 2025, subject to applicable requirements under the Employee Retirement Income Security Act of 1974 (ERISA). Under the terms of the merger, all Plan assets and participant account balances will be transferred to the receiving plan, and participants will continue to be 100% vested in their accounts.

Although the Company retains the right to terminate the Plan subject to ERISA provisions, it currently has no intention to do so outside of the planned merger.

NOTE 8 – BONDING REQUIREMENT

The Plan was in compliance with the bonding requirement by ERISA, Title I, Section 412 as of January 1, 2024 and 2023.

NOTE 10 – RELATED PARTY TRANSACTIONS

Plan investments are managed by John Hancock Life Insurance Company, the custodian as defined by the Plan and, therefore, these investments qualify as party-in-interest transactions. Fees paid by the Plan for investment management and other services totaled \$18,917 and \$14,797 for the years ended December 31, 2024 and 2023, respectively.

NOTE 11 – FORFEITURES

As of December 31, 2024, forfeited nonvested accounts totaled \$12,614. In accordance with the Plan's provisions, \$12,614 of these forfeitures were used to reduce employer contributions when paid.

NOTE 12 - SUBSEQUENT EVENTS

Subsequent events have been evaluated by plan management through September 5, 2025, the date the financial statements were available to be issued.

Subsequent to the Plan year-end, the Plan sponsor was acquired and as a result of this transaction, the Plan sponsor has communicated its intention to merge the Plan during the 2025 plan year. As of the date the financial statements were available to be issued, the Plan has not yet completed the formal merging process, which includes the adoption of a plan merger resolution and the distribution of plan assets to participants in accordance with applicable laws and regulations.

The financial statements do not reflect any adjustments related to the pending merger, as the event occurred subsequent to the plan year-end and does not affect the conditions that existed as of December 31, 2024.

Management has evaluated subsequent events through the date the financial statements were available to be issued, and has determined that no additional events require disclosure or adjustment to the financial statements.
