## INDEPENDENT AUDITOR'S REPORT

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Boys & Girls Clubs of the Midlands 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

**1. Description of Plan**

The following description of the Boys & Girls Clubs of the Midlands 401(K) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of its provisions.

General – The Plan is a defined contribution plan established to provide retirement benefits for the employees of Boys & Girls Club of the Midlands (the Company or Plan Sponsor). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility – Employees become eligible to participate in the Plan upon reaching the age of 19 and completing 90 days of service, as defined in the Plan document. Prior to the plan amendment effective January 1, 2024, employees become eligible to participate in the Plan upon reaching the age of 21 and completing one year of service, during which at least 1,000 hours of service was completed. The age and service requirements are waived for any eligible employee employed on January 1, 2021. Any such eligible employees will enter the plan on this date. Participants may enter the Plan on the first day of the plan year quarter coinciding with or next following the date they satisfy the eligibility requirements.

Contributions – Participants may elect to contribute a percentage of their annual compensation, as defined in the Plan, not to exceed limitations set by the Internal Revenue Service, through either pre-tax or after-tax Roth contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions). Participants aged fifty and older by the end of the calendar year may make catch-up contributions. The Company makes safe harbor matching contributions equal to 100% of the participant contributions up to 5% of eligible compensation and nonelective profit sharing contributions fixed at 5% of eligible compensation. Safe harbor matching contributions and nonelective profit sharing contributions made were \$277,430 and \$290,322 during 2024 and 2023, respectively. Participants direct the investment of all contributions into various investment options offered by the Plan.

Participant Accounts – Each participant account is credited with participant contributions, Company safe harbor matching contributions, Company nonelective profit-sharing contributions, and Plan earnings (losses) and charges with expenses. Plan earnings (losses) and investment related expenses are allocated based on actual results of investments selected by each participant. Certain Plan expenses are allocated to participant accounts based on specific participant requested services. The benefit to which a participant is entitled is the benefit provided from the participant's vested account.

Vesting – Participants are immediately vested in their contributions, safe harbor matching contributions, and earnings (losses) thereon. A participant is vested in nonelective profit sharing contributions 20% after two years of service and an additional 20% each year thereafter until becoming 100% vested after six years of service. Participants must complete at least 500 hours of service annually for vesting purposes.

Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set at 1% above the prime rate, as defined. Principal and interest is paid ratably through payroll deductions.

Payment of Benefits – Upon termination, retirement, disability, or death, participants and beneficiaries may elect to receive a lump sum payment equal to the value of the vested funds in the participant's account, or installments of such vested value. The Plan requires distribution payments between \$1,000 and \$5,000 to be rolled over to an individual retirement account designated by the plan administrator, if the participant does not elect otherwise. Distributions less than \$1,000 are paid in a lump sum, if the participant does not elect otherwise.

Forfeited Accounts – At December 31, 2024 and 2023, forfeited nonvested accounts (“forfeitures”) totaled \$4,800 and \$39,400, respectively. Forfeitures will be used to reduce future Company contributions and pay administrative expenses. Forfeitures were used to reduce employer contributions by \$91,745 and \$45,875 and pay administrative expenses of \$19,353 and \$9,693 for the years ending December 31, 2024 and 2023, respectively.

**2. Summary of Accounting Policies and Procedures**

Basis of Accounting – The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates – The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires Plan management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition – Investments are reported at fair value except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See note 4 for discussion of fair value measurements and note 5 for discussion of the investment contract.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**2. Summary of Accounting Policies and Procedures - Continued**

Administrative Expenses – Investment management and recordkeeping fees are paid by the Plan. Other expenses specifically incurred by or attributable to individual participants are paid from the applicable participant account and are included in administrative expenses. The Plan Sponsor pays for certain administrative expenses.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the participant is deemed to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits – Benefits are recorded when paid.

Subsequent Events – Plan management evaluated transactions and events occurring subsequent to December 31, 2024, and through September 18, 2025, the date the financial statements were available to be issued, to determine whether any events should be recognized or disclosed in these statements. There were no material transactions or events in the subsequent period requiring disclosure or recognition in the statements.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended and registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price, so they are deemed to be actively traded.

**5. Group Annuity Contract**

The Plan entered into a fully benefit-responsive guaranteed investment contract with Principal Life Insurance (Principal Life) company totaling \$14,128 and \$12,919 at December 31, 2024 and 2023, respectively. In accordance with the contract, contributions to the Fixed Income Guaranteed Option are held in Principal Life's general asset account. The Fixed Income Guaranteed Option under the contract is credited with interest and charged for participant withdrawals and administrative expenses. Principal Life is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by Principal Life and determined not more than every 12 months. Principal Life may terminate the contract by providing 60 days written notice.

This contract meets the fully benefit-responsive investment criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Principal Life, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on Principal Life's ability to meet its financial obligations. Principal Life's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Withdrawals from the account directed by the Company, or an unusual volume of participant directed transfers or withdrawals which Principal Life reasonably concludes an employer directed withdrawal has occurred, may limit the ability of the Plan to transact at contract value. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with Principal Life and that also would limit the ability of the plan to transact at contract value with the participants.

**6. Party-in-Interest Transactions**

The Plan engages the services of Principal and its affiliates, whose responsibilities include investing assets, paying benefits to participants under the direction of the Plan Administrator, and performing the recordkeeping of the Plan. Administrative expenses paid by the Plan to Principal and/or its affiliates qualify as party-in-interest transactions.

**7. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under Plan provisions to reduce, suspend, or discontinue its contributions at any time or to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

**8. Income Tax Status**

The Plan has adopted a non-standardized preapproved plan document created by Ascensus LLC and adopted by the Company on January 1, 2021. On June 30, 2020, the Internal Revenue Service stated the preapproved document adopted by the Company, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (“IRC”). The Plan has not received a determination letter specific to the Plan. Although the Plan has been amended, the Plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the Internal Revenue Service. The plan administrator believes the Plan has no significant uncertain tax positions. Therefore, no provision or liability for uncertain taxes has been recorded in the financial statements.

**9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances and the amounts reported in the statement of net assets available for benefits.
