APPENDIX II. SUMMARY OF PLAN PROVISIONS

A. Effective Date

The original effective date of the Plan was January 1, 2000.

B. Eligibility

All Covered Employees are eligible to enter the plan on the first day of the month coinciding with or following the attainment of age 18 and six months of service.

C. Normal Retirement Date

A participant's normal retirement date is the first day of the month coinciding with or next following the attainment of age 65 and completion of 5 years of service.

D. Normal Retirement Benefit

Upon normal retirement, a participant is eligible to receive a monthly benefit equal to 1.0% of average monthly compensation (averaged over three years) plus .5% of the excess (if any) of average monthly compensation over \$1,250, multiplied by service up to 35 years.

E. Early Retirement Date

A participant's early retirement date is the first day of the month following or coinciding with attainment of age 55 and completion of 5 years of service.

F. Early Retirement Benefit

The participant's accrued retirement benefit is reduced according to the following table:

G. Normal Form of Benefit

Unless an alternate election is made, benefits paid to single participants will be in the form of a 10-year certain and life annuity and for married participants it will be in the form of a 50% joint & survivor annuity.

H. Vesting

J. Pre-Retirement Death Benefits

Surviving spouses will receive the benefit required by the Retirement Equity Act which is the spouse's portion of the 50% joint and survivor annuity that would have been payable had the participant terminated employment on their date of death, survived to their earliest possible retirement date and begun receiving benefits as a 50% joint and survivor annuity. This benefit is payable at the earliest date the participant could have retired under the Plan.
