### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Philly Shipyard 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Philly Shipyard 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

### Note 1: Description of Plan

The following description of the Philly Shipyard 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan established by Philly Shipyard Inc., (the "Sponsor") as of January 1, 2022. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. Management has evaluated those provisions and determined there is no material impact on the Plan. Plan management will determine the optional provisions to elect in the future.

#### Eligibility and Participation

Employees are eligible to participate in the Plan immediately upon hire. The Plan also includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless a different affirmative election is made. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. For those participants that are automatically enrolled, their deferral percentage will automatically increase by 1% each year, up to a maximum of 10% of eligible compensation unless the participant elects a different amount.

The Sponsor may make discretionary matching contributions and/or discretionary profit sharing contributions to eligible participants. Non-union employees are eligible to receive Sponsor discretionary matching and discretionary profit sharing contributions after attaining 6 months of service. To be eligible for the profit sharing contributions, participants must be employed at the end of the year, work more than 1,000 hours during the year, and must not be covered under a collective bargaining agreement.

#### Contributions

Eligible participants may contribute up to 75% of their pretax or after tax annual compensation, as defined in the Plan up to the annual maximum allowed by the Internal Revenue Service (IRS). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Sponsor discretionary matching contributions were 50% of the participant's contribution up to 6% of a participant's eligible compensation, which totaled \$952,272 for the year ended December 31, 2024. The Sponsor also made a discretionary profit sharing contribution for the 2024 Plan year totaling \$716,841 that was remitted subsequent to the Plan year.

### Note 1: Description of Plan (Continued)

#### Participant Accounts

Each participant's account is credited with the participant's contributions, Sponsor discretionary matching contributions and allocations of (a) Sponsor's discretionary profit sharing contributions, (b) plan earnings (losses) and (c) administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their contributions plus actual earnings (losses) thereon. Vesting in the Sponsor's discretionary matching contribution and discretionary profit sharing contributions is based on continuous years of service and vest according to the following schedule:

Participants are fully vested in their Sponsor discretionary matching and discretionary profit sharing contributions upon the attainment of age 65 or upon retirement due to disability as defined in the plan document, death, or termination of the Plan.

#### Forfeitures

Plan forfeitures arise as a result of participants who terminate service with the Sponsor before becoming 100% vested in the Sponsor's contributions. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0 and \$26,129, respectively. These accounts will be used to reduce future Sponsor contributions in accordance with the plan document. During the year ended December 31, 2024, \$27,607 Sponsor contributions were reduced by forfeited nonvested accounts.

#### Notes Receivable From Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in their vested account and bear interest at the prime rate. Interest rates on existing loans range from 3.25% to 8.50%. Principal and interest are paid ratably through payroll deductions. A participant can only have one loan at any given time and generally must be repaid over five years unless the loan is used to purchase a primary residence.

### **Note 1: Description of Plan (Continued)**

#### **Payment of Benefits**

Upon termination of service due to death, disability, or retirement, a participant (or beneficiary) may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, a direct rollover to another eligible retirement plan, or installment payments if the balance is greater than \$5,000. If the participant's vested account balance is greater than \$1,000 but less than or equal to \$5,000, it will be paid in a lump-sum distribution as soon as administratively feasible after termination of employment. If the balance is less than \$1,000, it can be distributed without the participant's consent and only in a single lump-sum payment. In addition, in-service distributions are permitted from participant accounts that are 100% vested who have attained age 59 1/2. Hardship distributions out of the participant's voluntary contributions account are permitted if certain criteria are met.

#### **Administrative Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Sponsor. Expenses that are paid by the Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are allocated proportionately to plan participants based on their respective account balances and are included in total investment income.

### **Note 2: Summary of Significant Accounting Policies**

#### **Basis of Accounting**

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### **Use of Estimates in Preparation of Financial Statements**

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

#### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

#### Payment of Benefits

Benefits are recorded when paid.

#### Excess Contributions Payable

At December 31, 2024 and 2023, amounts payable to participants totaling \$41,479 and \$35,415, respectively, for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Sponsor distributed the 2024 excess contributions to the applicable participants prior to March 15, 2025.

#### Subsequent Events

The Sponsor has evaluated subsequent events through September 18, 2025, which is the date the financial statements were available to be issued.

### Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority level. Level 2 inputs consist of observable inputs other than quoted prices for identical assets. Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available.

Following is a description of the valuation methodologies used for assets measured at fair value.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

### Note 3: Fair Value Measurements (Continued)

*Collective trust funds:* The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it were determined to be probable that the fund would sell the underlying investments for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily, and there are no restrictions as to the redemption of these funds or unfunded commitments at December 31, 2024 or 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurement at the reporting date.

These investments include collective trust funds, whose primary objective is the safety and preservation of principal and accumulated interest for participant-initiated transactions.

### **Note 4: Information Prepared and Certified by Ascensus**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Ascensus, LLC, as an agent for Ascensus Trust Company.

### **Note 5: Party-In-Interest Transactions**

Certain plan investments are managed by The Vanguard Group, Inc., the third party administrator of the Plan. These transactions, notes receivable from participants, and administrative expenses qualify as party-in-interest transactions. These transactions are not, however, considered prohibited transactions under 29CFR 408(b) of ERISA regulations.

### **Note 6: Tax Status**

The Sponsor adopted a nonstandard pre-approved document with an IRS notification letter, dated June 30, 2020, which states the pre-approved plan document is in compliance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter; however, the plan administrator believes the Plan is designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.

### **Note 7: Plan Termination**

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants could become 100% vested in their Sponsor contributions.

### **Note 8: Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
