Consideration of Internal Control Over Financial Reporting

In planning and performing our audit of the financial statements of Savion LLC 401k Retirement Plan as of and for the year ended December 31, 2024, in accordance with GAAS, we considered the Plan's internal control over financial reporting (internal control).

This consideration served as a basis for designing our audit procedures that are appropriate in the circumstance for the purpose of expressing our opinion on the financial statements.

However, this consideration was **not** for the purpose of expressing an opinion on the effectiveness of the Plan's internal control.

Accordingly, we do not express an opinion on the effectiveness of the Plan's internal control.

Our consideration of internal control was for the limited purpose described in the preceding paragraphs and was not designed to identify all deficiencies in internal control that might be material weaknesses or significant deficiencies and, therefore, material weaknesses or significant deficiencies may exist that were not identified.

Categorizing Deficiencies by Severity

Deficiency

A deficiency in internal control exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent or detect and correct misstatements on a timely basis.



Significant Deficiency

A significant deficiency is a deficiency, or combination of deficiencies, in internal control that is less severe than a material weakness, yet important enough to merit attention by those charged with governance.



Material Weakness

A material weakness is a deficiency, or a combination of deficiencies, in internal control, such that there is a reasonable possibility that material misstatements of the Plan's financial statements will not be prevented or detected and corrected on a timely basis.



Identified Deficiencies

We identified certain deficiencies in internal control that we consider to be a significant deficiency and deficiency.

Significant Deficiency

- Lack of SOC 1 review - The plan sponsor is responsible for the prudent oversight and review of all services provided by third parties to the Plan. Hiring a service provider to perform duties on behalf of the Plan is a fiduciary function. As part of its fiduciary responsibilities, the plan sponsor should periodically monitor service providers to ensure that they are properly performing the agreed-upon services. For 2024, Plan management did not review the service auditor's report (SOC 1 Report) for the Plan's third-party service provider as part of ongoing fiduciary monitoring of the third-party services. SOC 1 reports address the effectiveness of the service organization's internal controls and outline "user controls" which should be in place at the plan sponsor to help ensure the service organization's controls operate effectively. Given the Plan is relying on its service provider to record and process transactions, including outsourced benefit payments, the SOC 1 Report for this organization should be reviewed to determine whether appropriate controls are in place and operating effectively, and to ensure plan management has placed in service all applicable complementary user entity controls. To strengthen the Plan's internal control environment and fulfill fiduciary monitoring duties, we recommend plan management obtain and review the relevant SOC 1 reports each year, including consideration of relevant complementary user entity controls in place as part of the report review process, and then document the results of those reviews. Documentation could include presenting an overview of the results to the Retirement Committee for mention in the meeting minutes.

Deficiency

- Safe Harbor matching contribution true-up miscalculation - For one new participant selected for testing, the eligible compensation used for the annual Safe Harbor matching contribution true-up calculation erroneously excluded their eligible insurance opt out compensation, resulting in an understatement of approximately \$33 in their employer contribution for 2024. We recommend screening all participants with this pay code for similar miscalculations and then making corrective contributions for any identified participants. We also recommend enhanced review controls over the census files used for the Plan's annual true-up to ensure eligible plan compensation is accurately calculated, especially when manually adjusting eligible wages to remove pre-entry compensation for newly-eligible participants.

 - e. There are no subsequent events that require adjustments to the fair value measurements and disclosures included in the financial statements.

Investments

41. Investments are properly measured at fair value. Investments measured at fair value include investments with a readily determinable fair value that are reported at net asset value (NAV) per share/unit.

Off-Balance Sheet Risk

42. Financial instruments with off-balance sheet risk and financial instruments with concentrations of credit risk, if any, have been properly recorded or disclosed in the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in *Note 3* to the financial statements, is complete and accurate.

Opinion

Note 1. Description of the Plan

General

The following description of Savion LLC 401(k) Retirement Plan (Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan sponsored by Savion, LLC (the "Company") for the benefit of its employees who have at least three months of service and are age 18 or older. Effective December 15, 2023, the Plan's eligibility service requirement was amended from three months to one month. Certain employees who are covered by a collective bargaining agreement or are part-time, seasonal or temporary are excluded from the Plan.

The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Fidelity Management Trust Company (Fidelity) serves as the trustee of the Plan.

Contributions

The Plan permits eligible employees through a salary deferral election to have the Company make annual contributions of up to 100 percent of their eligible compensation. Employee rollover and Roth contributions are also permitted. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Company makes safe harbor matching contributions of 100 percent of the first 3 percent of participants' compensation contributed to the Plan and 50 percent of the next 2 percent of participants' compensation contributed to the Plan. The Company may also make discretionary non-elective contributions. To receive discretionary non-elective contributions, participants must be employed on the last day of the Plan year and have at least 1,000 hours during the year. The Company did not make any discretionary non-elective contributions for 2024 or 2023. Contributions are subject to certain limitations.

Participant Investment Account Options

Each participant has the option of directing their contributions into any of the various investment options offered by the Plan and may change the allocation daily.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's contributions and plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary and employer safe-harbor matching contributions plus earnings thereon. Vesting in the Company's discretionary non-elective contribution portion of their accounts plus earnings thereon is based on years of credited service with a graduated vesting schedule. A participant is fully vested after six years of credited service.

Payment of Benefits

Upon termination of service, a participant will receive the value of the vested interest in their account as a lump-sum distribution or partial withdrawals. Withdrawals other than for termination are permitted under circumstances provided by the Plan.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets and the disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year end.

The collective trust funds are valued at NAV based upon the quoted market value of the underlying investments as reported by the trust managers. This NAV is calculated daily and is the basis for current transactions.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Company or the Plan, at the Company's discretion.

Note 3. Certification of Plan Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule are complete and accurate:

- Investments as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investment information included in the accompanying schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Related-Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association or relatives of such persons.

Certain Plan investments are mutual funds managed by an affiliate of Fidelity. Fidelity is the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

The Plan paid \$102,474 and \$76,201 of direct recordkeeping and investment advisor fees during the years ended December 31, 2024 and 2023, respectively. The Company provides certain administrative services at no cost to the Plan and pays certain costs on behalf of the Plan.

Note 5. Disclosures About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. The hierarchy comprises three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and that are significant to the fair value of the assets or liabilities

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

Note 7. Tax Status

The Plan operates under a nonstandardized adoption agreement in connection with a pre-approved profit sharing plan document sponsored by FMR, LLC. This pre-approved plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the Plan Administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
