- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Family Health Center 401(K) Plan's ability to continue as a going concern for a reasonable period of time.

Note 1 – Description of Plan

The following description of the Family Health Center 401(K) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan was established on January 1, 2008, and was restated effective January 15, 2015, and last amended November 30, 2016, covering all employees of Family Health Center of Southern Oklahoma, Inc. (the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Employees are eligible to participate in the Plan after completing three months of service with no age requirement.

Employer Contributions

The Plan allows for safe harbor matching, discretionary matching, and nonelective profit sharing contributions. The Company makes safe harbor contributions up to 5% of employee pay excluding reimbursement of expenses, compensation paid during the determination period while not a participant, and production based bonuses. The Company may make a discretionary match of 6% of participant compensation. The Company has not made a discretionary match or a profit sharing contribution to the plan in 2024 or 2023. To be eligible to receive a safe harbor contribution, or a discretionary matching contribution, participants must be considered active participants on the contribution date and have completed three months of service. To be eligible to receive a nonelective profit sharing contribution, participants must be considered active participants on the last day of the year and have completed one year of service.

Participant Contributions

Participants may elect to contribute up to 100% of their compensation to the Plan subject to the annual limitations imposed by the Internal Revenue Service. Plan participants age 50 and older were eligible to make a catch-up contribution of an additional \$7,500 to the Plan during the years ended December 31, 2024 and 2023. The participants eligible to make the catch-up contributions may do so only after making the total elective deferral contributions allowed by the Internal Revenue Service. Rollover contributions are permitted under the Plan agreement.

Participant's Accounts

Each participant's account is credited with the Company's contributions and the income and appreciation or depreciation of the investments attributable to each type of investment. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in the safe harbor match, any participant contributions and participant rollover contributions plus actual earnings thereon. Vesting in Company nonelective profit sharing or the discretionary match is based upon years of continuous service as follows:

Participants become 100% vested regardless of years of service upon death, total and permanent disability, or termination of the Plan.

Payment of Benefits

Upon retirement, termination, disability, or death, a participant, or his or her beneficiary in the event of death, may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Upon termination, distributions are required to be as soon as administratively possible for all account balances. Participant's consent is required for distributions above \$1,000. Distributions of less than \$1,000 will be made as a lump-sum. Generally, certain minimum distributions are required for participants who have reached age 72. Hardship withdrawals are permitted by the Plan.

Forfeitures

Discretionary matching or nonelective profit sharing contributions that are forfeited because of termination prior to vesting may be used to reduce future employer contributions or pay plan expenses. The Plan had no forfeitures for December 31, 2024 or 2023.

Note 2 – Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for collective investment funds, which are reported at cost plus earnings thereon. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) is included in the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid. There were no benefit payments requested before year-end that were not paid.

Administrative Expenses

The Plan allows certain administrative expenses to be paid from Plan assets. The Company pays certain administrative expenses for the Plan.

Date of Management's Review

Management has evaluated subsequent events through the date of these financial statements.

Note 3 – Fair Value Measurements

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. No Level 2 or Level 3 inputs were available at year end to the Plan for the years ended December 31, 2024 and 2023.

Level 1 Fair Value Measurements

- Mutual funds have publicly quoted prices.

Gains and losses (realized and unrealized) included in changes in net assets available for benefits for the years ended December 31, 2024 and 2023, are in net appreciation (depreciation) in fair value of investments.

Note 4 – Collective Investment Funds

The Plan allows participants to invest in a collective investment fund (CIF). Collective investment funds are specifically designed under banking and tax laws for qualified tax-exempt retirement plans and certain trusts. CIFs are regulated under several regulatory and statutory rules, including federal or state banking laws and regulations, and the Employee Retirement Income Security Act of 1974 (ERISA).

This CIF is backed by money market funds, cash, short-term securities of the US Government, or cash equivalents. While this fund invests primarily in the securities of the US Government and its agencies, the fund's value is not guaranteed by these entities. This fund seeks to preserve the value of fund at \$1 per share, but it is possible to lose money by investing in this fund. The value of this fund will be stated at cost, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at the current value of their vested account balance. For the years ended December 31, 2024 and 2023, the average rate was 2.05% and 1.98%, respectively. There are no restrictions on withdrawals from this fund.

Note 5 – Information Certified by a Qualified Institution

The Plan's trustee has certified the completeness and accuracy of all investment balances and activity, investment fair value and cost, accrued interest and dividends receivable, interest and dividend income, net appreciation (depreciation) in fair value of investments, and purchases and sales of investments for the years ended December 31, 2024 and 2023. Nationwide Trust Company, FSB does not certify loans or assets held outside of Nationwide.

Note 6 – Transactions with Parties-In-Interest

The Company provides administrative services at no cost to the Plan. Certain Plan investments are shares of mutual funds managed by the trustee of the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the Plan for investment management services are included in net appreciation (depreciation) in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment.

Note 7 – Income Tax Status

The Internal Revenue Service has determined and informed the Company in a letter dated June 30, 2020, that the Plan is designed in accordance with the applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. The Plan administrator and the Plan's tax counsel believe the plan is currently being operated in compliance with the applicable requirements of the IRC. The Plans' tax returns are generally subject to examination by the Internal Revenue Service for a period of three years from the date they are to be filed.

Note 8 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 9 – Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 10 - Correction of Delinquent Participant Contributions

During 2023, a total of \$26,638 of participant contributions were deemed delinquent, including the amount noted below for 2023. The earnings necessary to make participants whole were due to the plan to correct delinquent contributions at December 31, 2023, and were remitted after year end.

It was discovered during 2023 that the Plan sponsor did not use the Plan definition of compensation correctly for all deferrals and allocations dating back to 2021. A total of \$472, \$392 and \$352 were deemed delinquent for years ended December 31, 2023, 2022 and 2021, respectively.

There were no delinquent participant contributions for the Plan year ended December 31, 2024.
