### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Pattison Sign Retirement & Vesting Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

### **Opinion**



### **1. Description of Plan**

#### ***General***

Pattison Sign Retirement & Vesting Plan (Plan) is a defined contribution plan available to eligible employees of Pattison Sign Group, Inc. (Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### ***Participant Accounts***

Each participant's account is credited with the participant's contributions, employer contributions and allocations of the invested funds' earnings. Allocations of earnings are based on account balances as defined by the Plan. Certain administrative expenses may be charged directly to the participant's account incurring those expenses.

#### ***Eligibility***

To be eligible to participate in the Plan, an employee must have attained the age of 18 and have been employed by the Company for at least two months. All classifications of employees of the Company are eligible to participate in the Plan upon completion of the eligibility requirements, except for residents of Puerto Rico, leased employees and nonresident aliens with no income from a U.S. source.

#### ***Contributions***

Participants may contribute a percentage of their pre-tax and after-tax annual compensation, as defined in the Plan, not to exceed the Internal Revenue Service (IRS) limitations each year. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants who have attained age 50 are eligible to make catch-up contributions, subject to the statutory limit. The Company may elect to make an annual discretionary matching contribution to the Plan. In 2024, the Company elected to match 50% of the participant's contribution of up to 6% of the participant's eligible compensation. Participants may also make Roth deferral contributions (post-tax contributions) to the Plan, which are separately accounted for as are the gains and losses attributed to those deferrals. The Company may make discretionary contributions in addition to discretionary matching contributions to the Plan each year, as designated by the board of directors of the Company. Participants who are employed on the last day of the year and worked 500 hours during the Plan year share in the employer discretionary contributions. No additional discretionary contributions were made for the years ended December 31, 2024 and 2023.

#### ***Vesting***

Participants are immediately vested in their contributions plus actual earnings thereon. Participants vest in Company matching and discretionary contributions as follows:

#### ***Payment of Benefits***

Distribution of a participant's vested account is available upon the participant's retirement, death, disability, termination of employment or attainment of age 59 ½.

#### ***Notes Receivable from Participants***

Notes receivable from participants represent loans that are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. Plan participants may borrow from their accounts an amount generally not to exceed the lesser of \$50,000 or 50% of their vested account balance, except for amounts borrowed under the CARES Act. The repayment terms of loans may not exceed five years except for loans used to acquire a principal residence. Each loan bears interest at a rate determined by the Plan. Principal and interest are paid ratably through automatic payroll deductions. No allowance for credit losses has been recorded at December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan administrator deems the loan to be a distribution, notes receivable from participants is reduced and a benefit payment is recorded.

#### ***Plan Termination***

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

### ***Forfeitures***

Forfeitures from the Company's discretionary contributions are used to pay administrative expenses of the Plan and reduce future Company contributions. During the year ended December 31, 2024, the Company did not use any forfeitures. Forfeitures available for future use at December 31, 2024 and 2023 totaled \$57,330 and \$40,826, respectively.

### ***Administration Expenses***

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

## **2. Summary of Significant Accounting Policies**

### ***Basis of Accounting***

The financial statements have been prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

### ***Estimates and Assumptions***

Management uses estimates and assumptions in preparing financial statements in accordance with GAAP. Those estimates and assumptions affect the reported amounts of net assets available for benefits at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could vary from the estimates used in preparing the accompanying financial statements.

### ***Investment Valuation and Income Recognition***

Investments in mutual funds are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements. The Plan presents the net change in fair value of investments, which consists of realized gains or losses, unrealized appreciation (depreciation), and any income or capital gain distributions from such investments, in the accompanying statement of changes in net assets available for benefits.

Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Payment of Benefits***

Benefits to participants are recorded when paid.

### ***Risks and Uncertainties***

The Plan provides for investment options in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

### **3. Fair Value Measurements**

Under the Fair Value Measurements and Disclosures topic of the Codification, ASC 820, disclosures are required about how fair value is determined for assets and liabilities and a hierarchy for which these assets and liabilities must be grouped is established, based on significant levels of inputs as follows:

- Level 1 Quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; and model-derived valuations in which all significant inputs are observable in active markets.
- Level 3 Valuations derived from valuation techniques in which one or more significant inputs are unobservable.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

### ***Mutual Funds***

These investments are public investment vehicles valued using the net asset value (NAV) provided by the administrator of the fund. The NAV is based on the value of the underlying asset owned by the fund, less its liabilities, and then divided by the number of shares outstanding. The NAV is a quoted price in an active market.

The Plan's assets at fair value at December 31, 2024 and 2023 consists of mutual funds totaling \$11,348,648 and \$9,251,215, respectively, which are level 1 investments within the fair value hierarchy.

#### **4. Investment Contract with Insurance Company**

In 2019, the Plan entered into a traditional fully benefit-responsive investment contract with The Standard Insurance Company (Standard) totaling \$1,439,214 and \$1,354,329 as of December 31, 2024 and 2023, respectively. Standard maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract value is guaranteed by the full faith and credit of Standard. The crediting rate is based on a formula established by the contract issuer but may not be less than 1 percent. The crediting rate is reviewed on a quarterly basis for resetting.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate a permitted transaction under the terms of the Plan. Contract value, as reported to the Plan by Standard, represents withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal of transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events may limit the ability of the Plan to transact at contract value. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs and the liberalization of plan withdrawal or transfer rules. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with 30 days advance written notice to the contract owner for reasonable cause, which includes the contract owner's failure to abide by state or federal law, failure to render performance necessary to comply with the terms of the contract, failure to maintain assets of at least \$25,000, plan disqualification and failure to adopt the plan in a reasonable period of time.

**6. Tax Status**

The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that at December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan’s Annual Return/Report of Employee Benefit Plan is subject to examination by the IRS for three years from the date of filing.
