Note A - Description of Plan

The following description of the Mainline Pharmacy 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

1. General - The Plan is a defined contribution plan covering all employees the three months following employment of Mainline Pharmacy (Company) and its wholly owned subsidiaries who are age twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Retirement Plan Committee is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.
2. Contributions - Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company contributes to a "ADP test safe harbor contribution" which is a nonelective contribution of 3 percent of each Participant's compensation.
3. Participant Accounts - Each participant's account is credited with the participant's contributions, the Company's safe harbor contribution, account earnings, as well as an allocation of the Company discretionary contribution based on participant compensation with an integration level of the taxable wage base, as defined. Participant accounts are charged directly for participant requested services and an allocation of administrative expenses that are paid by the Plan. Allocations are based on account balances or the number of participants in the Plan, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
4. Vesting - Participants are vested immediately in their contributions plus actual earnings thereon.
5. Notes Receivable from Participants - Since January 1, 2016, participants are not allowed to borrow from their fund accounts.

6. Payment of Benefits - On termination of service, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or in installments.
7. Forfeited Accounts - At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$-0- and \$-0- respectively. During 2024 and 2023, amounts forfeited from nonvested accounts used to reduce Company contributions were \$-0- and \$-0- or to pay administrative expenses were \$-0- and \$-0- respectively.

Note B - Summary of Accounting Policies

1. Basis of Accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.
2. Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.
3. Investment Valuation and Income Recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Retirement Plan Committee determines the Plan's valuation policies utilizing information provided by the trustee. See note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

4. Excess Contributions Payable - Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding deduction. The Plan usually distributes any excess contributions to the applicable participants prior to March 15<sup>th</sup> of the year following the excess, with amounts paid being \$-0- in 2024 \$-0- in 2023.
5. Payment of Benefits - Benefits are recorded when paid.

6. Administrative Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees for third party advisory services are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.
7. Subsequent Events - The Plan has evaluated subsequent events through the date of the Independent Auditor's Report, which is the date the financial statements were available to be issued.

Note C - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Note G - Tax Status

The Internal Revenue Service (IRS) has determined and informed the pre-approved plan provider by letter dated June 30, 2020, that the Non-Standardized Pre-Approved Profit Sharing Plan With CODA is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Non-Standardized Pre-Approved Profit Sharing Plan With CODA has been amended since receiving its determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt. Since the Plan is a pre-approved plan, it is not necessary for the Plan administrator to submit the Plan for favorable determination.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note H - Related-Party Transactions

Plan investments are with Capital Bank and Trust Company as the current trustees for the Plan. Retirement Plan Solutions is the recordkeeper for the Plan, therefore, these transactions qualify as party-in-interest transactions.

The Plan had a Master Service Agreement with Capital Bank and Trust Company for administrative and recordkeeping support. Fees incurred by the Plan for investment management services are included in net appreciation (depreciation) in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. See Note B for further description on administrative expenses.

Investment advisor fees paid by the Plan amounted to \$8,326 in 2024 and \$1,175 in 2023.

Note I - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
