#### **1. Description of Plan**

The following description of ModuSpec, LLC 401(k) Plan (the Plan) (previously named Vysus Group 401(k) Plan), provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions, including benefit provisions.

##### **General**

The Plan is a tax-exempt defined contribution plan covering ModuSpec, LLC (the Company). The Internal Revenue Service has determined and informed the Company, by a prototype opinion letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the prototype opinion letter. However, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Vysus ModuSpec, Inc. and Vysus Americas, Inc. employees were formerly all covered under the Vysus Group 401(k) Plan.

During 2024, the Company, formerly Vysus ModuSpec, Inc. was purchased by MR Group Americas, Inc. (MR Group) and employees were covered under the Plan. Vysus Americas, Inc. was not included in the sale to MR Group and as of March 1, 2024 the employees of Vysus Americas, Inc. and their related assets were transferred out of the Plan totaling \$8,490,401.

Effective January 1, 2025, the MR Group Americas Inc. 401(k) Plan merged into the Plan and MR Group Americas Inc. is a Participating Employer in the Plan.

##### **Contributions**

Employees may voluntarily contribute up to the maximum percentage compensation and dollar amount permissible under the IRC. The Company contributed a safe harbor match contribution of 100% of the first 6% of eligible participant compensation in 2024.

#### **2. Summary of Significant Accounting Policies**

##### **Use of Estimates**

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

##### **Investments**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for discussion of fair value measurement.

Dividend income is recorded on the ex-dividend date. Interest income is accrued when earned. Purchases and sales of investments are recorded on a trade-date basis. Net appreciation in fair value of investments includes the Plan gains and losses on investments bought and sold as well as held during the year.

The Plan has an investment in the John Hancock (JH) Stable Value R6, a common collective trust, with a fair value based on the net asset value (NAV) of the underlying assets in the common collective trust. The investment objective of the JH Stable Value R6 is to provide a competitive level of income over time that is consistent with the preservation of capital. Withdrawals from the JH Stable Value R6 are permitted at any time by participants.

#### **Payment of Benefits**

Benefits paid to participants are recorded when amounts are distributed.

#### **Note Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued, but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

#### **Subsequent Events**

Management has considered transactions or events occurring through September 24, 2025, which is the date that the financial statements were available to be issued. Management has not evaluated subsequent events after that date for inclusion in the financial statements.

### **3. Information Certified by Trustee**

Information included in the financial statements and supplemental schedule relating to investments, notes receivable from participants, net appreciation in fair value of investments, and investment and notes receivable from participants income was obtained by management, and agreed to or derived from the information certified by Fidelity Management Trust Company, the trustee, as complete and accurate. This information is included in the following:

### **4. Party-In-Interest Transactions**

Plan investments are managed by Fidelity Management Trust Company (FMTC). FMTC provides trustee and plan administration services and, therefore, these transactions qualify as party-in-interest transactions. Administrative expenses paid from the Plan totaling \$27,162 were paid to FMTC for recordkeeping services and to the Plan investment advisor.

#### 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

#### 6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### 7. Fair Value Measurement

Financial Accounting Standards Board Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurement*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets;

Quoted prices for identical or similar assets or liabilities in inactive markets;

Inputs other than quoted prices that are observable for the asset or liability; and

Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2024 and 2023:

*Mutual funds and money market fund:* Valued at the quoted NAV of units held by the Plan at year-end.

*Collective trust fund:* Valued at fair value using the market approach based on the underlying NAV of units held by the Plan. NAV is used as a practical expedient to measure fair value. Withdrawals or transfers initiated by participants will generally be paid at book value, except where they are the result of plan sponsor actions. Withdrawals that are the result of plan sponsor actions may be subject to a market value adjustment or paid out after a 12-month delay.
